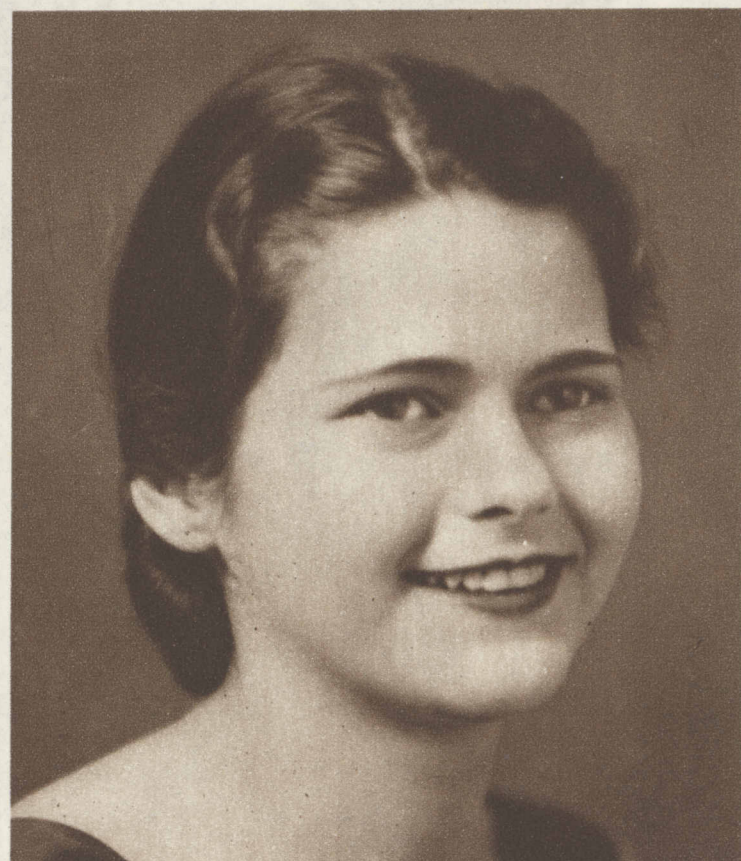

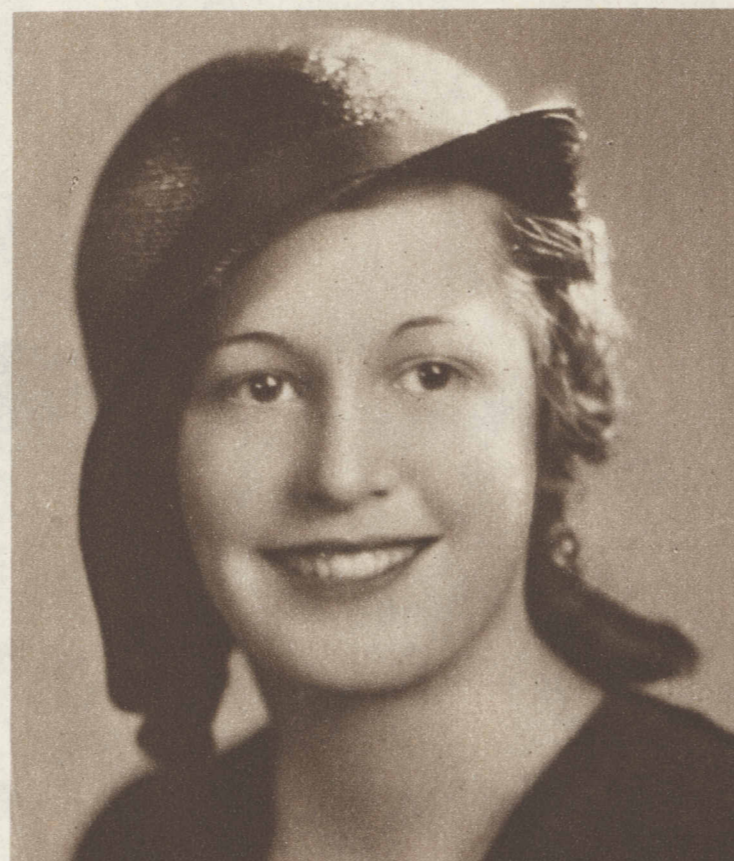

1. Girls everywhere are invited to submit their photographs.
2. This offer is open to every girl—unmarried or widow—residing anywhere in the world, excepting professional beauties such as stage girls and artists' models and excepting employees of the Chicago Tribune and members of their families. It is free. There is no charge of any kind.
3. From all the photographs submitted in this competition the fifty-one most charming girls will be chosen to serve as the "Queen" and her "Court of Honor." These fifty-one girls will be invited to Chicago for the final judging. All their expenses will be paid. From these fifty-one girls three Grand Prize winners will be chosen and the following cash sums paid to them:

 The 1st Grand Prize winner shall be crowned "Queen." The 2nd and 3rd Grand Prize winners shall be, respectively, the first and second Ladies-in-Waiting. The forty-eight other girls chosen shall, with the two Ladies-in-Waiting, complete the fifty members of the "Queen's Court of Honor." The "Queen and Her Court" will formally dedicate the Century of Progress International Exposition at Chicago under suitable ceremonies.
4. The "Queen" and members of her "Court of Honor" shall be guests of the Chicago Tribune at the Exposition. The Chicago Tribune will furnish proper chaperonage for such girls while in Chicago and will pay all such expenses as transportation, hotel accommodations, entertainment, etc., and will provide suitable gowns for the "Queen and Her Court." Each entrant agrees to abide by the regulations of the Chicago Tribune respecting chaperonage, conduct, services, and any and all other matters.
