MEMORANDUM OF AGREEMENT AND WORK CONDITIONS

6/30/84

River Rouge, City of

BETWEEN, The City of River Rouge and The Police Chief, Fire Chief, Deputy Police Chief Deputy Fire Chief and Detective Inspector, known as the River Rouge Police and Fire Supervisor's Association.

It is agreed that the undersigned employees shall receive the same cleaning, clothing, optical and dental benefits afforded members of the F. O.P., Unit II, Lieutenants and Sergeants. In addition thereto, the undersigned shall continue to receive those benefits they currently enjoy, namely: holiday pay, vacation leave, sick leave, life and hospitalization insurance, longevity, a gun (Police) or food (Fire) allowance and workmen's compensation insurance, and pension benefits.

Life Insurance for retirees shall be \$8,000.00.

Holiday Benefit The Holidays for members of this unit are as follows:

- 1. New Years Day (Jan. 1)
- 2. Martin Luther's King's Birthday (Jan. 15)
- 3. Lincoln's Birthday (Feb. 12)
- 4. Mashington's Birthday (Feb. 22)
- 5. Memorial Day last Monday in May
- 6. Independence Day (July 4)
- 7. Labor Day first Monday in September Columbus Day (Oct. 12)

- 9. Veteran's Day (Nov. 11)
- 10. Thanksgiving Day last Thursday in November
- 11. Employee's Birthday
- 12. City General Election Day
- 13. Employee's Hire Date
- 14. Good Friday Friday preceding Easter.

If an employee works a holiday, that day shall be paid at a regular day's pay plus time and one half.

The regular work week shall be five days, eight hours per day. However, the undersigned may be required to work more than forty (40) hours from time to time, for which there will be no compensation.

ACCUMULATION OF TIME: VACATION AND SICK DAYS

With regards to new members coming into the Supervisor's Unit:

Any new member entering the unit with accumulated time and/or days on the books, will at the option of the City, be asked to take time off or be paid at that rate of pay in existence at the time the days and/or time was earned. This option will

be exercised, by the City, until such time as all accumulated time and/or days have been exhausted. This provision excludes the sick time accumulation up to a maximum of 120 days.

- B. Any member coming into the Supervisory Unit after 7/1/80, shall be permitted to accumulate up to fifty-eight vacation days; however, upon retirement, he will be compensated for such days at the rate of pay existing at the time said days were accumulated.
- C. No member shall accumulate compensatory time, leave days and/or personal days. All said time and/or days shall be forfeited upon entry into this unit.
- D. Present members, (O'Hara, Pacheco, Smith, Grignon, and Barnes) shall be permitted to accumulate up to 100 vacation days and 120 sick days. This provision is intended to eliminate all other forms of accumulated time except vacation and sick days.

This Agreement shall continue in full force and effect until June 30, 1984. All benefits hereunder shall continue until a new agreement is reached. It should be understood that there will be no reductions in wages or fringes from the present level unless by mutual consent of the undersigned parties.

PENSION CHANGES

A. Military Service Credit

- 1. Current association members shall be permitted to purchase or pay into the retirement system an amount of service credit equal to no more than three (3) years service time for those who actually served in the armed forces of the United States, or two (2) years non-service time for those who never served, at the rate of the employee's contributing percentage times his base pay, times the number of years he is desirous of purchasing. The base pay, at the time of the request for service credit, shall be used to determine the employee's payment. Said purchase of time shall be on or before July 1, 1981 and, if not, said time shall only be permissibly purchased 30 to 90 days immediately prior to the employee's specified date of retirement.
- 2. New members desirous of purchasing military service time shall be permitted to do so thirty (30) to ninety (90) days prior to the date set for retirement at the present compensation (as reflected on the W-2 form). If a member is entitled to any retroactive monies, for whatever reason, the member shall purchase military time based upon the W-2 form and including payment for retroactivity.
- B. Service Retirement Pension Computation.

Straight Life Pension for any member of the association, new or current, shall be based upon two (2%) percent times the number of years and months of credited service of an employee's final average compensation over the last three (3) years with a maximum of seventy-five (75%) percent of the employee's final average compensation (amending Section 201 (a) of the Red Charter, Policemen and Firemen Retirement System).

- C. The survivor or survivors of members shall receive an amount equal to fifty (50%) percent of said member's retirement benefit. The previous options known as "A" or "B" are eliminated.
- D. A member who is retired on a duty disability pension can earn up to \$15,000.00 over and above the disability pension.
- E. Pension shall be deducted from cleaning, clothing, food or gun allowances afforded members of this Unit only.

Economic

- 1. Two year contract
 - A. First year pay freeze.
 - B. Second year wage re-opener.
 - C. No layoffs during the first year of the contract.
- 2. The management unit shall concede two (2) holidays (Easter and Christmas).
- 3. The management unit sahll reduce their vacation days by two (2); thereby reducing vacation time from thirty-nine (39) days to thirty-seven (37) days.
- 4. New Salary Schedule effective July 1, 1982.

Assistant Fire Chief - \$32,937.00

Police Inspector - \$32,272.00

5. Life Insurance ceases sixty (60) days after layoff.

6. Hospitalization

City shall retain the same Blue Cross/ Blue Shield insurance carrier.

- A. Change from \$1.00 drug co-pay charge to a \$2.00 drug co-pay charge.
- B. Change Master Medical deductible from \$50.00/\$100.00 to \$100/\$200.
- C. Hospitalization re-opener the second year of the agreement.

The parties may begin negotiations about February, 1983, with regards to salary and hospitalization and February, 1984, to modify, change or alter any portion of this document.
