In resolution of the dispute heretofore existent over all of the unsettled terms of the contract currently under negotiation the Panel of Arbitrators awards as follows:

- The contract shall be of a term of three years, commencing on July 1, 1975, and terminating on June 30, 1978.
- The salary levels for each of the following classifications, effective and retroactive to July 1, 1975, shall be:

3. An ambulance bonus of \$312.00 will be paid after July 1, 1976, to cover the period July 1, 1976, through June 30,1977; and an ambulance bonus of \$312.00 will be paid after July 1, 1977, covering the year July 1, 1977, through June 30, 1978.

Any unpaid ambulance bonus of any employee, otherwise eligible, who shall terminate his employment with the City of Hastings shall be prorated on the basis of fifteen cents per hour for all hours worked, to a maximum of 2,080 hours, from and after July 1, 1975, or July 1, 1976, as the case may be.

4. Vacations for the contract years 1975-76, 1976-77 and 1977-78 shall be as follows:
