

### WAGES

# UNION'S FINAL OFFER OF SETTLEMENT:

11.1: <u>Classification and Rates</u>. The foregoing shall constitute a schedule of classification and rates for all employees subject to the terms of this contract:

### WORKER'S COMPENSATION SUBSIDY

UNION'S FINAL OFFER OF SETTLEMENT:

16.1: Worker's Compensation Subsidy. Whenever an employee is entitled to Worker's Compensation payment through the City, he shall endorse his Worker's Compensation check over to the City and receive in exchange his full regular daytime pay exclusive of any overtime pay, provided the employee makes himself or herself available for a medical check by the City physician when requested. The City shall continue the Life Insurance, Dental Insurance, Optical Insurance and Blue Cross-Blue Shield coverage during the period the employee is under Worker's Compensation. The provisions of this section shall not exceed a maximum of two (2) years' duration.

Worker's Compensation Subsidy to be retroactive to July 1, 1985.

EMPLOYER'S FINAL OFFER OF SETTLEMENT:

16.1: Worker's Compensation Subsidy. Whenever an employee is entitled to Worker's Compensation payment through the City, he shall endorse his Worker's Compensation check over to the City and receive in exchange his full regular daytime pay exclusive of any overtime pay for the same period for which he receives Worker's Compensation pay. The provisions of this section shall expire after two (2) year's duration.

The Worker's Compensation Subsidy is retroactive to July 1, 1985.

Add language to contract:

Sergeants assigned to shift commander duties in the absence of a Lieutenant shall receive Lieutenant's pay.

Step-Up Pay to be retroactive to July 1, 1985.

EMPLOYER'S FINAL OFFER OF SETTLEMENT:

10.7 Working Out of Classification. In the absence of the Sergeant on the shift, the senior man shall fill the vacancy and receive the appropriate pay while acting in such capacity. No employee on probationary status shall fill any vacancy.

#### VACATION TIME

UNION'S FINAL OFFER OF SETTLEMENT:

12.3: Length of Vacation - Police Officers and ACO. For all employees the amount of vacation awarded after one (1) year of service shall be one (1) week; from one (1) year to the end of three (3) years of employment, two (2) weeks of vacation shall be awarded; from the fourth (4th) year through the end of the sixth (6th) year of employment, three (3) weeks of vacation shall be awarded; from the seventh (7th) year through the end of the ninth (9th) year of employment, four (4) weeks of vacation shall be awarded; after ten (10) years of employment, five (5) weeks of vacation shall be awarded. Each employee shall receive one (1) additional vacation day for every year thereafter of service after ten (10) years of service in the Department.

Vacation Time to be effective June 30, 1986.

Residency to be effective date of award.

8.20: Residency. The provisions relative to residency will prevail as provided in the City Charter.
