By letter of August 26, 1969, the Hearings Officer was appointed by the Employment Relations Commission as its Officer and Agent to conduct a fact finding hearing pursuant to Section 25 of Act 176 of Public Acts of 1939, as amended, and the Board's Regulations thereunder. The appointment arose from a Petition from the Allen Park Public Schools dated August 26, 1969.

The Hearings Officer contacted the respective parties and the initial fact finding was held on September 2, 1969 and adjourned to September 3, 1969 and terminated on that date. On September 4, 1969 the Hearings Officer wrote a preliminary letter report recommending a certain Salary Schedule. On September 5, 1969 the Hearings Officer advised the parties by telephone of his proposed recommendations on the remaining issues which are included in this Report.

Prior to the hearing, the Hearings Officer was provided with a statement of the positions of the Board of Education and the Union, which is attached hereto and included herein as Exhibit A, to which reference will be made from time to time in this report. Certain corrections have been made by the Hearings Officer to Exhibit A in order to conform with the paragraphs in the labor contract.

The Hearings Officer was impressed by the clarity of the presentation by both parties and on the basis of all the evidence presented, would make the following recommendations:
