ARTICLE I

Recognition

A. The Board hereby recognizes the Association as the exclusive and sole bargaining representative for all certificated personnel whether under contract, on leave, on a per diam basis, employed or to be employed by the Board, excluding: Superintendent, Principala, Assistant Principals, and supervisors within the meaning of the Public Employment Relations Act. The term "teacher," when used hereinafter in this Agreement, shall refer to all employees represented by the Association in the bargaining or negotiating thit as above defined, and references to male teachers shall include female teachers.

B. The Board agrees not to negotiate with any teachers' organization other than the Association for the duration of this Agreement.

ARTIGLE II

Association and Teacher Nights

Pursuant to the Michigan Public Employment A . Relations Act, the Board hereby agrees that every shill be of the Board shall have the right to freely organize, join and support the Association as authorized by law for the purpose of engaging in collective bargaining or negotiation and other concerted activities for mutual aid and protection. As a duly elected body exercising governmental power under cover of law of the State of Michigan, the Board undertakes and agrees that it will not directly or indirectly discourage or deprive or coarce any teacher in the enjoyment of any rights conferred by the Act or other laws of Michigan or the Consittations of Michigan and the United States; that it will not discriminate against any teacher with respect to hours, wages, or any terms or conditions of employment by reason of his membership in the Association, his participation in any activities of the Association or collective professional negotiations with the Board, or his institution or any grievance, complaint or proceeding under this Agreement.

B. Nothing contained herein shall be construed to deny or restrict to any teacher rights he may have under the Michigan General School Laws or other applicable laws and regulations. The rights granted to teachers hereunder shall be deemed to be in addition to those provided elsewhere.

C. The Association and its representatives shall have the right to use school buildings at all reasonable hours for meetings or the transaction of official Association business with approval of the building principal.

D. The Association shall have the right to use school facilities and equipment, including typewriters, mimeographing machines, other duplicating equipment, calculating machines, and all type of audio-visual equipment, when such equipment is not otherwise in use. The Association shall pay for the total cost of all materials and supplies incident to such use. The above-mentioned equipment shall not be removed from school building.

E. The Association shall have the right to post notices of of its activities and matters of Association concern on teacher bulletin boards, at least one of which shall be provided in each school building. The Association may use the teacher mail boxes for communications to teachers. No teacher shall be prevented from wearing insignia, pins or other identification of membership in the Association either on or off school premises. F. The Board agrees to furnish to the Association in response to reasonable requests from time to time all available information concerning the financial resources of the district, tentative budgetary requirements and allocations and such other information as is public information and will assist the Association in developing intelligent, accurate, informed and constructive programs on behalf of the teachers and their students, with the exception of the personnel file.

G. The Board will seek recommendations from the Association on new or modified fiscal, budgetary or tax programs, construction programs, or major revisions of educational policy, which are proposed or under consideration. Their recommendations will be sought prior to their adoption and/or general publication.

ARTICLE III

Board Rights

"The Board, on its own behalf and on behalf of the electors of the District, hereby retains and reserves unto itself, without limitation, all powers, rights, authority, duties and responsibilities conferred upon and vested in it by the laws and the Constitution of the State of Michigan, and of the United States, including, but without limiting the generality of the foregoing, the right:

- To the executive management and administrative control of the school system and its properties and facilities, and the activities of its employees.
- (2) To hire all employees and subject to the provisions of law, to determine their qualifications and the conditions for their continued employment, or their dismissal or demotion; and to promote, and transfer all such employees.
- (3) To establish grades and courses of instruction, including special programs, and to provide for athletic, recreational and social events for students, all as deemed necessary or advisable by the Board.
- (4) To decide upon the means and methods of instruction, the selection of textbooks and other teaching materials, and the use of teaching aids of every kind and nature.
- (5) To determine class schedules, the hours of instruction, and the duties, responsibilities, and assignments of teachers and other employees with respect thereto, and with respect to administrative and non-teaching activities, and the terms and conditions of employment.

The exercise of the foregoing powers, rights, authority, dubies and responsibilities by the Board, the adoption of policies, rules, regulations and practices in furtherance thereof, and the use of judgment and discretion in connection therewith shall be limited only by the specific and express terms of this agreement and then only to the extent such specific and express terms hereof are in conformance with the Constitution and Laws of the State of Michigan, and the Constitution and Laws of the United States."

ARTICLE IV

Deductions for Professional Dues

A. Teachers may at any time sign and deliver to the Board an assignment authorizing deduction of membership dues and assessments of the Association (including the National Education Association and the Michigan Education Association). Such authorization shall continue in effect unless subsequent to June 1st and prior to September 15th of any year, such authorization is formally revoked by the teacher in writing and copies thereof are delivered to the Association and the Board.

B. The deduction of membership dues shall be made from one regular pay check each month, for ten (10) months, beginning in September and ending in June of each year and the Board agrees promptly to remit to the respective Associations all monies so deducted, accompanied by a list of teachers from whom the deductions have been made.

ARTICLE V

Teaching Hours and Class Load

A. The teacher's daily required time in the building shall not be less than seven (7) hours nor more than seven hours (7:30) minutes including a lunch period of not less than thirty (30) minutes. (For exceptions see E below.)

B. The normal weekly teaching load shall include one preparation period and one assigned non-teaching period per day. Should it be necessary, with the teacher's agreement, to assign an extra teaching period, in place of the preparation period, extra compensation shall be added. This compensation to be determined by dividing the base pay by the number of periods. The elementary teacher shall have the equivalent of the 5 junior and senior preparation periods per week. Any departure from these norms, except in case of emergency, shall be authorized with prior consultation with the teacher.

C. All teachers shall be entitled to a duty-free uninterrupted lunch period of at least 30 minutes.

D. Elementary teachers will rotate recess duty whereby each teacher will have one duty-free (20 minutes) recess duty. Elementary teachers may use for preparation all time during which their classes are receiving instruction from various teaching specialists.

E. Daily preparation for effective teaching, correcting examination papers, themes, attending faculty meetings and similar activities require many hours of application outside the classroom and add to the professional responsibilities of the teacher. In addition, demands are made for attendance at staff conferences, parent-teacher conferences, PTA meetings, and the like, which demands can readily become excessive. It is accordingly agreed that such extra-curricular activities shall be kept at a minimum.

F. A teacher engaged during the school day in negotiating in behalf of the Association with any representative of the Board or participating in any professional grievance negotiation, shall be released from regular duties without loss of salary. G. Since pupils are entitled to be taught by teachers who are working within their area of competence, teachers shall not be assigned, except temporarily and for good cause, outside the scope of their teaching certificates or their major or minor field of study. Should a teacher be assigned to a class which is outside his area of competency, the Board shall make no reference in writing as to the teacher's compatence in the area nor consider such competency when determining probationary, tenure, or promotional status.

H. Teachers who will be affected by a change in grade assignments in the elementary school grades and by changes in subject assignment in the secondary school grades will be notified and consulted by their principals as soon as practicable and when possible prior to June 1st. Such changes will be voluntary to the extent possible.

ARTICLE VI

Teaching Conditions

The parties recognize that the availability of optimum school facilities for both student and teacher is desirable to insure the high quality of education that is the goal of both teacher and the Board. It is also acknogledged that the primary duty and responsibility of the teacher is to teach and that the organization of the school and the school day should be directed at insuring that the energy of the teacher is primarily utilized to this end.

A. Because the pupil-teacher ratio is an important aspect of an effective educational program, the Board will make a continuing effort to reach the state recommended standard. In the event that an elementary teacher's pupillead exceeds this standard by an amount in excess of 15% (3) pupils), the teacher shall receive extra componsation in the amount of \$200 per pupil exceeding the standard.

B. In the event that easay or lengthy examinations of a written nature are required by the Board, the teacher shall be given a minimum of one-half day in which to grade such examinations if such examinations are required at the end of semesters.

C. In addition to the above-mentioned time, each teacher shall be given at least one full day prior to the distribution of report cards in order to average and enter grades on the report cards, This day shall not be a Saturday. Sunday, or holiday.

D. The Board shall make available one room in each school for adequate lunchroom, restroom, and lavatory facilities exclusively for teacher use and such room, appropriately furnished, shall be reserved for use as a faculty lounge in which smoking shall be permitted. Appropriate vending machines for beverages, etc., shall be allowed in said room at no expanse to the Board.

E. Telephone facilities shall be made available to teachers for their reasonable use at no expense to the Board.

F. Adequate parking facilities shall be made available to teachers for their exclusive use. In the event the parking area is not paved, teachers shall be allowed to enter the building at the nearest entrance to the building. All parking shall be on school grounds.

G. Notwithstanding their employment, teachers shall be entitled to full rights of citizenship and no religious or political activities of any teacher or the lack thereof shall be grounds for any discipline or discrimination with respect to the professional exployment of such teacher. The rpivate and personal life of any teacher is not within the appropriate concern or attention of the Board, unless it reflects on his teaching ability or becomes detrimental to the educational goals of his relationship to his students, or personal conduct which adversely reflects upon the achool system or the community.

ARTICLE VII

Qualifications and Assignments

A. No teacher shall be hired that does not hold a teaching certificate unless such teacher is not available. In that case, a specially certified ... candidate may be hired but cannot advance above the minimum on the regular certified teacher salary schedule.

B. Any assignments in addition to the normal teaching schedule during the regular school year, including adult education courses, driver education, extra duties enumerated in Schedules B, and summer school courses, shall not be obligatory but shall be with the consent of the teacher. Preference in making such assignments will be given to qualified teachers regularly employed in the district.

ARTICLE VIII

Vacancies, Promotions and Transfers

A. The Board declares its support of a policy of filling vacancies from within its own teaching staff. Whenever a vacancy arises or is anticipated, the superintendant shall promptly notify the Association. Vacancies shall by filled on the basis of the experience, competency and qualifications of the applicant, length of service in the district, and other relevant factors.

B. An involuntary transfer will be made only in case of emergency or to prevent undue disruption of the instructional program. The superintendent shall notify the affected teacher of the reasons for such transfer and the association of such transfer.

C. Any teacher who shall be transferred to a supervisory or executive position and shall later return to a teacher status shall be entitled to retain such rights as he may have had under this Agreement prior to such transfer to supervisory or executive status.

ARTICLE IX

Sick Leave Pay

A. A beginning teacher shall be entitled to ten (10) days sick leave for the ensuing school year immediately upon signing his contract, but payable only upon commencing his assigned duties to which said contract applies.

B. Each teacher shall be entitled to an accumulation of the unused portion of each year's ten (10) day sick leave which shall be available in future years. Provided, however, such sick leave may not accumulate beyond minety (90) days, including the current school year.

C. If any employee exceeds his allowable days of 140 sick leave, his contractual salary shall be reduced by 1/180 for each day.

D. Accumulated sick leave is forfeited when a teacher leaves the school system for teaching duties at another school system, and re-employment by the Deerfield Public Schools shall not reinstate such forfeited accumulation of sick leave.

E. Absence due to injury incurred in the course of the teacher's employment shall be charged against the teacher's sick leave days at the rate of ½ day per day, provide that the board shall pay to such teacher ½ of his daily wages for the duration of the injury or for the duration of the available sick leave, whichever is the lesser.

ARTICLE X

Leaves of Absence

A. Any tenure teacher whose personal illness extends beyond the period compensated under Article VIII shall be granted a leave of absence without pay for such time as is necessary for complete recovery from such illness, but not to exceed one (1) year for less than foru (4) years of service or two (2) years for four (4) or more years of service.

B. Leaves of absence with pay chargeable against the teacher's allowance for sick leave shall be granted for the following reasons:

- A maximum of five (5) days per school year for a critical illness in the immediate family as defined in C(1) of this Article.
- (2) One day when emergency illness in the family requires a teacher to make arrangements for necessary medical or nursing care.
- (3) One (1) day shall be granted for personal business, as described in Article XI after the personal business day in Article XI has been used.
- (b) Time necessary for attendance at the funeral service of a person whose relationship to the teacher warrants such attendance.

C. Leaves of absence with pay not chargeable egainst the teacher's sick leave allowance shall be granted for the following reasons:

- (1) A maximum of three (3) days per school year for a death in the immediate family. "Immediate family" has been interpreted to include father, mother, brother, sister, husband, wife, child, parent-inlaw, or any other member of the family or household who has clearly stood in the same relationship with the employee.
- (2) Time necessary to take the selective service physical examination.

D. Leaves of absence without pay may be granted upon application for the following purposes:

(1) Saudy related to the teacher's license field.

- (2) Study to meet eligibility requirements for a license other than that held by the teacher.
- (3) Study, research, or special teaching assignment involving probable advantage to the school system when not required by the school system.

In such event a year of approved service shall be applied toward immediate future employment.

E. Teachers who are officers of the Association or are appointed to its staff may, upon proper application, be given leave of absence without pay for the purpose of performing duties for the Association. Teachers given leave of absence without pay shall receive credit toward the annual salary increment on the schedule appropriate to their rank.

F. Military leaves of absence shall be granted to any teacher who shall be inducted or shall colist for military duty to any branch of the Armed Porces of the United States. A teacher who re-enlists shall not be considered under the provisions of this article.

Teachers on military leave shall be given the benefit of any increment and sick leave allowances which would have been credited to them had they remained in active service to the school system.

ARTICLE XI

Personal Business

A. At the beginning of every school year, each teacher shall be credited with one (1) day to be used for the teacher's personal business. A personal business day may be used for any purpose at the discretion of the teacher. A teacher planning to use a personal leave day or days shall notify his principal at least one day in advance, except in cases of emergency. A teacher shall not be required to give any explanation for a personal business day unless he desires to do so. Such days shall not be available the immediate day preceding or following a vacation, unless an emergency occurs, and such days shall not accumulate from one year to the next.

B. A teacher called for jury duty or to give testimony before any judicial or administrative tribunal shall be compensated for the difference between the teaching pay and the pay received for the performance of such obligation.

ARTICLE XII

TEACHER EVALUATION

A. No teacher evaluation shall be made this 1967-68 school year until such time that the teacher committee and administration have successfully worked out the precedure. Upon completion of the evaluation procedure, it shall be typed and added to each teachers contract. The Master

ARTICLE XILI

Professional Behavior

A. The Board recognizes that the Code of Ethics of the Education Profession is considered by the Association and its membership to define acceptable criteria of professional behavior. The Association shall deal with ethical problems in accordance with the terms of such Code of Ethics of the Education Profession.

B. The Association recognizes that abuses of sick leave or other leaves, chronic tardiness or absence, willful deficiencies in professional performance, or other violations of discipline by a teacher reflect adversely upon the teaching profession and create undesirable conditions in the school building. Alleged breaches of discipline or the Code of Ethics of the Education Profession shall be promptly reported to the offending teacher and to the Association. The Association will use its best efforts to correct breaches of professional behavior by any teacher and, in appropriate cases, may institute proceedings against the offending teacher.

C. A teacher shall be entitled to a follow-up meeting with the administration after being disciplined, reprimended, warned if he/she so desires an Association representative present. If a second meeting is requested, no action shall be taken until after said meeting.

ARFICLE XIV

Reduction in Fersonnel and Annexations and Consolidations of Districts

A. To the full extent permitted by law, this Agreement shall be binding upon the Board and its successor personnel and upon any school district into which or with which this district shall be merged or combined.

B. In the event this district shall be combined with one or more districts, the Board will use its best efforts to assure the continued recognition of the Association and the continued employment of its members in such consolidated district.

C/ Should substantial and unforseen changes in student population or other conditions make necessary a general reduction in the number of teachers employed by the Board, the Board will retain, as nearly as possible, these teachers with permanent teaching certificates having the longest service in the district. The Association and Board will further use their best efforts to assist all teachers terminated for lack of work to secure employment in adjacent school districts upon terms and conditions as nearly comparable as pessible. Nothing herein shall relieve the Board from fulfilling the terms of any contract with a teacher.

ARTICLE XV

Continuity of Operations

A. Both parties recognize the desirability of continuous and uninterrupted operation of the instructional program during the normal school year and the avoidance of disputes which threaten to interfere with such operations. Since the parties are establishing a comprehensive grievance procedure under which unresolved disputes may be settled by an impartial third party, the parties have removed the basic cause of work interruptions during the period of this Agreement. The Association accordingly agrees that it will not, during the period of this Agreement, directly or indirectly, engage in or assist in any strike, as defined by Section 1 of the Public Employment Relations Act.

B. The Board agrees that it will not, during the period of this Agreement, directly or indirectly engage in any unfair labor practice as defined by Section 10 of the Public Employment Relations Act.

C. When school is in session, all suployees are to be in attendance.

ARTICLE XVI

School Calendar

A. The following legal holidays shall be observed and school closed.

Christmast Beginning the end of the 312 calendar day prior to Christmas and ending the first school day following January 1, unless said day be a Friday; Easter: Good Friday ending at noon plus 5 working days; Memorial Day; Labor Day; Thanksgiving Day and the Friday immediately following.

ARTICLE XVII

Professional Compensation

A. The seleries of teachers covered by this agreement are set forth in Schedule A which is attached to and incorporated in this Agreement. Such selery schedule shall remain in effect for one year, provided, however, that upon written notice to the other party at least sixty (60) days prior to the first day of May of every year of this Agreement, either party may request the reopening of negotiation of such salary schedule.

B. It shall be considered a violation of this contract for the Board to employ a teacher at a salary higher or lower than that which is specifically stated for said teacher's level of experience, and/or preparation.

5. The salary schedule is based upon a normal weekly teaching load not to exceed 5 days per week nor 190 days per year. Activities such as PTA, parent-teacher conferences, and teacher meetings shall be considered a part of the regular teaching load. The Administration is advised to plan a reasonable number of these during the school day after consultation with the Association if so requested.

D. Teachers shall be required to report to work for the 190-day contractual period.

E. A maximum of four (4) days may be allowed for a representative of the Association to attend area or regional meetings of the MEA or NEA. Approval of the Superintendent shall be required for such attendance if to be without loss of salary.

ARTICLE XVIII

Student Discipline and Teacher Protection

Since the teacher's authority and effectivenes A. in his classroom are undermined when students discover that there is insufficient administrative backing and support of the teacher, the Board recognizes its responsibility to give all reasonable support and assistance to teachers with respect to the maintenance of control and discipline in the classroom. The Board further recognizes that the teacher may not fairly be expected to assume the role of warden or custodian for enotionally disturbed students nor to be charged with responsibility for psychotherapy. Whenever it appears that a particular pupil requires the attention of special counselors. social workers, law enforcement personnel, physicians or other professional persons, the Board will take reasonable steps to relieve the teacher of responsibilities with respect to such pupil.

B. It is recognized that discipline problems are less likely to occur in classes which are well taught and there a high level of student interest is maintained. It is likewise recognized that when discipline problems occur, they may most constructively be dealth with by encouragement, praise and emphasis upon the child's desirable characteristics. A teacher may use such force as is necessary to protect himself from attack or to prevent injury to another student.

C. A teacher may exclude a pupil from a class on a temporary basis, when the grossness of the offense, the persistence of the misbehavior or the disruptive effect of the violation makes the continued presence of the student in the classroom intolerable. In such cases, the teacher will furnish the principal, as promptly as his teaching obligations will allow, full particulars of the incident.

D. Any case of assault upon a teacher shall be promptly reported to the Board or its designated representative. The Board will provide legal counsel to advise the teacher of his rights and obligations with respect to such assault and shall render all reasonable assistance to the teacher in connection with handling of the incident by law enforcement and judicial authorities.

E. If any teacher is complained against or sued by reason of proper disciplinary action taken by the teacher against a student, the Board will provide legal counsel and render all necessary assistance to the teacher in his defense. The provisions of this paragraph shall in no way be deemed as assumption of any legal responsibility for liability arising from willful, intentional, and wrongful act as determined by proper court of law of a teacher for which the Board shall respond in damages.

F. The lost by a teacher in connection with any incident mentioned in this Article shall not be charged against the teacher. This shall not apply to any disciplinary action ruled improper through court of law or mutual settlement against the teacher.

G. The Board will reinburse teachers for any malificus loss, damage or destruction of clothing or personal property of the teacher while on duty in the school or on the school premises if not reinbursable otherwise.

H. No action shall be taken upon any complaint by a parent of a student directed toward a teacher, nor shall any notice thereof be included in said teacher's personnel file unless such matter is promptly reported in writing to the teacher concerned. If any question of breach of professional ethics is involved, the Association shall be notified.

ARTICLE XIX

Professional Grievence Procedure

A. A claim by a teacher or the Association that there has been a violation, misinterpretation or misapplication of any provision of this Agreement or any rule, order or regulation of the Board may be processed as a grievance as hereinafter provided. However, if an individual teacher has a personal complaint which he desires to discuss with a supervisor, he is free to do so without recourse to the grievance procedure.

A. The Grievant may invoke the formal grievance procedure on the form set forth in annexed Schedule C, signed by the grievant and a representative of the Association, which form shall be available for the Association representative in each building. A copy of the grievance form shall be delivered to the principal or supervisor. If the grievance involves more than one school building, it may be filed with the superintendent or a representative designated by him.

C. Within three (3) school days of receipt of the grievance, the principal or supervisor shall meet with the Association in effort to resolve the grievance. The principal or supervisor shall indicate his disposition of the grievance in writing within three days of such meeting, and shall furnish a copy thereof to the Association.

D. If the Association is not satisfied with the disposition of the grievance, or if no disposition has been made within three school days of such meeting (or six school days from the date of filing, whichever shall be later) the grievance shall be transmitted to the superintendent. Within five school days the superintendent or his designee shall meet with the Association on the grievance and shall indicate his disposition of the grievance in writing within three school days of such meeting, and shall furnish a copy thereof to the Association.

B. If the Association is not satisfied with the disposition of the grievance by the superintendent or his designes, or if no disposition has been made within three school days of such meeting (or 8 school days from the date of filing, whichever shall be later), the grievance shall be transmitted to the Board by filing a written copy thereof with the Secretary or other designee of the Board. The Board, no later than its next regular meeting or two calendar weeks, whichever shall be later, may hold a hearing on the grievance, review such grievance in executive session, or give such other consideration as it shall deem appropriate. Disposition of the grievance in writing by the Board shall be made no later than seven days thereafter. F. If any teacher for whom a grievance is sustained shall be found to have been unjustly discharged, he shall be reinstated with full reinbursement of all professional compensation lost. If he shall have been found to have been improperly deprived of any professional compensation or advantage, the same or its equivalent in money shall be paid to him.

E. The time limits provided in this Article shall be atrictly observed but may be extended by written agreement of the parties. In the event a grievance is filed after May 15th of any year and strict adherence to the time limits may result in hardship to any party, the Board shall use its heat efforts to process such grievance prior to the end of the school term or as soon thereafter as possible.

H. He grievance shall be adjusted without prior notification to the Association and opportunity for an Agsociation representative to be present, for shall any adjustment of a grievance be inconsistent with the temms of this Agreement. In the administration of the grievance procedure, the interests of the teachers shall be the sole responsibility of the Assoclation.

ANTIGLE XX

Negotiation Procedures

A. Terms and conditions of employment provided in this agreement shall remain in effect until altered by mutual agreement in writing between the parties. Nevertheless, because of the special nature of the public educational process, it is likewise recognized that matters may from time to time arise of vital mutual concern of the parties which have not been fully or adequately negotiated between them. It is in the public interest that the opportunity for mutual discussion of such matters be provided. The parties accordingly undertake to cooperate in arranging meetings, selecting representatives for discussion, furnishing necessary information and otherwise constructively considering and resolving any such matters.

B. A reasonable time prior to expiration of this Agreement, upon request of either party, negotiations will be undertaken for an agreement covering the 1968-1969 school year.

C. Who no final agreement shall be executed without ratification by the Association and Board of Education, the parties autually pledge that their representatives will be clothed with all necessary power and authority to make proposals, consider proposals, and make concessions in the course of negotiations.

IXX LIDITSA

Miscellaneous Provisions

A. In the event a substitute teacher is not available and it is necessary to use a regular staff member as a teacher, the teacher shall be paid an amount equal that paid a substitute teacher for each class the teacher substitutes based on per class rate. In the event of an emergency arising during the course of the day, a teacher may substitute on a voluntary basis with no reimbursement if he is asked and agrees to do so.

B. No polygraph or lie detector device shall be used in any investigation of any teacher.

C. The Association shall deal with othical problems arising under the Gode of Ethics of the Education Profession in accordance with the terms thereof and the Board recognizes that the Gode of Ethics of the Education Profession is considered by the Association and its membership to define acceptable eriteria of professional behavior.

D. This Agreement shall supersede any rules, regulations or practices of the Board which shall be contrary to or inconsistent with its terms. It shall likewise supersede any contrary or inconsistent terms contained in any individual teacher contracts heretofore in effect. All future individual teacher contracts shall be made expressly subject to the terms of this Agreement. The provisions of this Agreement shall be incorporated into and be considered part of the established policies of the Board.

E. Copies of this Agreement shall be printed at the expense of the Board and presented to all teachers now employed or hereafter employed by the Board.

F. If any provision of this Agreement or any application of the Agreement, or any part of any provision or application of the Agreement shall be found contrary to law, then such provision or application, or part of such provision or application shall not be decaded valid and subsisting except to the extent permitted by law, but all other provisions or applications or remainder of any provision or application shall continue in full force and effect.

G. Bach <u>Association</u> nomber <u>Mill</u> present evidence, upon the first day of work each year, that they have been examined by a licensed physician to determine if he is free from any allocat, disease or defect that would prevent him from performing his duties.

XXIS ARTICLE XXV

DURATION OF AGREEMENT

This agreement shall be effective as of July 1, 1967, and shall continue in effect until the 30th day of June 1968. This Agreement shall not be extended orally and it is expressly understood that it shall expire on the date indicated.

II. PLACEMENT GUIDELINES

The following statements define teacher placement on the salary schedule:

- A. Full credit shall be granted for experience, up to five (5) years, earned in other schools.
- B. Each year of military experience, up to four (4) years, shall be counted as one year of teaching experience.
- C. Maximum outside experience credited for both teaching and military service shall not exceed five (5) years.
- D. Teachers will successfully complete three (3) semester hours or the equivalency thereof every three years until successfully completing his/her master degree in order to qualify for the regular increments.
- E. Salary adjustments for change in classification of degree level shall be made twice a year and shall be in effect as of the beginning of either semester.
- D. Teachers transferring from one degree group to another shall receive the yearly incorment in addition to the increase for additional training, provided that the work completed is recorded in the office of the superintendent not later than 30 (30) days after the start of the local semester.

F. Substitute teachers shall be paid at the rate of \$20 per day
