Changed in the Master Agreement

For 1973-74

The 1972-73 Master Agreement between the Kingsley Education Association and the Kingsley Area School Board shall remain in effect with the exception of the changes listed here.

Article VIII - Leaves (Page 12)

B. Sick Leave

4a. (New Section)

The parties jointly acknowledge that abuse of sick leave has a deleterious effect on the education of children and therefore mutually pledge to dissuade the teaching staff from improper use of sick leave.

Should the administration become aware of circumstances which it believes is an abuse of sick leave, the teacher(s) in question may be called on by an administrator to satisfactorily explain the circumstances. The KEA will be notified of such hearing and will send a representative to the hearing to reaffirm the first sentence in this paragraph. Should the administrator determine that discipline is in order, the KEA representative shall be notified of same. It is expected that the KEA will face up to its responsibility and not pursue grievances which are unmeritorious or based on political expediency.

The KEA affirms that it is the right of the administration and school board to adopt policy and procedure to insure a correct usage of sick leave, however, this shall not deprive the KEA of their normal grievance rights as to the application of policy and procedure pertaining to sick leave.

Article XV - Reduction in Personnel

- B. Previous wording removed and replaced with:
- B. In such case the following procedure shall be used:

.

- 1. All staff members shall be granted seniority equal to the number of years the teacher has taught in the school system.
- 2. Seniority shall be the primary consideration in the lay-off of any teacher, providing that the following conditions are met:
 - a) Teachers must be kept within levels of certification.
 - b) Secondary teachers have seniority rights only in subject matter positions for which they have college major or minor preparations.

- c) A secondary teacher with a major in a teaching area shall have priority over one with a minor.
- d) An elementary teacher shall have seniority rights only in the grade that she is teaching plus one grade above and one grade below her present grade level.
- e) In the event that two teachers with the same seniority shall qualify for one position, then administrative evaluations shall be the deciding factor. It shall be the responsibility of the administration to determine which evaluations are superior.

Article XVIII To Read:

This agreement shall be effective immediately upon ratification by both the KEA and the Kingsley Area School Board and shall continue in effect until the first day of September, 1974.

This agreement shall not be extended orally and it is expressly understood that it shall expire on the date indicated.

Insurance Benefit

- A) The Board shall pay \$47 per month towards the cost of the comprehensive MESSA or blue cross full family health care package for a full twelve month period for the employee's family. All additional programs available through MESSA shall be available at the employee's expense through payroll deduction.
- B) For single teachers the Board will pay completely for the teacher's health insurance under the MESSA-Super Med plan or will pay an equal amount toward health insurance subscribed to under Blue Cross.
- C) Employees not wishing health care protection may apply a \$18.96 per month board subsidy toward the Selective Option package available through MESSA or Blue Cross.
- D) Any amount allowed towards insurance may not be paid to a teacher in cash.
