- II. Deduction for dues (BEA, MEA, and NEA) shall follow the same procedure as previously provided elsewhere.
- III. The teachers work day shall begin 15 minutes before and 1. end 15 minutes after the last regularly scheduled classes.
  - The teaching schedule of classes shall be 5 hours in a normal Ba school day.
  - All teachers shall be provided a duty-free lunch period C. equivalent to the regular lunch period.

  - VIII. Upon the request of either party, BEA or Board, negotiations will be initiated to constructively consider and resolve matters not covered or not clarified by this agreement. The outcome of such negotiations shall be subject to ratification and added as an amendment to this document.
    - IX. As part of this agreement the salaries of certificated personnel and additional compensations for extra duties is set forth in Schedule A. All teachers shall be given credit on the Salary Schedule set forth in Schedule A for each year of outside teaching experience but in no event more than five years.
