With all due respect for the wisdom and integrity of our Board of Supervisors, in their action upon the vexed question of building a new court-house at Ann Arbor, we do not think it will prove satisfactory to the electors and tax-payers of this county. Not because many are opposed to erecting a new court-house at this time; neither for the reason that many will oppose it because they believe that ultimately the county will be located at Ypsilanti.

With all due respect for the wisdom and integrity of our Board of Supervisors, in their action upon the vexed question of building a new court-house at Ann Arbor, we do not think it will prove satisfactory to the electors and tax-payers of this county.

To be sure the Board have passed a resolution which seems to be the entire cost of the county at \$100,000. And Ann Arbor provides \$20,000 more but who is legally bound under every contingency in either case? Was there ever a public building erected by this estimate mode that did not eventually require an additional appropriation to complete it, or for heating apparatus, gas, furniture, or for something overlooked in estimating without a plan of the building, the additional appropriation being often equal to the original estimate, and then came the dilemma, with its choice of two horns, either to leave the building unfinished or to levy an additional tax.

As to all such dilemmas, we present these two horns, and our new court house is not likely to prove an exceptional "muley." We "rise to inquire" why it would not be better to adopt that other mode of building, first to adopt a plan, receive bona fide bids in accordance with that plan, thus ascertaining the total cost beforehand, then levy the tax and erect a building in accordance with that there would be no itching cracks left open to tempt fleecing fingers?
