PRETORIA ALMOST IMPREGNABLE. Cleaning Time

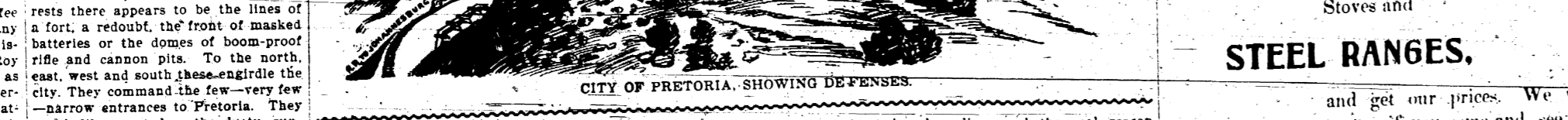

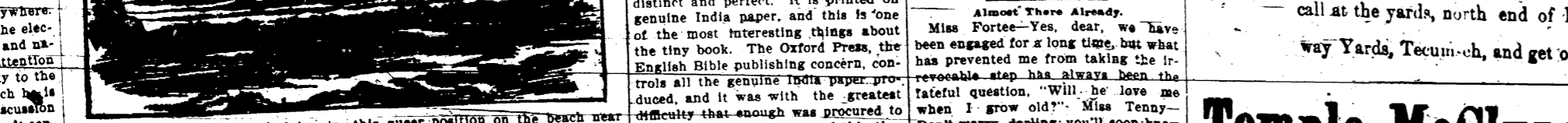
