

NOVEMBER MEETING - FREDRICKSBURG COUNTRY CLUB

The next meeting of the Mid-Atlantic Association will be a joint meeting with the Central Virginia Association. Their Association will be hosts for the meeting which will be held at Fredricksburg Country Club, Fredricksburg, Virginia, on Tuesday, November 5. Mr. Paul Wiess, Sr., superintendent at Lehigh Country Club in Allentown, Pennsylvania, will speak on "Maintenance Methods".

OUR HOST

Mr. Emory Stafford, a member of the Central Virginia Association, has been professional-superintendent at Fredricksburg for the past three years. Mr. Stafford entered this profession in 1958. He relies on the advice of Earnest Stanley and Jim Reynolds on turf matters and also keeps well informed by attending the superintendents association meetings. Emory was pro-manager at Winter Quarters Country Club in Pocomaker City, Maryland, in 1958. He went from there to Hermitage Country Club in Richmond where he held the position of assistant pro for two and one half years after which time he moved to Fredricksburg.

THE COURSE

Fredricksburg is a private 18-hole golf course. The front nine has been in play for two years. The new nine was designed by Carl Raswik and was built by Mr. Raswik and Mr. Stafford; it has been in play for three years. The layout has a yardage of 6, 302 for a par of 71.

DIRECTIONS TO THE CLUB

Take Route No. 1 south to Fredricksburg, in Fredricksburg take Routes No. 2 and 17 south. The club is three miles from the heart of Fredricksburg, turn left to the club.

THE MID-ATLANTIC 10 YEARS AGO

by L. Robert Shields Ten years ago on November 10, 1963, fifty five members and guests of the Mid-Atlantic met at Manor Country Club where Ernest Parsley was superintendent.

Greens chairman, Louis Fuchs, and club president, Mr. Carney, pointed out that despite the fact that their club house had recently burned down making house social functions impossible, the membership in the club had increased by 100 members indicating that the golf course is the main attraction at Manor.

Officers were elected for the year 1954. They were: Jim Thomas, president; Charles Schalestock, vice president; Bob Scott, Jr., secretary-treasurer. A new set of By-laws was read at this meeting and with the exception of a few minor changes were accepted as read. The president extended thanks to the committee co-chairmen, John Connolly and Admiral Phillips, for their work and efforts in preparing the new By-laws.

Guest speaker, Bob Hagan, began his talk by giving some interesting experiences with Charlie Wilson who had just left the area, then went on with his subject "Grass Roots Irrigation".

Some basic definitions given were:

A Saturated Soil - is one such as we experience after a heavy rain. The soil has all the water it can possibly hold - all pore spaces are completely filled. Field Capacity - sometimes designated as normal capacity. That water which is held in the soil after the gravitational water has drained down.

Wilting Point - The point at which a plant begins to wilt for lack of moisture.

Available Water - the difference between field capacity and the wilting point. The normal moisture range over which plants grow.

There was no Constructive Suggestion Report at the Manor meeting, there was no golf and no one saw the golf course - it was covered with snow.

A LOOK INTO THE FUTURE OF GOLF COURSE DEVELOPMENT VI by Harry C. Eckhoff The National Golf Foundation - a non profit corporation founded in 1936 by the major manufacturers of golf equipment - was organized to meet the need for a national clearing house for information essential to the planning, construction, operation and maintenance of golf courses and to increase public interest in the game.

By 1953 the need for new facilities became so critical that the Foundation sponsors decided to establish a field service to directly assist in the development of all types of golf courses. Today the Foundation maintains four regional field service offices available to any group or individual actively considering the development of new golf courses. In my capacity as Director of the Eastern Region (territory Maine to Florida, which includes 17 eastern states and the District of Columbia) I met with almost 300 planning groups last year to give assistance on overall organizational, operational and maintenance problems.

Golf is big business. It continues to lead in sales of sporting goods equipment. Last year golf equipment sales totalled over \$100 million; this is more than three times the amount sold in 1947 - fifteen years ago.
