NEXT MEETING

The Mid-Atlantic Golf Course Superintendents will meet at The Tantallon Country Club on December 5, 1967 for golf, cocktails, dinner and the annual election of officers for the year 1968. The course will be open for golf all day, weather permitting.

THE COURSE

Construction of the course began in October of 1961 and was completed in May, 1962. The following August the front nine was opened for play. The back nine was not opened for play until May 1963, due to no irrigation for the newly seeded Penncross greens.

MAINTENANCE

The fairways receive 3 pounds of actual nitrogen per acre per year. The fairways have a quick coupling sprinkling system and receive 1" water per week.

The greens are Penncross bent receiving 8 to 10 pounds of actual nitrogen per 1000 square feet annually. Several of the green bases were improperly mixed, therefore leaving layers of turface, sand, humus and top soil. Irregular mix causes poor internal drainage.

The greens are cut three times weekly at 5/6'' during the summer months and 1/4'' during the cool season. The greens are dethatched, top dressed and aerified in the spring and fall.

The roughs are thick with trees and difficult to maintain. Future budgeting will include trimming, removal of dead trees, lime, top soil, seed and fertilizer.

DIRECTION TO THE CLUB

Directions to The Tantallon Country Club: From Baltimore, take Baltimore-Washington Parkway to the Capital Beltway or 495 South, to Indian Head Highway, exit 37 South to Fort Washington Road. Turn right on Fort Washington Road approximately 2 miles and then turn right on St. Andrews Drive into the Club. From Washington, follow directions from 495 only.

EMPLOYMENT INFORMATION FOR BALTIMORE COUNTRY CLUB

We have been requested to advise the members of our association of the following employment opportunity. Due to the death of golf course superintendent Mr. Frank Dunlap, the Baltimore Country Club is now actively seeking to hire a man with the necessary qualification to handle this position.

The Club is an old established one dating back to 1898, operates two eighteen hole courses, both located at the same location just outside of Baltimore. (The courses are better known as Five Farms.) It is near Towson, Maryland.

Minimum Qualifications - Education and experience - The only education needed is a thorough knowledge of grasses, etc. Must be able to maintain a filtration plant as water is supplied from a lake from the club house, swimming pool, etc. The age limit span is from 26 to 50 years.

Duties - Golf course maintenance, budget, purchasing responsibility, trees and shrubbery, club house lawn.

The superintendent is directly responsible to John A. Emich, Golf Committee Chairman. At peak season there are 22 to 24 employees in the grounds crew. This job is open immediately. This is a private membership club, open year round. The annual salary bracket ranges from \$11,000 to \$15,000 with merit raises as seen fit. Fringe benefits include 30 days paid annual vacation, paid annual sick leaves whenever necessary, dues paid for membership G. C. S. A. A., expenses involved in attending regional and national educational conferences. Housing is provided on the Club grounds consisting of an unfurnished five or six room house; utilities not included. The current annual club maintenance budget for the golf course and grounds is \$129,000 with an increase in appropriations for the course as necessary to meet rising costs and normal improvements is anticipated.

Course comprised of 36 holes; yardage - west, 6,400; east, 6,680. Types of grass greens are Bent; tees - various varieties; fairways - Bent, Bermuda. Irrigation is semi-automatic on greens, tees, and fairways. This club has sponsored the P.G.A. Championship in 1928, the U.S.G.A. Amateur in 1932 and the Walker Cup in 1965. 
Springfield County Club - Denny McCammon, Superintendent
