THE Green Section of the Westchester County Golf Association held its first meeting of the year at the Grassy Sprain Golf Club, Bronxville, New York, on June 9, where a program of unusual interest was staged.

The Green committee chairmen of all Westchester clubs were invited, along with their greenkeepers, to play a round of golf in the morning. From 9 A.M. until 6 P.M. there was an exhibition on the lawn facing the clubhouse, and samples of every conceivable item of golf equipment and golf supplies were shown by close on forty dealers and manufacturers.

First in line came the very complete display of the Stumpp & Walter Company, showing everything from a rotary soil screen to glazed china tee balls.

Second came E. L. Winn, Inc., of Elizabeth, New Jersey, who featured equipment manufactured by Messrs. Pattison of England. An all brass putting cup and a proportioning machine of his own manufacture were notable items in his display.

Followed the display table of the Four-Seasons Fertilizer Company, claiming for their product that it has the virtue of retaining moisture and of ultimate reversion to humus in the soil.

The Bayer Company was on hand with Uspulun and Nu-Green, for use in preventing, restoring and curing the dreaded brown-patch.

It was the extreme privilege of these members who attended this meeting to spend a very pleasant day reviewing one of the largest golf courses in the United States under the guidance of Mr. Fred Kruger, the superintendent at Olympia Fields.

The opportunity was given the visiting greenkeepers to view five different varieties of greens, *poa annua* and *poa trivialis* in the seed sown greens and Virginia Bent, Flossmoor and Washington in the Vegetative Bent greens. The subject of the upkeep of these various types of greens was interestingly discussed by Mr. Kruger and in this regard, it is worth while mentioning that Mr. Kruger has shown himself to be one of the most competent greens superintendents in the golf course field. His intelligent discussions of his methods and system of budget used in maintaining these four golf courses which make up this great institution of Olympia Fields proved this beyond question.

A talk was given by Dr. Seaman on soil problems encountered by a number of greenkeepers of our district. One of the problems under discussion, so much in the limelight, was that of "brown-patch."

Luncheon was furnished by the courtesy of the Olympia Fields Country Club to the 35 visiting greenkeepers and a motion was made that we issue a vote of thanks to the chairman of the club and to Mr. Kruger for helping to make the first outdoor meeting the Association has held a very successful one in furnishing the members with practical information as well as exchange of ideas.
