Fellow Greenkeepers:

It was during the year 1926 that the National Association of Greenkeepers was born. When in the embryo stage great care was given in outlining the aims and objects of our organization and deliberations on the destiny of the association were long and I believe wise.

It was then decided that no one individual would ever control the organization, because some time some individual might use the office for mercenary purposes. It is not the intention of the organization to take the voice of the membership out of the association. Justice, benevolence, and education is the foundation of the N. A. G. A. and one man is not big enough to give all of these.

The workings of our organization when the Convention is not in session, is left entirely in the hands

of the Executive committee. All matters of importance must be presented to this committee, and further, to prevent any radical move, any member who has a grievance must first present it before a special committee which must present its findings to the executive board.

There are seven special committees consisting of seven members, each selected and appointed by the President. Each committee is a necessary part of the organization. The duty of the President is to receive instructions and see that they are faithfully performed.

Golf Business Is Good

We have heard a lot about hard times, poor business, etc., since the little party in Wall street last fall. But the golf business is good if purchases of equipment may be considered a fair barometer.

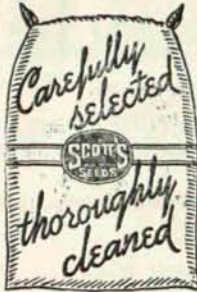
