

Mike writes about "The OAKMONT GOLF COURSES are part of a retirement community. This project was started in 1963 with the last of 36 holes being completed in 1980. There are are 3,400 residents now, with a final population of 5,000 when the building of homes is completed.

The courses are open to the public, but with 1,000 resident golfers, most of the 110,000 annual rounds are by golfers that live at Oakmont. There are cart paths throughout both courses. These are necessitated by 445 privately owned carts and a rental fleet of 30 more.

The meeting will be held at the Oakmont East Club House. Since this location is right next to the golf course maintenance center, you are invited to wonder through it. Any suggestions you have to improve it, are welcome, and you are welcome to any ideas you go away with."
