LARGEST TURNOUT EVER

The regional TARP meeting at Palo Alto Hills G & CC on April 26th was the largest turnout ever for a meeting since the regional format was adopted. A total of 84 people attended a fine meeting and lunch. Those who played golf that afternoon discovered why Tim Sedgley won the award for Excellence in Turfgrass Management. The course was in great shape considering the 2" of rain Tim got that weekend. Super job Tim.

The meeting, conducted by Gordon Scott and Charles McFarland, included speakers: John Zoller "The New NCGA Golf Course at Poppy Hills", Chuck Pratt "The Trouble Shooting Techniques for Turf Management", Larry Costello "Are Nematodes Killing Your Greens", and Bill Davis "An Update on the New Experimental Green".

The architect picked for the "Poppy Hills" lay out was Robert Trent Jones, Jr. John showed the layout over the 168 acres of wooded land purchased on the Monterey Peninsula for \$7,000 an acre. The Pebble Beach Corp. kept some land in and around the golf course for future development. The new NCGA course will sure help alleviate a lot of the pressure of tournaments, tournament dates, and the addition of new tournaments to the other courses in the NCGA.

Chuck brought to light some interesting facts concerning soil tests and the PH of the soil. There are two types of soil tests: dry and saturated paste. There is a significant difference between the two. Chuck uses the saturated paste method as do most companies in the west. It may be necessary for you to try your own comparison to see the difference as Chuck did at UC Davis.

Farm Advisor Larry Costello's topic on Nematodes seemed to stir up quite an interest. The problem came to light last year in the San Francisco and Monterey Bay areas to poa annua greens. Galls were found at the crown of the grass plants which were visible to the naked eye, but inside were upwards to 500 larva which feed on the inside of the plant. If you develop a mottling and yellowing that browns out, and the normal functions of fertilization and fungicides fail to get the grass to respond, look for the galls, get a soil test, and contact your farm advisor or UC Davis. There are nematicides available but are restricted. Nematodes are still being investigated and monitered and we will try to keep everybody updated as much as possible.

Bill Davis reported on the experimental green which is now about 20 months old. More stress tests are being performed, such as aerifying at two o'clock in the afternoon on the hottest day of the year to see how it responds. It will soon be open to foot traffic. There is a grant to enlarge the green for future nutrient tests etc. to aid the homeowner.

Thanks again to Tim and the entire Palo Alto staff for a superior effort.

Joseph Rodriguez started his career at Oak View Cemetery in Antioch in 1959. In 1969 he went to work for Contra Costa County in Landscape. He progressed to the Chief Gardener position where he was in charge of all landscaped and turf areas within the County's jurisdiction. While with Contra Costa County, Joe graduated from Diablo Valley College with a degree in Ornamental Horticulture. He also attended Los Medanos College for two years and possesses a State Contractor's License for Landscaping. Joe has been Superintendent at the Rossmoor Golf Course since 1978.

Rossmoor is a planned adult community that was first opened in 1964. The

community has its own medical clinic and security force for the 8,400 residents whose age averages 74.5 years. Rossmoor maintenance and management is administered by the Golden Rain Foundation.

The 18 hole private golf course was dedicated in 1964 with a new 9 holes added in 1975. The new 9 were designed by Robert Muir Graves and blended into the back nine for the 18 hole South Course. The original front nine became the North Course.

The South Course is rated at 67.9 from the white tees with a length of 5,765 yards. Cart paths extend from Tee to Green with carts restricted at all times. Because of the age factor there is no rough, with approximately 175 acres of fairways being mowed $2\frac{1}{2}$ times a week. Rossmoor has averaged 88,000 rounds of play a year over the past 3 years.


The 11th green on the South course has been rebuilt with the 8th green scheduled next. In addition, new bunkers are scheduled to the right of the 6th and 15th greens.



CALIFORNIA GOLF COURSE SUPERINTENDENTS ASSOCIATION

TO SAY the 1983 California GCSA annual meeting and conference was a success would be a severe understatement. The San Diego Chapter, Dave Fleming and his crew, and all the staff at Singing Hills Country Club came up with a superior effort. You could find no fault in their efforts from the warm welcome of the club house and pro shop staffs, and the fine meals, to the excellent educational sessions with exceptional speakers.

John Van Dam led off with a talk on integrated pest management (1. Genetic 2. Physical 3. Cultural 4. Regulatory) He then presented us with an updated report on the 5 year research project called CIMIS California Irrigation Management Information System.

Dave Schultheiss talked on aquatic weed control, mechanical, biological, growth regulators, and chemical to control the 3 types - submused, emersed, and free floating. Dave noted one thing of interest - he mixes cutrine to diquot for a better thoroughness of kill and a longer residual effect.

Mill Maker, So. California, Vice-Fres

Dr. Joe Vargas followed with a talk on disease, not just fungi but bacterial disease. It infects the cells that transfer the water thru the plant.

Roy McMikkin of the B. Hayman Co. gave a slide presentation of the types of equipment at national equipment shows in England and Japan. It showed the on site demonstrations in England to the exclusive Japanese only equipment (with a resemblance to American) show, geared to their 900 private courses.

Dave Fleming's presentation on color on the golf course was self evident. All you needed to do was walk outside and look around. With about \$4,000 worth of annuals, it is a nice compliment to all the other trees and shrubs.

Jim Lipari of Upjohn Co. discussed the control of diseases with a nice slide presentation of all the major diseases and their control.

Craig Kolodge talked on growth regulators. Primarily Embar, Maintain and Atrinol and what kind of results you get from the three.

Don Niboli of Wilbur-Ellis had a presentation on incapsulation. He spoke of a product Bivert that stops evaporation, is a drift retardant, gives superior coverage, sticks to target, easy to use, and economical.
