Within the structure of the GCSA of Northern California, a card is presented to each member which identifies his classification and affiliation

with this organization. At the present time, this card only has one restriction to its use. "Call the host Superintendent in advance to inform him of your intention to play his golf course." This courtesy is three-fold: it shows professional courtesy, you would be informed of possible tournaments and tee time conflicts, and you should be insured of a complimentary round of golf because; as was mentioned before, it is at the discretion of each club whether you can play and/or pay. The membership card that we possess should not and does not give the carrier "carte blanche" privileges at other golf clubs without going through the proper channels.

Please use this card with the best interest of our association in mind. It would be a real discourtesy to everyone involved to have this privilege revoked.

Seed update - by Don Naumann

Most cool season grass seed used on golf courses is grown in the Willamette Valley of Oregon. Like other agricultural crops, the hope of a good crop is determined by mother nature.


Going into this summer harvest the crop looked excellent, promising farmers another banner year. However, this year is going to be a very frustrating one.

In the Willamette Valley most grass is dry farmed so no supplemental irrigation is required. When the plant has seeded out, it is normally swathed (cut) and layed to dry in the fields for 7 to 10 days. By that time the stalk is sufficiently dry enough to be ground up by a combine (cont. on page 7)


HOST SUPERINTENDENT

and the seed can then be removed. This year after swathing there was almost 6 straight weeks of rain. As a result the earlier varieties began to rot and in some cases sprouted in the fields. The types of grasses affected are mostly the ryegrasses and fescues (both fine leafed and turf-type tall varieties.)

The prices on these types are sure to rise after last years excess inventory is depleted. It is an estimated \$75 million loss for the seed industry in Oregon. Later seeding grasses like bentgrass, bluegrass, and Elka ryegrass as of now have not been affected.
