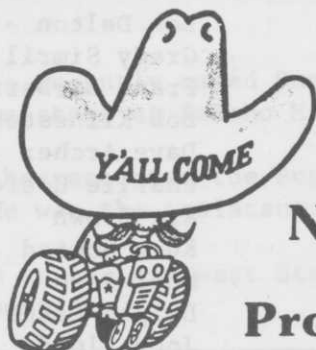

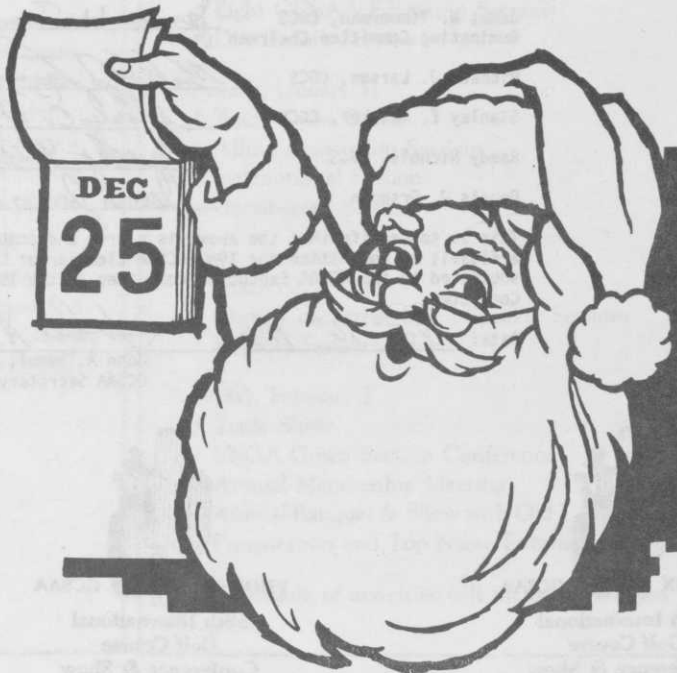
SUPERINTENDENTS ASSOCIATION: November 9, 1986 -
