# Tips from the USGA Are You Listening to Real Golfers?

Sometimes you have to just sit back and wonder about some comments golfers make. For example, a couple of years ago I was riding around with a new member on one of America's top ten courses, and on the 14th fairway he started complaining about ballmarks. Not ballmarks on the greens, mind you, but ballmarks on the fairway! Furthermore, his belief was that if the maintenance staff could not keep up with things, the members were going to have to play Winter Rules. How would you even begin with a response to such a ridiculous statement?

Let me tell you what I wanted to say: "Hey mister, are you a real golfer, or are you just someone pretending to be a real golfer? Because if you're just pretending, then I'll pretend I'm your doctor and prescribe 10cc's of cyanide."

If you're not sure what a "real" golfer is, here is a list you can use.

### **Real Golfers:**

- 1. know that it is not always possible to find their ballmark, so they fix all the ballmarks they find. They would also never complain to the superintendent about unfixed ballmarks, they would talk to their fellow players, who are responsible!
- 2. know better than to clean their balls in their mouth. Not because they are worried about pesticide residue, but because they know better than to eat dirt!
- 3. never move their ball on the fairway, even if it is resting in a divot.



- 4. play in the rain, but leave the course when lightening threatens their safety.
- have a dream of playing Augusta National before they die. Video golf doesn't cut it either.
- 6. never drop their cigarette butts and other trash on the course.
- 7. know that Jack Nicklaus is the greatest golfer of all time. They can also tell you how many U.S. Opens, British Opens, PGA Championships, and Masters Tournaments he has won. By the way, he has also won both the U.S. Amateur and the U.S. Senior Open twice. If that isn't great golf, what is?
- don't need yardage markers on all the sprinkler heads. They also don't need red, white and blue flags, and whiffle balls on the flagpoles.


