IT'S TIME WE SHARED THE GOOD NEWS ABOUT GOLF AND THE ENVIRONMENT

Because of the negative and emotional exposure from television and radio news stories, it has been an uphill battle for the golf industry to portray a positive image and separate fact from fiction. The overwhelming majority of superintendents and golf courses we visit go to extraordinary lengths to ensure that the golf course is a safe place to be for golfers, employees, and wild life.

Several years ago, the USGA and other organizations realized that the only way to fight this emotional argument is by conducting unbiased research to get factual information on the effects of golf courses on the environment. It was also important to report the results without any "sugar coating" so that detractors of the golf industry could not find fault with the results. Although everyone felt confident that the results would be good, there was some uneasiness about what the studies would actually reveal. Well, the results from the first set of studies are in, and

for the most part, the news is very positive. At each of our Green Section Regional Conferences this year, the morning program will be devoted to presenting this information in a clear and easy to understand format.


For the Office of Vice Pres. Leon Snethen


