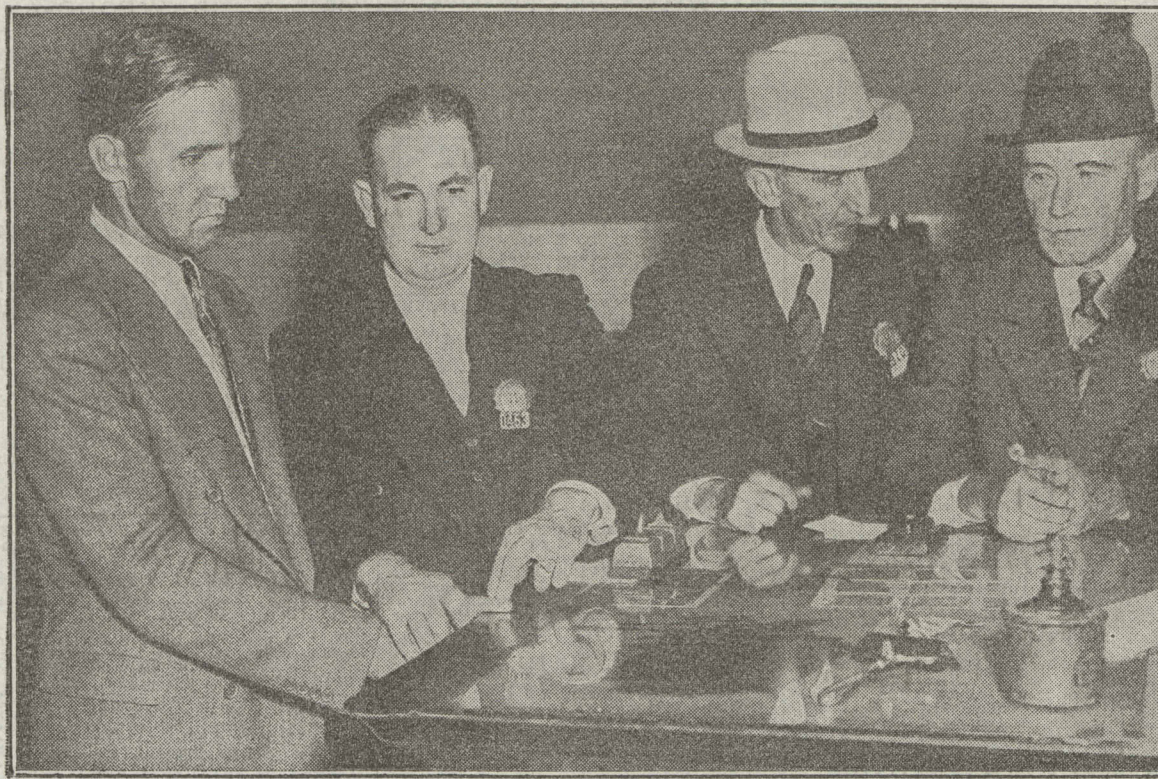


# Warant Names Hauptmann as Lindbergh Baby Slayer—Persists in Denials as He Is Arraigned in Court

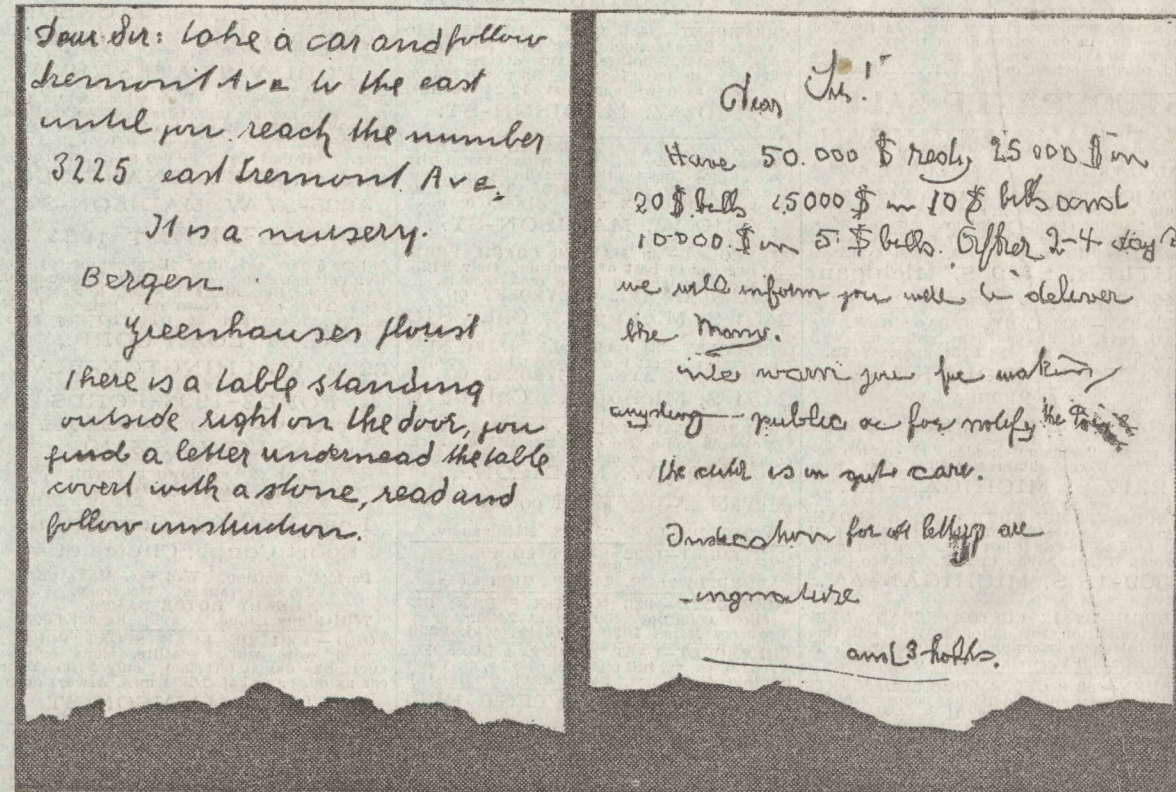

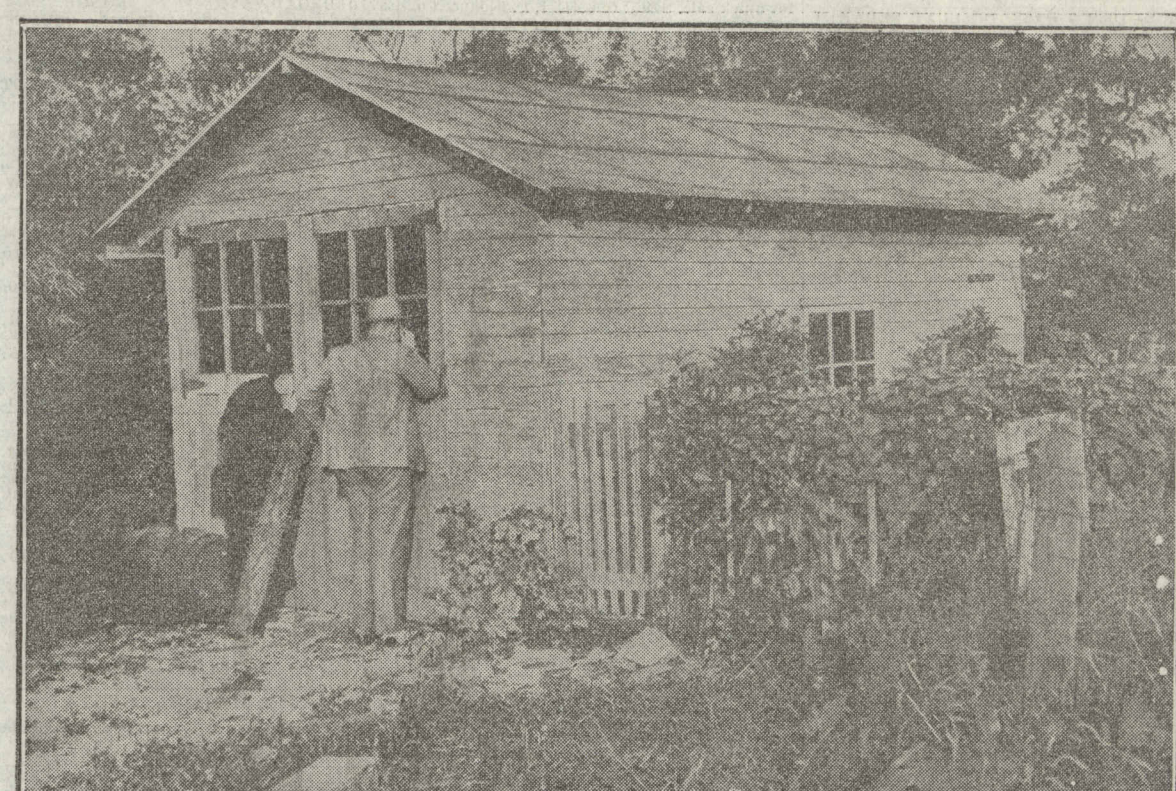

Mrs. Bruno Hauptmann after questioning by police in Lindbergh case.



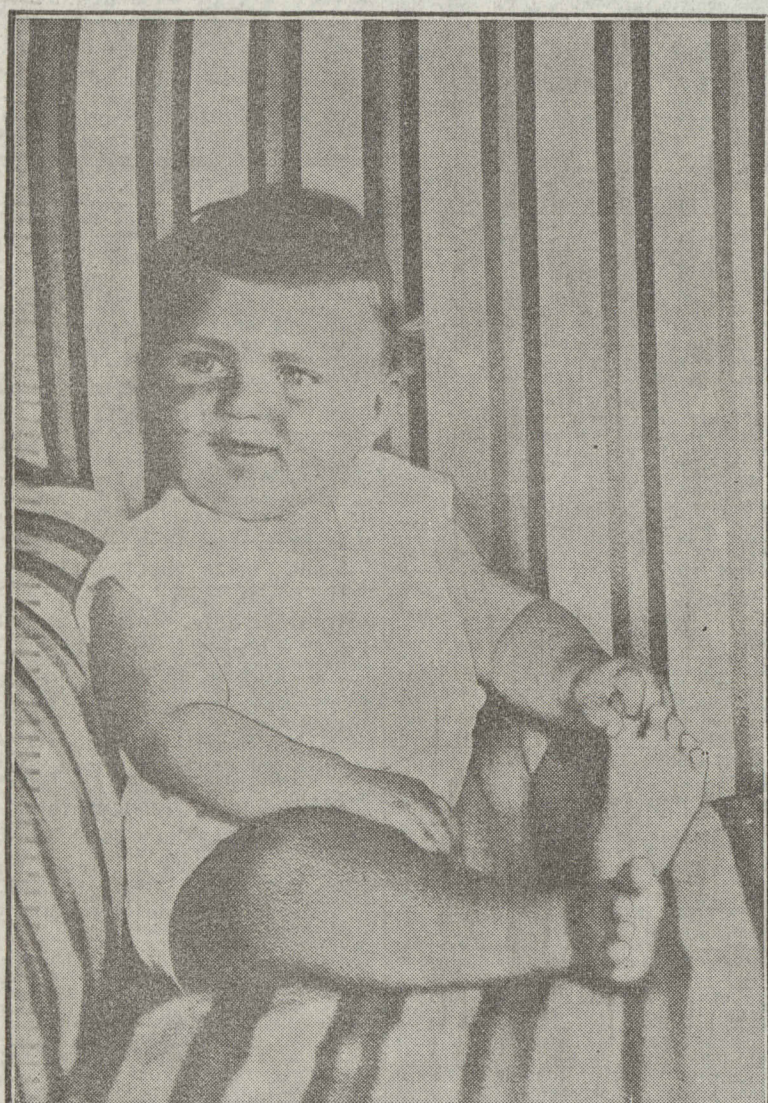

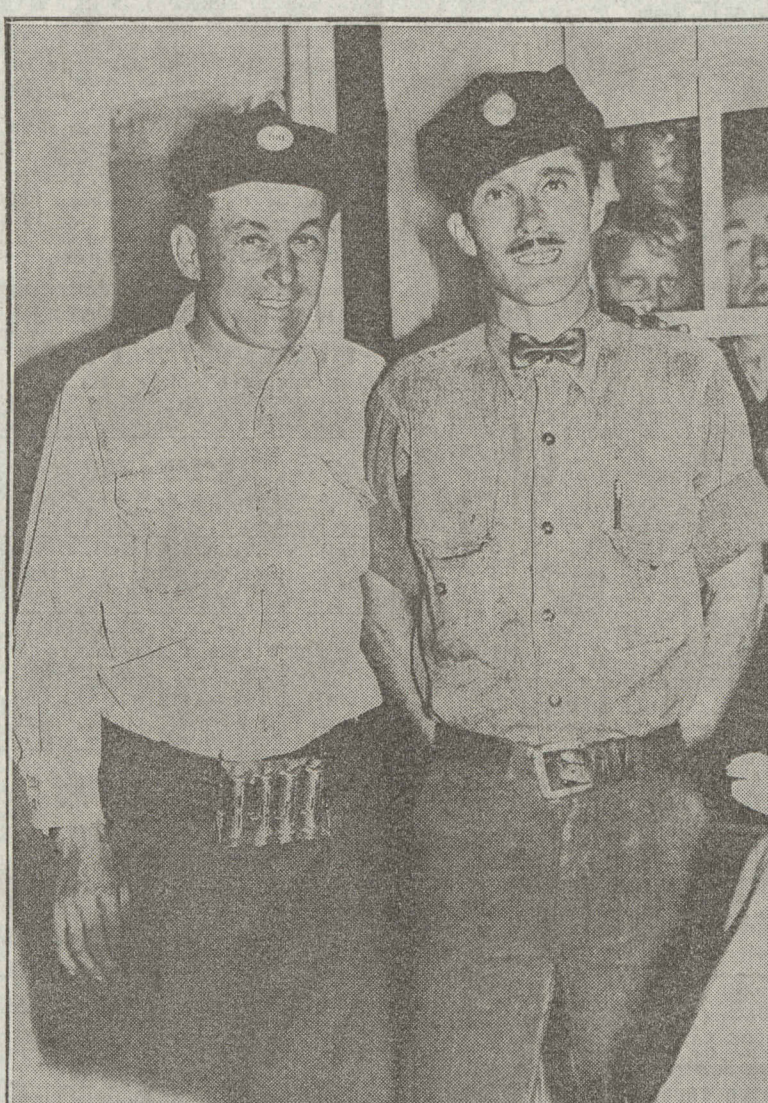
