JOIN THE MARCH OF DIMES

Farm Problem Will Face 84th Congress; Relief Seen

The major domestic problem facing the second session of the 84th Congress is the farm program.
Those on both sides of the congressional aisle agree that something must be done—but there the agreement seems to end.
Last year, most Democrats and several farm-belt Republicans contended that the current crop-price squeeze could be relieved only by a return to the 80 per cent support level on the six basic crops—wheat, corn, peanuts, tobacco, rice and cotton.
There is still considerable sentiment for this solution—included in the farm bill passed in 1955 by the House and now before the Senate Agriculture Committee.
The administration vigorously disagrees, and argues that such a step would only compound the crisis by piling up ever more surpluses now jamming warehouses over the country.
Agriculture Secretary Ezra Taft Benson has declared that, as long as he is the administration's chief farm policy strategist, flexible rather than rigid supports will prevail.
A compromise now being pushed by Sen. Milton Young (R-N.D.)

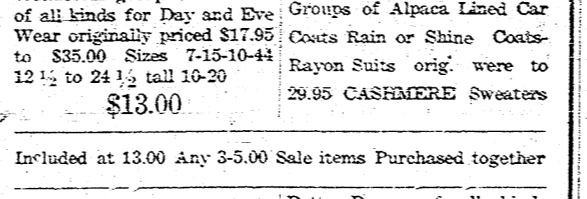

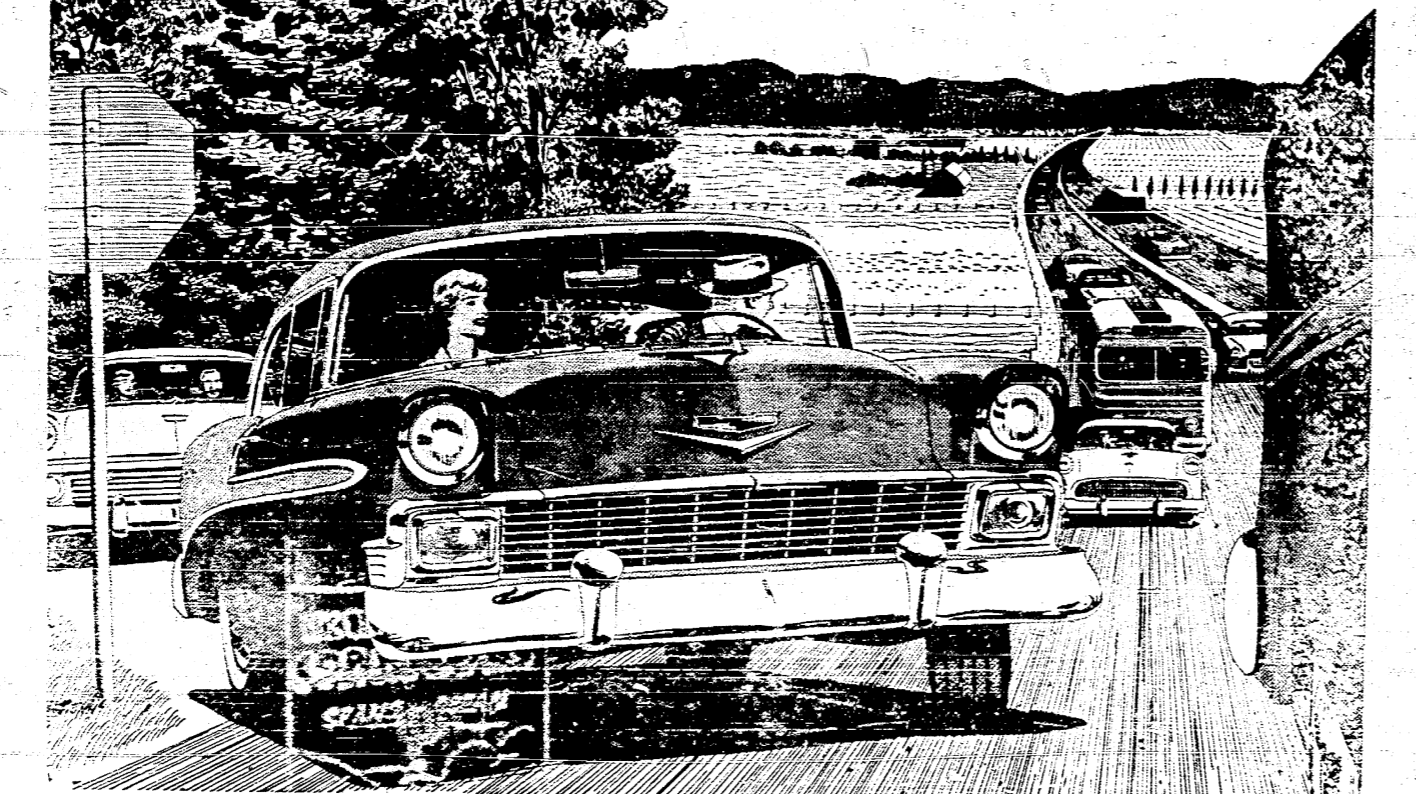

Farmers Get Income Tax Aid In Book

Farmers who may face problems growing out of the new social security program are being helped by a new book, "Federal Income Tax Returns as well as other information pertaining to income tax," available at the office of the Internal Revenue Service and from county farm agents.

The booklet was prepared by the national office of the tax collection agency with the aid of revenue agents in farm areas. The Federal extension of the Department of Agriculture, and the State extension services of the Federal land grant colleges.

In addition to descriptions in detail the steps to be taken by farmers in all categories in preparing their 1955 returns, the booklet deals with such subjects as farm inventory, depreciation, capital gains and losses, thefts, trade condemnations and dissolved livestock and water conservation, and other matters of farm interest.

The publication contains considerably more material than is included in the information booklet which will accompany 1955 farmers' tax forms, scheduled to go into the mails in December, early in January. Farmers who need special problems during 1955 will be able to plan much of the calculation required by their returns by using the new guide.

Revenue officials said, it will enable them to get a better estimate to do much of their computation in advance.

Farmers desiring the guide should contact or write to their county agricultural agent who has copies, but will not sell. The guide will not be available at the Internal Revenue office in your local area.

THE BOBCAT — NEW GAME ANIMAL

For the first time in Michigan the bobcat has been recognized as a true game animal, and has been offered seasonal protection to fit its status. On December 15th in the lower peninsula the 1955-56 season opened, and in certain northern localities hardy groups of hunters with trained hounds took to the snow-filled swamps in the pursuit.

Bobcat hunting is well on its way to becoming an important attraction to winter sports enthusiasts, with certain reservations. The mammals are far from plentiful in much of the north country, and protection was provided in the nick of time. However, sufficient breeding stock to provide good hunting for years to come, it is likely that the species will soon firmly reestablish itself in areas where ruthless hunting and trapping for bounty had all but eliminated it completely.

The Nature of the Beast

The Michigan bobcat is a king-sized version of a tawny housecat, weighing up to 40 pounds in weight and exhibiting a few nasty characteristics inherited from his feline cousin, the lynx. He feeds on mice, ground squirrels, fogs, crickets, and now and then, if he's lucky, on small birds or a partridge or two. The latter, for obvious reasons, are rarely included on his menu. The big cat will live out his life as a couple of square miles of swamp unless pursued, and then he'll prove he's a cool traveler, treading in a huge circle, the bobcat will generally wind up back in the country he knows best, confounding the hounds and hunters with phantoms and circling over the same track, leaping from tree to tree repeatedly.

Frightening Countenance

Once compared or tried the bobcat presents a defiance hard to match in any Michigan animal. He's growing, spitting fury is enough to scare the bravest of hounds. And to the hunter the rage of the animal seems to inflate his size until the cat approximates a tiger ready to spring. Such is the sport of bobcat hunting in Michigan that some groups call it a day once the quarry is treed, and refuse to kill the victim unless it is of "trophy" size. Truly, the sport is in the chase! And with a fresh fall tracking now beckoning you can count on October this winter—with Wade many a fine hunt in Michigan (Miller's) pack of hounds near Houghton Lake, or perhaps, through the swamps surrounding the lakes near Mio and Fairview, or with Stan Godfrey leading the way in the great cedar swamps west of Alpena. Try it for a new winter sports thrill this year!

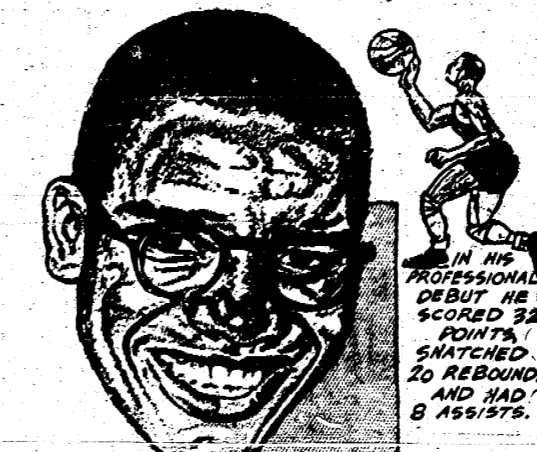

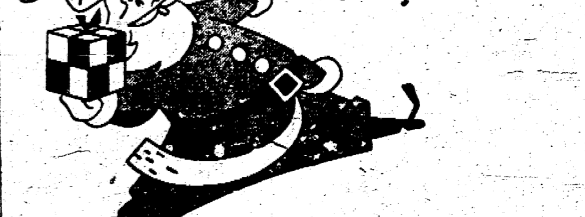
