FOR SHERIFF

John LeRoy Tice, a former top command officer with the Sheriff's Department, today announced his candidacy for the Republican nomination for sheriff in the Aug. 2 primary election.

Tice, 56, of 1614 Ferndale Pl., is the first avowed candidate from either major party to seek the post now held by Sheriff George A. Petersen.

In his announcement Tice outlined three goals for which he would strive if nominated and elected sheriff. They include:

- 1) Impartial enforcement of the law regardless of personalities or groups involved.
2) Schools and training programs for all deputies on a continuing basis.
3) The eventual installation of civil service status for all Sheriff's Department employees.

In referring to his first point Tice said: "It has always been my belief that if a person commits a crime he should be arrested and brought before a court of justice. The judge or magistrate then must determine the punishment, the officer already having done his duty. Because a violator is a 'friend' or 'has influence' does not determine his guilt or innocence. His guilt is only up to the courts to decide."

STORE CHAIN MOVES AGAINST SHOPLIFTERS

A chain of five grocery stores which is losing thousands of dollars a year by thefts of shoplifters has started a penetrating security program in Washtenaw county.

The stores, which are all named "The Country Market," operate in Saline, Manchester, Milan, Clinton and Tecumseh.

Ray Gretzner, manager of the Saline store, today estimated between \$10,000 and \$12,000 is lost each year to store thefts in the five stores.

"It got to such a ridiculous point that the word was being passed among all the sneak thieves that any one of our stores was an easy mark," Gretzner said.

After a meeting of store managers recently it was decided to start a crack-down program on shoplifters in an effort to stop the thefts. The program includes floorwalkers, special police officers and a tighter check on suspicious appearing persons seen wandering around the stores.

DAY CARE CENTER SLATED

The first Day Care Service Center for cerebral palsied children in this area is now being planned by officers of the United Cerebral Palsy Association of Washtenaw County.

Dr. D. C. Morley, senior clinician at the University Speech Clinic and president of the local association, said final plans for the new center were laid at a meeting this week. He said preliminary discussions about such a center for Washtenaw County began more than a year ago.

The Care Service is to be aimed at help for those children in the County who are severely afflicted with cerebral palsy. Such children will include those who can neither walk nor talk and whose severe handicap makes it impossible to fit them into regular schools or other programs.

Initially the group to be cared for by the Center will be small and will meet three mornings a week from 9 a.m. to noon. Dr. Morley said a location for the Care Service has not been set although several possible sites are under consideration. He said as soon as the place for the Center is set it will go into operation under the direction of Mrs. Chester Carter of 323 John Street and Mrs. Wilber Bigelow of 1136 Mintwood Avenue, both in Ann Arbor.

The doctor had said help is needed in staffing the Center. Persons who have had experience in working with handicapped children and who are interested in part-time employment should contact Mrs. Carter at Normal 8-6692 or Mrs. Bigelow at Normal 2-5237. The two women may also be contacted for information on the Center.

CIVIL DEFENSE EXERCISE:

Clayton Parr of Manchester, chairman of the Board of Supervisors of Washtenaw County has asked all city Mayors, village presidents and their councils to officially participate in the nationwide Civil Defense exercise to be held May 3 to 5.

"In view of the world-wide situation and the emphasis being placed on Civil Defense at all levels of government today," Parr said, "it is imperative that all our communities extend mutual efforts in providing for the general health safety and welfare of our citizens."

Disasters, both of natural causes and possibly from an enemy attack on our nation, will not necessarily recognize political subdivision boundaries.

"I further feel that what plans we lay at this time will have a direct bearing on our ability to meet and cope with a major disaster of any kind that could strike our citizens. This will be the first such operation in which all local governments have been asked to participate, and it is intended to test their present plans for Civil Defense emergencies."

APPLICATIONS FOR WOOL INCENTIVE PAYMENTS MUST BE FILED BY MAY 2:

With the 1959 wool marketing year coming to a close and the 1960 year beginning, growers were reminded today of the importance of complete records on their sales of wool and unshorn lambs. Producers will be eligible for payments for the 1959 marketing year for wool and unshorn lambs marketed not later than March 31 of this year. Later marketings will be eligible for payments for the 1960 year.

Max M. Kalmbach, chairman, Washtenaw County Agricultural Stabilization and Conservation Committee, reminds wool growers that the sales documents must show the true net sales proceeds, including deductions made for freight and other marketing charges. Where false information is filed, both the producer and the wool buyer are subject to penalties.

Applications for payment under the 1959 program must be filed at the county ASC office not later than May 2. The average price received by farmers for wool during the entire marketing year can then be calculated and the payment rate announced. Payments to growers will be made some time during the summer.

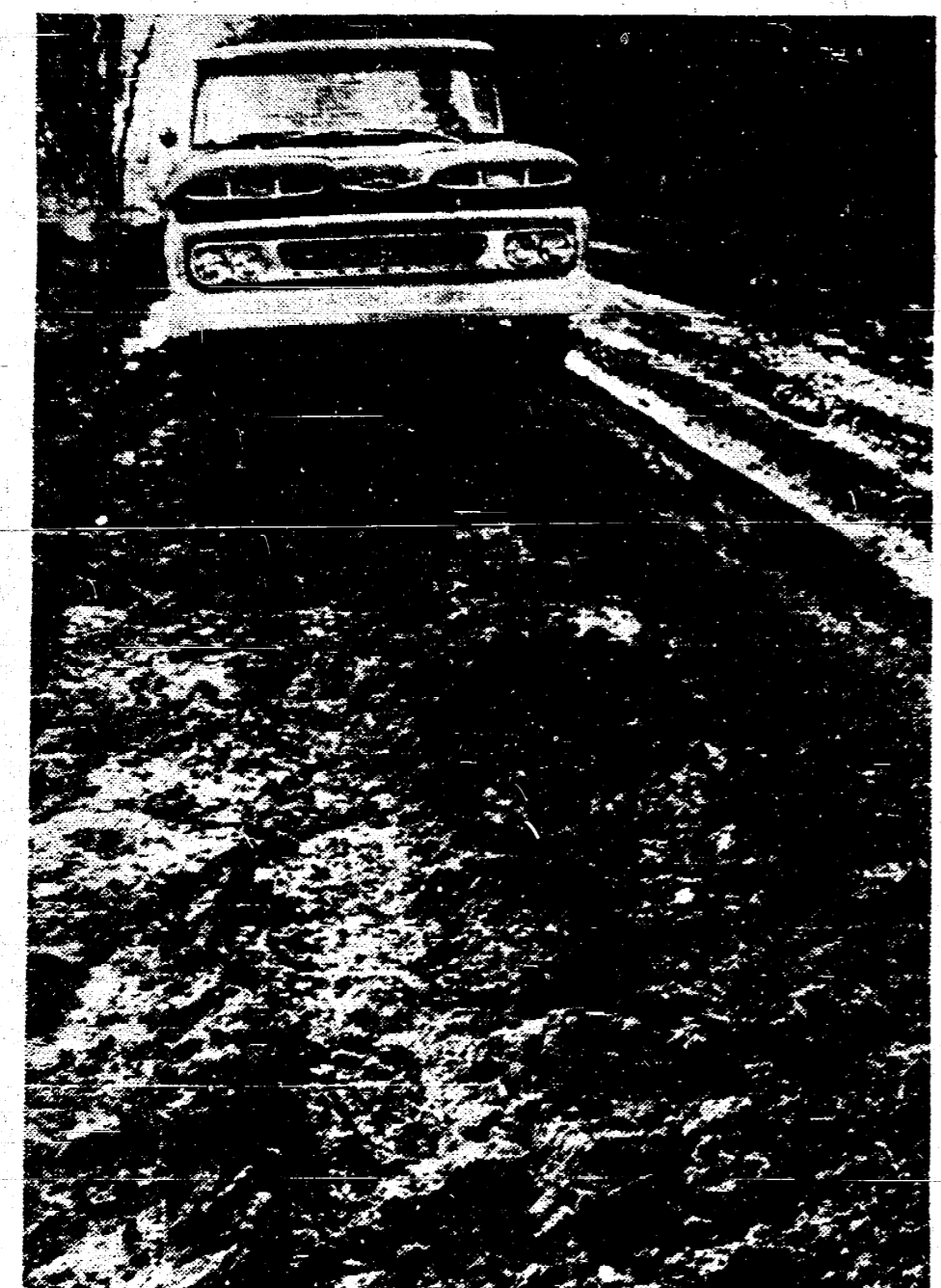

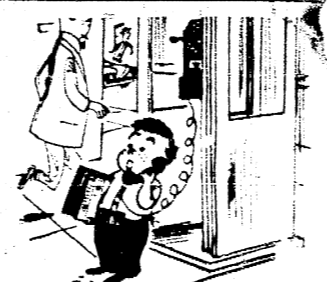

HIGHWAY PROJECTS SCHEDULED

There are about 60 projects scheduled for the new five-year primary road construction program announced by the County Road Commission.

Included in the list are the following townships together with their cost and tentative completion dates:

Manchester Township - Sharon Hollow Road, 3.75 miles from Herman Road to US-112 sub-base, base, prime and double seal, \$85,000 by 1965.

Bridgewater Township - Par-Road, .25 of a mile, from Freedom Township lines to Austin Road, sub-base, base prime and double seal, \$8,300 by 1963; Kaiser and Burmeister Roads, 2.60 miles from Austin to McCollum Rds. sub-base, base, prime and double seal, \$60,000, 1964.

McCollum Road, 3.01 miles from Burmeister Road to US-112, sub-base, base, prime and double seal, \$75,000, 1965. Freedom Township - Parker Road, 1.53 miles, from Scio-Church Road to Pleasant Lake Road, complete base, prime and double seal, \$35,000 by 1961; Scio-Church, one mile from Parker Road to Lima Township line, sub-base, base, prime and double seal, \$21,000, 1963; Parker Road 1.75 miles from Pleasant Lake Road to Bridgewater Township line, sub-base, base, prime and double seal, \$58,500, by 1963; Fletcher Road, 3.18 miles from Pleasant Lake Road to Lima Township line, gravel surface sub-base, base construction, \$70,000, by 1965.

Sharon Township - Grass Lake Road, 2.86 miles from M-92 to Sharon Hollow Road, sub-base, base, prime and double seal, \$65,000, by 1963.

Mr. Minier said this will include 90 miles of paved roads added to the present road system in the county. The commission just completed an eight-year program. The aim of the program will be to pave all of the county's primary roads and maintain local roads. The county will have 350 miles of paved primary road when the system is completed. This compares with 269 miles now and 111 miles of paved roads in 1952 when the first county road improvement plan began.

Raymond Koch, chairman of the county road commission said the five-year plan, however, will meet only one-third of the Washtenaw county's over-all highway deficiencies.

COUNTY ROAD PLAN

A \$2,350,000 five-year county road construction program for Washtenaw county's primary roads has been announced by Howard G. Minier, road superintendent.

Mr. Minier said this will include 90 miles of paved roads added to the present road system in the county. The commission just completed an eight-year program.

The aim of the program will be to pave all of the county's primary roads and maintain local roads. The county will have 350 miles of paved primary road when the system is completed. This compares with 269 miles now and 111 miles of paved roads in 1952 when the first county road improvement plan began.

Raymond Koch, chairman of the county road commission said the five-year plan, however, will meet only one-third of the Washtenaw county's over-all highway deficiencies.
