MILLAGE FOR ROADS REQUESTED

Washtenaw county tax allocation board was asked at a hearing to grant two-tenths of a mill of the 15-mill property tax for repair and maintenance of streets and roads which suffered damije from the winter breakup this spring.

Supervisor E. A. Wolterm chairman of the board of supervisors put in the request for the millage for the roads. The board has been asked by the county road commission for the emergency appropriation.

The county was given a pre-liminary allocation of 4.25 mills on a tax base of \$650,802,500 recommended by the state tax commission. Any increase in the county's share will automatically decrease the Ann Arbor public schools' share of the 15 mills by a corresponding amount.





"Drag racers" in Washtenaw county got a warning today. It was from the sheriff.



allocation of 8.75 mills from Jackson County was a little more than expected. On the other side of the ledger he reported that state aid would be \$13,000 less than would have been received if property valuation had remained the same as last year.

After due consideration it was decided that next year's budget, as presented to area citizens, could be balanced with a two mill request. This reduces the total operating millage from 12 mills to 10.75 mills for the next year. The 10.75 mills is the same amount available to many Washtenaw County schools without extra millage. The millage for debt retirement in the district will be reduced to 5.25 mills as compared to 6.75 mills last year. the people of the Manchester district will be requested to pay a total 16 mill tax for local schools if the issue carries, in place of the 18.75
