SCHOOL BUDGET PLANNED

At a special meeting of the Manchester Board of Education, next year's school budget was discussed in relationship with the new district valuation and allocation. The board has a standing agreement with the community to request only the millage necessary each year to balance the next year's school budget. This budget is formed early in the year with citizen participation.

Earlier in the year it seemed to be necessary to request three mills to replace last year's three and one-half mills if the school program was not to be further curtailed.

Superintendent Robert Masten informed the board that the new district valuation was over a million dollars larger than expected and that the allocation of 8.75 mills from Jackson County was a little more than expected. On the other side of the ledger he reported that state aid would be \$13,000 less than would have been received if property valuation had remained the same as last year.

After due consideration it was decided that next year's budget, as presented to area citizens, could be balanced with a two mill request. This reduces the total operating millage from 12 mills to 10.75 mills for the next year. The 10.75 mills is the same amount available to many Washtenaw County schools without extra millage. The millage for debt retirement is set at 5.25 mills as compared to 6.75 mills last year. The people of the Manchester district will be requested to pay a total 16 mill tax for local schools if the issue carries, in place of the 18.75 levied by the board last year.

OPEN HOUSE PLANNED FOR SOCIAL SERVICE

Catholic Social Service of Washtenaw County, 200 N. Division Street, Ann Arbor, will have open houses each afternoon, June 5-11, in observance of Catholic Social Service Week.

Members of the board of directors, members of the Good Samaritans, a volunteer group, and staff members will act as hosts for the open houses.

Different professional groups, with whom the agency has had a close working relationship during the past year, will be entertained at each of the five afternoons. All open houses will be from 3:30 to 5 p.m. Schedules for professional groups are: Tuesday, June 7th, lawyers; Wednesday, June 8th, doctors; Thursday, June 9th, teachers and principals; Friday, June 10th, public officials.

The agency opened its doors in May 1st, 1959 and is dedicated to the promotion of better family living. Each month since the agency opened its doors, people from all walks of life have asked for help in behavior problems of children, marital difficulties, unemployment, financial assistance, unmarried motherhood, planning for the aged, adoption requests, arranging for foster home care, and marital or emotional problems arising out of marital discord.

No one is refused home, religion, color or station. The service is geared to enable families to work out their own destinies. Since May of last year, the agency has helped 587 families with problems from all areas of Washtenaw County.

The goal of the volunteer group is threefold--inocent assistance, help with certain phases of the work which can be done by laymen and the development of a sound public relation program. The contribution of Catholic Social Services of Washtenaw County to the people of this area is in many respects the result of this dedicated group. The agency is supported by the Archdiocesan Development Fund and individual contributions.

General chairmen of the affair are Mrs. Erwin Frederick and Mrs. Simon Girbach. Mrs. Robert Mast and Mrs. Jack Bradbury, both of Dexter, will direct the broiling of 4,000 chicken servings. Mrs. Walter Wolfgang is chairman of purchasing.

The barbecue is sponsored by the Washtenaw Farm Council, the governing body of the Activities Center located on Saline Ann Arbor Road. Farm organizations throughout the county cooperate with the council in organizing the main committees.

SHERIFF CANDIDATE SAYS HE'LL APPOINT EXPERIENCED MEN

"The men I will appoint to key command positions have been battle-tested through decades of solid police experience. They will not be campaign managers or political 'yes' men."

John LeRoy Tice yesterday used these words in filing his nominating petitions for sheriff in the August primary election. Tice, a former under-sheriff and detective sergeant with the Sheriff's Department, is one of three persons seeking the Republican nomination for sheriff.

Tice, who is now co-ordinator for welfare services for the county, was the first person to enter the race for the primary nomination from either party. He announced his candidacy March 17. Later Elmer F. Klump, a former deputy sheriff, and the incumbent, Sheriff George A. Petersen, announced they would also seek the GOP nomination. Klump, Sheriff Petersen and Lawrence Ostersdorf of Superior township who is seeking the Democratic sheriff's nomination are all circulating nominating petitions but have yet to file. The deadline for filing is June 14.

Tice, who filed more than the required number of signatures, called his filing "the real beginning of a campaign to form a rock-solid county law enforcement organization which is better than any in the state."


Chee-Scalloped Cauliflower



A year-round vegetable favorite makes a fresh springtime appearance in a new version.
