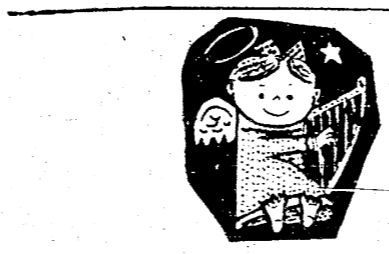

1960 TAX REVIEW FROM 6 TOWNSHIPS
The tax picture in Washtenaw County has changed by varying amounts throughout the county. This was brought about by re-evaluation of property by the State Tax Commission. This process raised the valuation of the school district approximately four million dollars here.
This means two things to the Manchester board of education. 1-The state aid would be thirteen thousand less than last year because of the increased valuation. 2-The millage requested on the equalized valuation would have to be reduced 2.75 mills when the new valuation was applied to the tax levies.
The following shows the school taxes levied by the Manchester school district in 1959 as compared to 1960 in each township. This does not take into account the 1/2 mill levied by the county.

KLAGER ELECTED BY NEW COUNCIL
Luther Klager, Manchester hatchery and president of Michigan Allied Poultry Industries, has been named first vice-chairman of a new, 48-member Michigan Livestock Health Council.
The Council was organized by a meeting of State veterinary and medical representatives called at Michigan State University to discuss the possibility of setting up such a group.
Finding themselves in agreement and having discovered a working rapport within their meeting, the representatives decided to set up the Council itself without further delay.
It will study livestock diseases, make recommendations on regulatory education and research programs, plan and implement statewide health programs and review general progress in this field.
Among the organizations represented were the Michigan Veterinary Medicine Association, the Michigan State Medical Association, the State TB Association, the Michigan Health Council, the Michigan Dietetic Association and the Michigan Home Economics and Business Association.
Other officers are Elton R. Smith, Caledonia Guernsey breeder, elected chairman; and E.A. Wenner, manager of the Michigan Artificial Breeders' Co-operative chosen secretary.

FOSTER CHILDREN RECEIVE CHRISTMAS GIFTS
All of the 140 Washtenaw County children who are in foster and boarding homes by placement of probate court, were given presents this year.
Some received gifts in the names of their parents. Others were given theirs in the name of their foster and boarding parents. Still others were given presents by the juvenile court worker assigned to supervision of their welfare.
The presents, however, were paid for by the Ann Arbor Salvation Army and Washtenaw County American Legions. The gifts were purchased by and delivered to the Women's Auxiliary of the Washtenaw County Bat Association.
Many parents of the children have had little or no contact with them, and had it not been for the groups involved, the youngsters would have had a very unhappy Christmas.

FARM ACCOUNT BOOKS AT UNION SAVINGS BANK
Michigan State University farm account books are now available at the Union Savings Bank. Good farm accounts are one of the most important tools to success of the farm business.
Records are important in filing income tax and social security returns, but more important is the use of them to improve the farm business. Through study of records weakness can be determined and the business strengthened.
Approximately 40,000 of these account books are distributed in Michigan each year. The books are available in Washtenaw County through the courtesy of the Bankers Association. This Association distributes approximately 1,400 books in Washtenaw county each year.

WASHTENAW ISSUES 1125 LICENSES DURING NOVEMBER
A total of 1,125 drivers' licenses were issued by the Sheriff's license division according to a report from Sheriff George Petersen. The number included 43 duplicates, 172 chauffeur renewals, 163 originals and one minor renewal. Collected fees amounted to \$785.50.
The Dog Control Division report showed a total of 94 dogs picked up and 132 complaints handled.
Accidents investigated, numbered 88 of which one involved a fatality and 41 personal injuries.
There were 179 traffic violations. Complaints handled numbered 565; there were 102 arrests; 506 civil papers were served; and 60 warrants were closed during the month.
The report also says that Sheriff's Department Cars were driven a total of 43,665 miles during November and during the same period 5,310 meals were served to the inmates at the county jail.

NOVEMBER-The Fellows Bridge was dedicated by the oldest resident of the area. The bridge was rebuilt and is now back into operation.

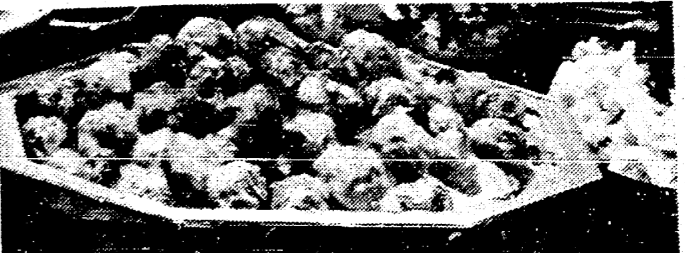
The new telephone directories were distributed in December, this is quite the directory, as we have never had anything like it before.

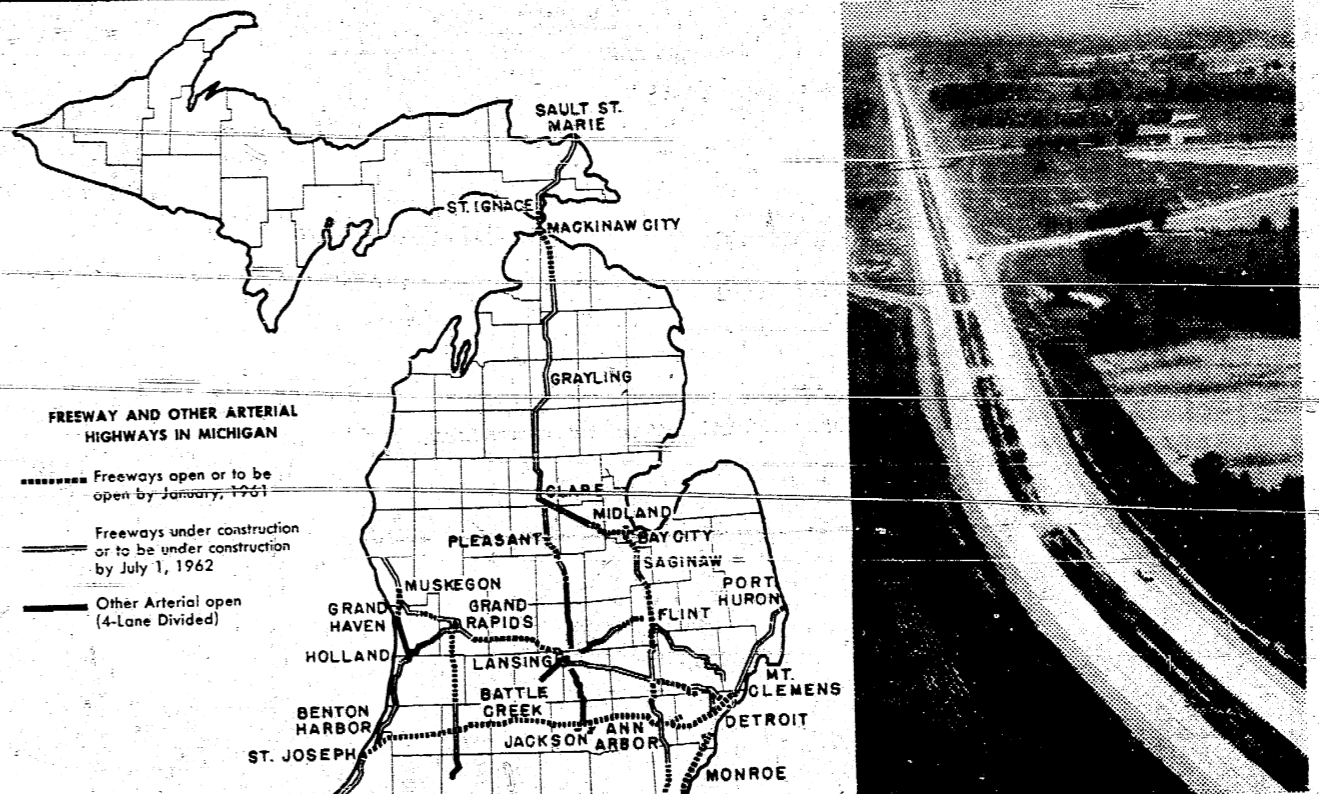
NEW YEARS EVE SMORGASBORD



This New Year's Eve, serve a buffet supper with an international flavor—Swedish Smorgasbord. The recipe below for Swedish Meat Balls is from the Smorgasbord spread in the January Ladies' Home Journal:

| 1/2 lb. ground beef | 2 t. paprika |
| 1/2 lb. ground pork | 1 t. poultry seasoning |
| 1/2 lb. ground veal | 1 t. dry mustard |
| 2 c. soft whole-wheat bread cubes | 1/4 t. pepper |
| 1/2 c. milk | 3 eggs, beaten |
| 1 onion, peeled and finely chopped | 1 t. flour |
| 10 t. butter | 1 can (10 1/2 oz.) condensed beef bouillon |
| 2 1/2 t. salt | 1 c. commercial sour cream |

Have your butcher grind beef, pork and veal together twice. Soak bread cubes in milk. Squeeze dry and add to beef, pork and veal. Add onion which has been sauteed in 2 T. butter, salt, paprika, poultry seasoning, mustard, pepper and eggs. Mix well. Form into about 100 small balls. Brown meat balls in a skillet, a portion at a time, using 1/2 c. butter. As they are browned, transfer them to a bowl. When all meat balls are browned, stir the flour into the pan drippings. Blend in tomato paste and the bouillon mixed with enough water to make 2 1/2 c. Stir over low heat until sauce is thickened. Put the meat balls back and heat for a few minutes. Just before serving stir in the sour cream, blending well. Makes 12 servings.

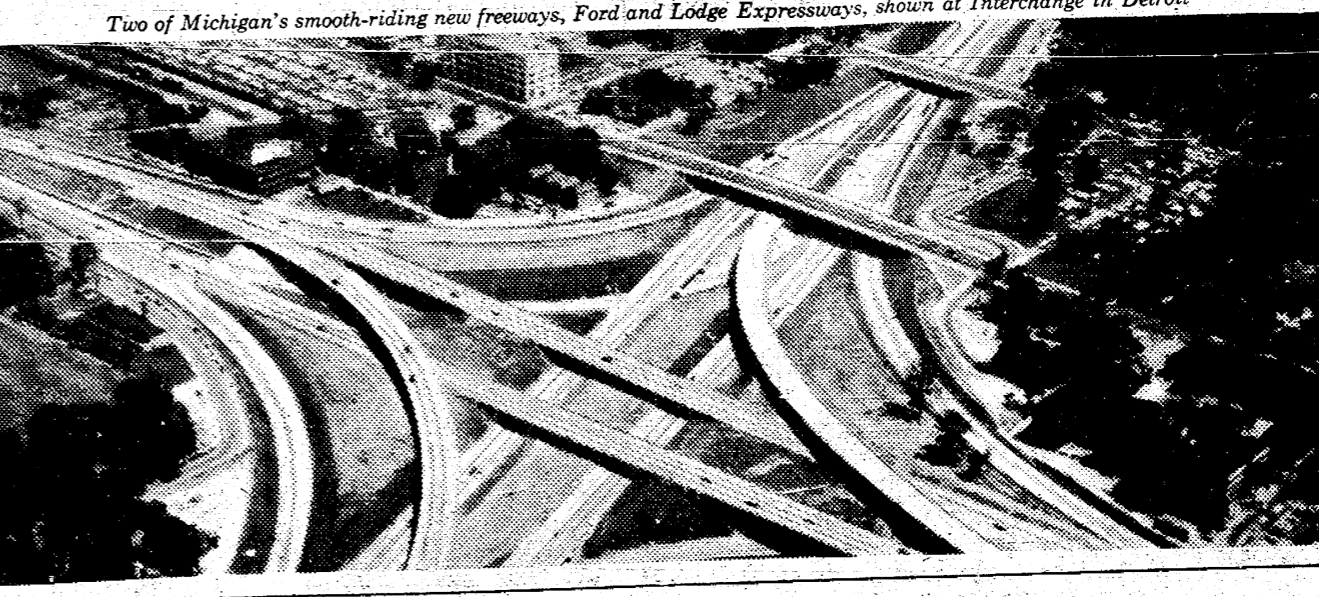

FEED BABY PIGS FOR TOP GAINS. It takes very little feed to produce a pound of gain early in the pig's life. Every extra ten pounds a pig puts on during the first two months will cut 12 days off the feeding time in the feedlot. Start feeding a pre-starter as soon as pigs are a week to ten days old. This should be provided in special baby pig feeders right in the farrowing crate. If sows and litters are in regular pens, set up a pig creep for self-feeding commercial pre-starter.

PREVENT EXCESSIVE TRACTOR ENGINE WEAR IN WINTER. During warm-up, when the tractor is being choked, gas tends to wash oil from the cylinder walls. If you put a full load on the engine during this time, you will get unnecessary engine wear. Your engine will warm up faster if you cover the radiator while the engine is still cold. Change oil more frequently in winter — it sludges up faster.

INSURE AGAINST VITAMIN A DEFICIENCY in your beef fattening ration. Although corn and roughage normally contain sufficient amounts of vitamin A to meet cattle requirements, deficiencies have been showing up. Rate of gain and feed efficiency drop drastically. Common symptoms are an unthrifty appearance, lame-ness, night blindness, watery and inflamed eyes and convulsive seizures. Include a vitamin A supplement in the ration if many animals show symptoms.

STICK WITH THE ALFALFA VARIETIES BEST ADAPTED TO YOUR AREA. Don't plant on older seed varieties this winter, when the intention of seeding is a blend next spring. Research indicates that single adapted varieties do better than blends.

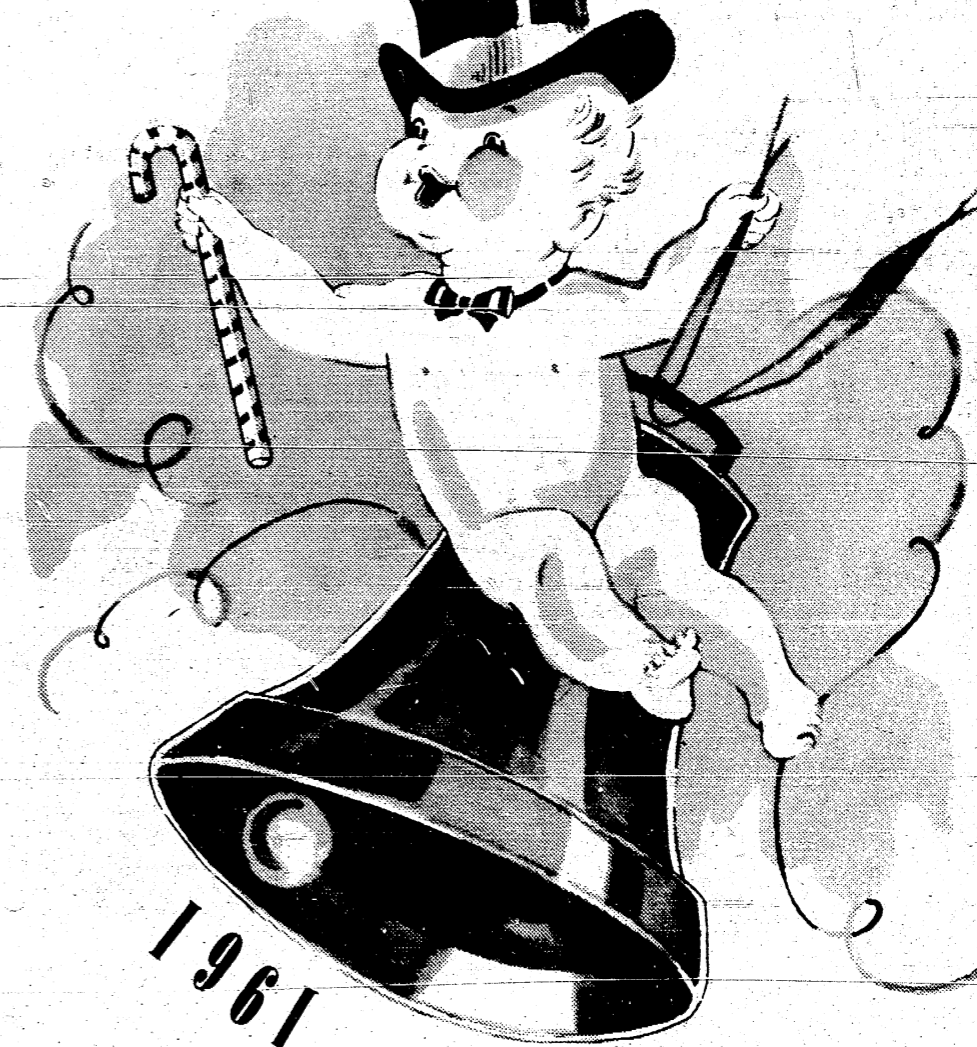
