OSCAR BAHNMILLER RETIRES FROM ROAD COMMISSION



Oscar Bahnmiller, who resides at 103 Duncan Street here, has retired from active service with the Washtenaw County Road Commission.

Mr. Bahnmiller was employed on May 19, 1930 and retired January 1, 1961. He had worked at the Manchester yard for the past thirty years and was the manager when he retired.

Mr. Bahnmiller explained that his actual work with the commission was finished December 1 but he had piled time during the past months to accumulate about a month of time which he had coming to him.

For 26 years, he operated a scraper truck until the death of Wilburt Buss in 1957. At that time he replaced Mr. Buss as foreman of the Manchester yard. He is 68 years old and during the time he worked for the road commission he had no accidents of any kind.

He was given a party at the home of George Goodell by the fellow workers of the Manchester yard and their wives. He was presented with a camera. We learn that later this month he will be feted by the Washtenaw Road Commission at a party in his honor.

There have been many changes in the work of the road crews during the past thirty years. For the first two years he worked out of the Ann Arbor yard and then moved to Manchester. There were no salters or sanders

in the old days he remembers. Until about 5 years ago county road men worked every other Saturday. Many times the crews worked all night clearing the roads.

Mr. Bahnmiller recalls that in the early years with the road commission when the boys were out all night clearing roads it was not uncommon to have farmers

invite them to get warm and give them a cup of coffee. Then of course they could always stop at the farm houses for a drink of water from the outside pump. This has all changed.

He says we "just don't have the storms we used to, so of course the roads are cleaned much quicker, they would be anyway with the new equipment." In the old days the side roads were not cleaned with the speed they are today.

"The road commission is a good employer," he says. "Maybe we don't get the highest wages but the work is steady year around. I've enjoyed my work every bit of it. It is a good set up. They have a fine pension plan for the workers and in all the years I worked there I have never missed a pay day."

He and his wife Mattie were farmers before he took the job with the road commission. They have three children, Gerald of Ann Arbor, Mrs. Grant (Elaine) Van Deusen of Ann Arbor and Mrs. Cady Hall of Laguna Beach, California.

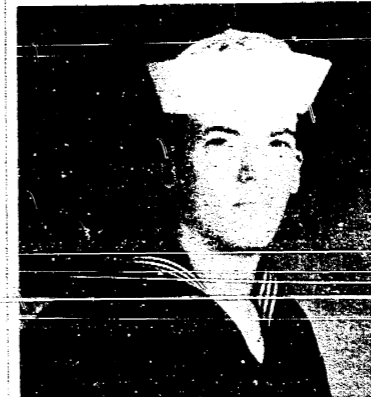
The dinner is scheduled at 6:30 p.m. J.P. Soumala is chairman of the event.

ANTI-RABIES DOG CLINICS SCHEDULED
Rabies vaccination clinics for dogs in Washtenaw County will begin next Thursday, the County Health Department has announced and will be held in 13 locations through Saturday, January 28.
A clinic will be held in Ann Arbor from 3 to 7 p.m. Tuesday, January 10, in the National Guard Armory.
A new vaccine which protects dogs for two years and which will cost \$2.00 will be administered at the clinics this year.
The clinics, according to Dr. Otto K. Engelke, county Health Department director, offer low cost vaccination to dog owners who might find it difficult to comply with the regulation requiring vaccination.
It was pointed out that the clinics are not the only means of securing rabies vaccinations. Veterinarians offer the vaccinations year around at their offices for a regular fee.
Sponsored by the County Veterinary Medical Association and the Health Department to keep rabies out of Washtenaw county, this year's clinics will be under the direction of Dr. George Bowler, veterinarian and meat inspector with the Health Department.
Practicing veterinarians in each community serve at the clinics without fee.
The clinics have been held since 1948, when a county ordinance was passed requiring all dogs to be vaccinated before licenses could be bought for them.
Dr. Bowler said a representative of the various township clerks offices will be present at the clinics to issue licenses to all dog owners who wish to purchase one. The deadline for obtaining the licenses without a penalty is March 1.
Dr. Engelke said the \$2 fee will approximately cover the costs of the clinics but that the department would not know for sure until a few have been held.
The schedule for the townships are as follows: Superior township, 4-6 p.m. Jan. 5, Superior twp. hall Saline 7-9 p.m. Jan. 5 at the fire station; Ann Arbor, 3-7 p.m. Jan. 10, at the Armory; Ypsilanti, 4-7 p.m. Jan. 11 Ypsi twp. hall, Willow Village, 6-8 p.m. Jan. 13; fire station.
Other clinics will be held in Salem, 2-4 p.m. Saturday Jan. 14, at the fire station; Milan 7-9 Jan. 17, equipment building; Lyndon township hall Dexter, 2-5 Jan. 21; fire station; Augusta township 7-9 Jan. 24 Lincoln school garage; Manchester 7-9 Jan. 25, County Road Commission garage; Chelsea, 7-9 Jan. 26, town hall; and Whitmore Lake 7-9 Sat. Jan 28, fire station.
