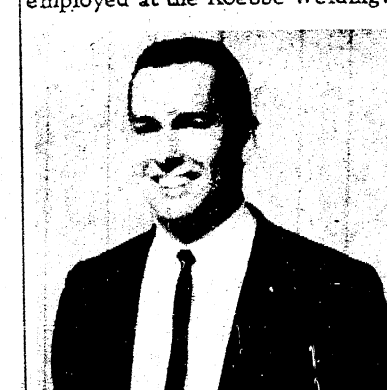

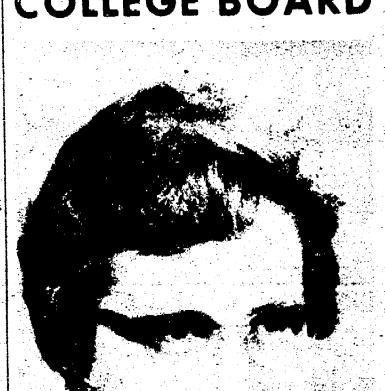

Holiday Greenery Brightens Home

Home decorations are not complete without holiday greenery about the house. The best choices include spruce, pine, hemlock, yew and aborvitae. Of these, yew seems to hold up best. If you use broadleaf evergreens—laurel, andromeda, boxwood, or Japanese holly—for table decorations, keep them in water or the leaves will shrivel and die within a short time. Even though short lasting, broadleaf evergreens are ideal for making wreaths. For this purpose, they may be mixed with holly, balsam or yew.

"Auriga, the large five-sided figure, ruled by the bright yellow star, Capella, rises soon after sunset.

"The winter constellations center mostly around Orion. With his Hunting Dogs, this giant with the red star strides across the southern sky."

Miss Losh continues by saying that Sirius is easily identified by extending a line downward through the Belt of Stars of Orion. From time immemorial, Sirius has been watched, admired and revered, rising as 'the Star of the East', pointed to by 'Three Wise Men of the East'.

"Fittingly, the Northern Cross is steadily moving toward the west, and may be seen to splendid advantage on Christmas Eve. After dark, it will stand upright against the western sky, a beautiful symbol of the season," Dr. Losh said.

So if you are wondering about the Star of the East, you will know how to identify it.

OUR NEW NURSES; SALARY RAISE AT COUNTY HOSPITAL

Washtenaw County hospital at an Arbor has added four practical nurses to the staff and a number of hospital and social welfare department staff members received salary upgrading in action by the Board Supervisors.

Alfred E. Brose, director of the department of social welfare and county social welfare board, thanked the staff increase.

A six-bed section of the County hospital will be reopened because of the staff increase. This he pointed out will be very good because the hospital, a convalescent and rehabilitative facility, has almost a constant list for its 78 beds in use.

Brose said that because of lack of facilities, patients who could be cared for at the county hospital, ten times had to remain in general hospitals at a higher, often a higher per day patient cost when they could be transferred to the county facility for convalescence if beds were available. Cost to the county for 66 patient days in general hospitals was \$2,745 during the month, according to Brose.

Cost of operating the hospital in 1963 was \$314,000, with 16 percent or \$50,000 coming from county taxes. In 1963 it cost \$13.45 per day and is averaging less in 1964, Brose said. General hospital costs average between \$40 and \$55 per patient day.

Additional practical nurses (4) resulted in a transfer of \$13,062 from the reserve appropriation for their salaries. The upgrading of the staff will amount to an additional \$7,000, next year.

Supervisor Robert Marsh, chairman of the ways and means committee said that the committee had decided to maintain one grade differential between the case-workers in welfare and the juvenile division, and the nurses at the county hospital and in the health department. He said that the juvenile division and the health department have additional educational requirements which must be met by their staffs.

Some \$6,700 has been earmarked for hospital equipment and \$100 for psychiatric consultation, and an additional \$78 to the secretary's salary. These sums will be transferred from the reserve appropriation in the 1965 budget. There is \$229,000 in the direct relief appropriation because of a reduction in caseload.

SCHOOL BOARD NAMES ARCHITECTS

Manchester Board of Education at its regular session Monday named the architectural firm of Louis C. Kingscott and Associates, Inc. to serve as consultants to the Citizen's Committee on a proposed building program. The firm, one of the largest organizations of its kind in the state, has gained national prominence in the fields of architecture and engineering.

Prior to making the choice of architects, members of the Manchester Board of Education viewed a number of schools designed by different architects and interviewed representatives from several firms.

Representatives from Kingscott and Associates will show plans and costs of their proposals to the Citizen's Committee and the Board of Education in order that an early decision can be made on the facilities needed in the district.

Board representatives to the Chelsea, Dexter, Manchester Vocational Education Cooperative reported that a vocational director has been hired to coordinate and implement a vocational education program in the three districts. The new director is Ted Blake, presently working in this same capacity in the Lansie Cruise Public Schools.

Mr. Blake will start in his new position at the beginning of the second semester. He received his Master's Degree from Michigan State University and has had a wide and varied experience in the field of industry.

In other action, the Board of Education adopted a resolution in support of Mrs. Elvira Vogel, who is a candidate for the Community College Board of Trustees.

Mrs. Vogel, longtime active supporter of schools and education is presently chairman of the Manchester Citizens' Committee and a member of the Washtenaw County Intermediate School Board.

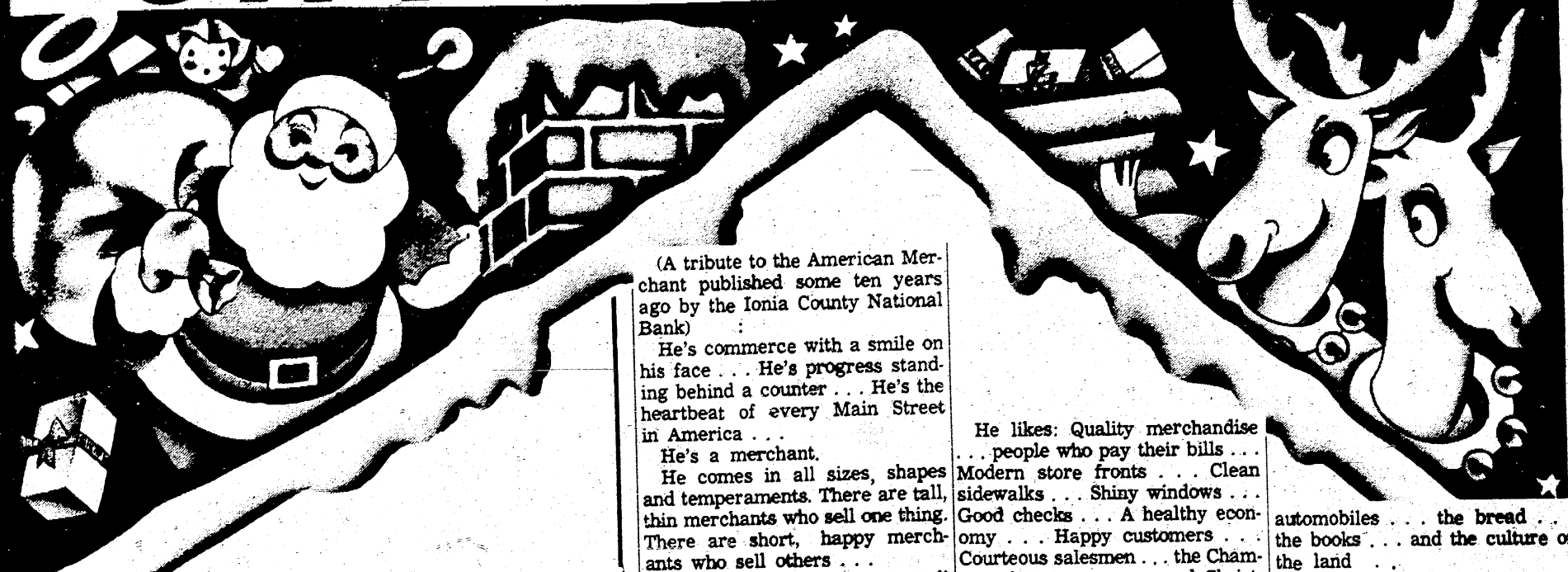
They had visited in the past at the church with their six sons and were well known here.

In an interview Friday at Friday, Mrs. McMillan and her two oldest sons told of some of their experiences and also the shooting of their two sons. They have recovered since that time.

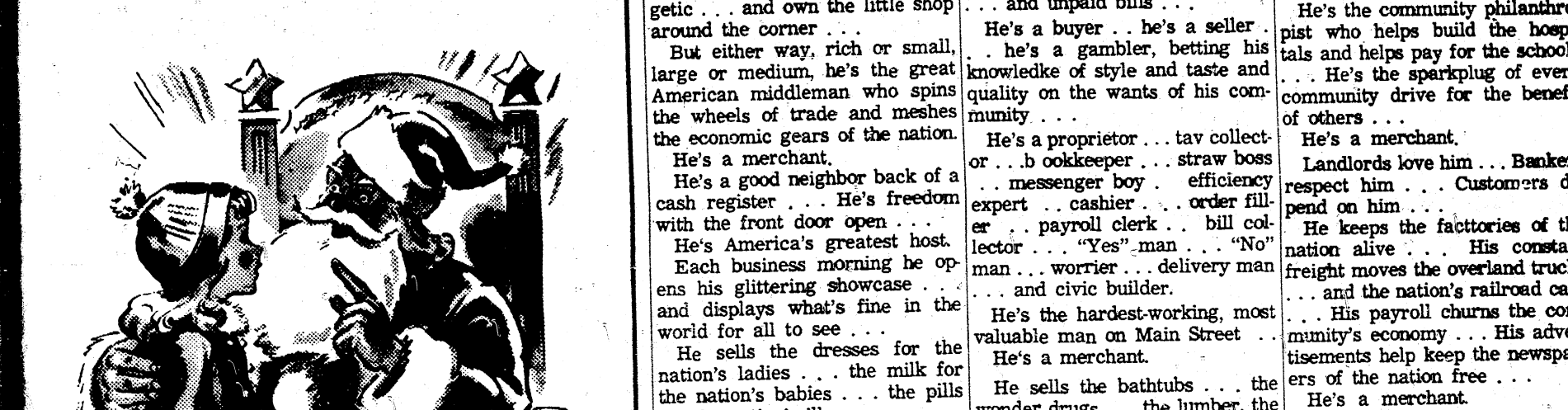

Ten foot cantilever roof overhang is useful to provide shelter when manger is located along the face of frame leg. It is also used along the open side of a cattle shed to keep rain and snow out of bedded area as well as to provide more shade in summer.

Pruden frame sheds are frequently used to shelter cattle in one end, and to store hay in the other. This building near Brussels, Wisconsin, uses the roll type of metal roofing on wall as well as roof.

STEEL FRAMED CATTLE SHEDS PROVIDE CLEAR SPAN MANEUVERABILITY AND VERSATILITY

This hay storage building may be converted to a dairy cattle shed when herd is expanded, and then the post-free interior will be much more important. This points out the importance of farm buildings being adaptable for alternate uses. Who knows for sure what the use will be ten or even five years ahead?

Hay is fed directly into feed bunk under cantilever. Note how hay can be "packed" to the peak where there are no internal posts, ties or framework in the usable storage area.

Village of Manchester ORDINANCE NO. 65

AN ORDINANCE RELATIVE TO DISORDERLY PERSONS AND DISORDERLY CONDUCT.

THE VILLAGE OF MANCHESTER ORDAINS:

Section 1. DEFINITIONS. The term "public place" as used in this Chapter shall mean any street, alley, park, public building, any place of business or assembly open to or frequented by the public, and other place which is open to the public view, or to which the public has access.

Section 2. ACTS PROHIBITED. No person shall:

- (1) Commit an assault, or an assault and battery on any person;
- (2) Be drunk in any public place or under the influence of any narcotic drug in any public place;
- (3) Drive or attempt to drive or operate any motor vehicle on any highway within the Village of Manchester while showing any evidence of having drunk intoxicating liquor;
- (4) Discharge any firearm, air rifle, air pistol or bow and arrow in the Village, except when in connection with a regularly scheduled educational or training program under adequate supervision;
- (5) Fire, discharge, display, or possess any fireworks except the type and under the conditions permitted by Chapter 39 of the Penal Code of the State of Michigan, as last amended by Act 242 of the Public Acts of 1949;
- (6) Engage in peeping in the windows of any inhabited place;
- (7) Beg in any public place;
- (8) Swim or bathe in any public place without wearing proper attire;
- (9) Utter vile, profane or obscene language in any public place;
- (10) Engage in fortune telling or pretend to tell fortunes for reward, gain, or reward;
- (11) Engage in any indecent, insulting, immoral, or obscene conduct in any public place;
- (12) Make any immoral exhibition or indecent exposure of his person;
- (13) Print, engrave, sell, offer for sale, give away, exhibit, publish, or have in his possession for any such purpose, any obscene, lewd, lascivious or immodest book, pamphlet, paper, picture, cast statutory, image or representation or other article of an indecent or immoral nature, or any book, paper, print, circular or writing made up principally of pictures or stories of immodest deeds, lust, or crime, or exhibit any such article in the view of any passerby;
- (14) Improperly, loudly or wrongfully accost, ogle, insult, annoy, follow, pursue, lay hands on, or by any gesture, movement of body or otherwise wrongfully molest any person in any public place or public vehicle;
- (15) Engage in any disturbance, fight, or quarrel in a public place;
- (16) Collect or stand in crowds, or arrange, encourage, or direct the collection of persons in crowds for illegal or mischievous purposes in any public place;
- (17) Jostle or roughly crowd persons in any street, alley, park, or public building;
- (18) Loiter on any street or sidewalk or in any park or public building or conduct himself in any public place so as to obstruct free and uninterrupted passage of the public;
- (19) Play any ball game in any public street or sidewalk or otherwise obstruct traffic on any street or sidewalk by collecting in groups thereon, for any purpose;
- (20) Engage in any act of prostitution;
- (21) Attend, frequent, operate or be an occupant or inmate of a place where prostitution, gambling, the illegal sale of intoxicating liquor, or where any other illegal or immoral business occupation is permitted or conducted;
- (22) Engage in prostitution, gambling, the illegal sale of intoxicating liquor, or any other illegal or immoral business or occupation. Proof of recent reputation for engaging in prostitution, gambling, illegal sale of intoxicating liquor, or other illegal or immoral occupation or business shall be prima-facie evidence of being engaged or occupied therein;
- (23) Solicit or accost any person for the purpose of inducing a commission of any illegal or immoral act;
- (24) Knowingly transport any person to a place where prostitution or gambling is practiced, encouraged, or allowed for the purpose of enabling such person to engage in gambling or in any illegal or immoral act;
- (25) Keep or maintain a gaming room, gaming tables, or any pool room, gaming tables, used for gambling; or knowingly suffer a gaming room, gaming tables, or any pool room tickets to be kept, maintained, played or sold on any premises occupied or controlled by him;
- (26) Disturb the public peace and quiet by loud, boisterous, or vulgar conduct;
- (27) Permit or suffer any place occupied or controlled by him to be a resort of noisy, boisterous, or disorderly persons;
- (28) Obstruct, resist, hinder, or oppose any member of the police force, or any peace officer in the discharge of his duties as such;
- (29) Wander about the streets, either by day or night, or loiter in any public building, without any lawful means of support or without being able to give satisfactory account of himself;
- (30) Prowl about any alley or the private premises of any person in the nighttime, without authority or the permission of the owner of such premises;
- (31) Spit on any sidewalk or on the floor or seat of any public assemblage;
- (32) Wrongfully throw or propel any snowball, missile or object from any moving automobile;
- (33) Wrongfully throw or propel any snowball, missile or object toward any person or automobile;
- (34) Neglect or fail to support his wife, children or family, if he shall have sufficient ability to do so, or leave or desert his wife, children or family without sufficient means of support;
- (35) Vend, sell or distribute in any manner whatsoever, any article or medicinal preparation primarily manufactured for, or which may be used as, a contraceptive except sales or distributions by or to any licensed medical practitioner or registered pharmacist;
- (36) Wilfully destroy, remove, damage, alter or in any manner deface any property not his own, or any public school building, or any public building, bridge, fire hydrant, alarm box, street light, street sign, traffic control device, railroad sign or signal, parking meter, or shade tree belonging to the Village or located in the public places of the Village, or mark or post handbills on, or in any manner mar the walls of, any public building, or fence, tree, or pole within the Village, or destroy, take, or meddle with any property belonging to the Village, or remove the same from the building or place where it may be kept, placed, or stored, without proper authority;
- (37) Summon, as a joke or prank or otherwise without any good reason therefor, by telephone or otherwise, the Police or the Fire Department or any public or private ambulance to go to any address where the service called for is not needed;
- (38) Go upon the lands of another or upon the right of way of any railroad company, or climb, stand in or upon any tree for the purpose of witnessing or looking at any football game, baseball game or other athletic sports or games whatsoever, or any fair, show or other entertainment whatsoever, without the consent and permission of the owner or occupant of such lands, right of way or the owner of any such tree;
- (39) If under the age of twenty-one (21) years be in the possession of alcoholic beverages as defined by the appropriate statutes of the State of Michigan;
- (40) Furnish alcoholic beverages as defined by the appropriate statutes of the State of Michigan to any person under the age of twenty-one (21) years.

Section 3. VIOLATION. Any person doing any of the acts, things, or doing in the last preceding section prohibited shall be deemed a disorderly person, and to be guilty of disorderly conduct and on conviction thereof shall be punished for every such offense by a fine of not more than one hundred (100) dollars or imprisonment in the Washtenaw County Jail for a period of not longer than ninety (90) days or both such fine and imprisonment in the discretion of the court.

Section 4. REPEAL. Ordinance number entitled an ordinance relative to disorderly persons and disorderly conduct and ordinance number 57 amending ordinance number 8, and all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 5. EFFECTIVE DATE. This ordinance shall take effect and be enforced twenty (20) days after legal publication thereof.

Section 6. VALIDITY. Should any section, clause or provision of this ordinance be declared by the courts to be invalid the same shall not affect the validity of the ordinance as a whole or any part thereof other than the part so declared to be invalid.

COMMITTEE ON ANTI POVERTY TO MEET JANUARY 5th

Washtenaw County's anti-poverty effort is getting underway and interested individuals have outlined the membership of a community action committee which will decide where the greatest need is and screen proposals for federal and anti-poverty funds.

A full group of representatives from governmental units, public and private agencies and civic organizations will meet January 5 to consider nominations of a six-man nominating committee.

Tentatively on the nominating committee are Curt Will, chairman of the County Board of Supervisors; Guy Larcom, Ann Arbor city administrator, Dr. Albert Wheeler, civil rights leader; Robert Kershbaum, executive director of the Ann Arbor Area United Fund; and John Salcau, Ypsilanti Public Schools curriculum director.

A representative of the Washtenaw School Superintendents Association will be a member of the nominating group.

A guideline for representation on the community action committee, as set up gives the county two members, one an administrator and one a supervisor. The county's three cities together, one member; the four villages together, one member; and all schools, together, an administrative and a board member.

It also includes representation for the community services organization and a single member from each of the following: civil rights groups, labor, Farm Bureau, Chamber of Commerce, the medical profession, churches, the professional social workers and Planned Parenthood.

Three citizens-at-large may be chosen and the Michigan Employment Security Commission will be represented.

It is believed that a county of this size would probably be eligible for \$500,000. Programs initiated under the anti-poverty act should concentrate on the most poverty stricken areas to have the best effect, according to Malcolm Lovell, director of the State Office of Economic Opportunity.

The role of the community action committee will be to do broad planning and to screen proposals from a wide variety of groups.

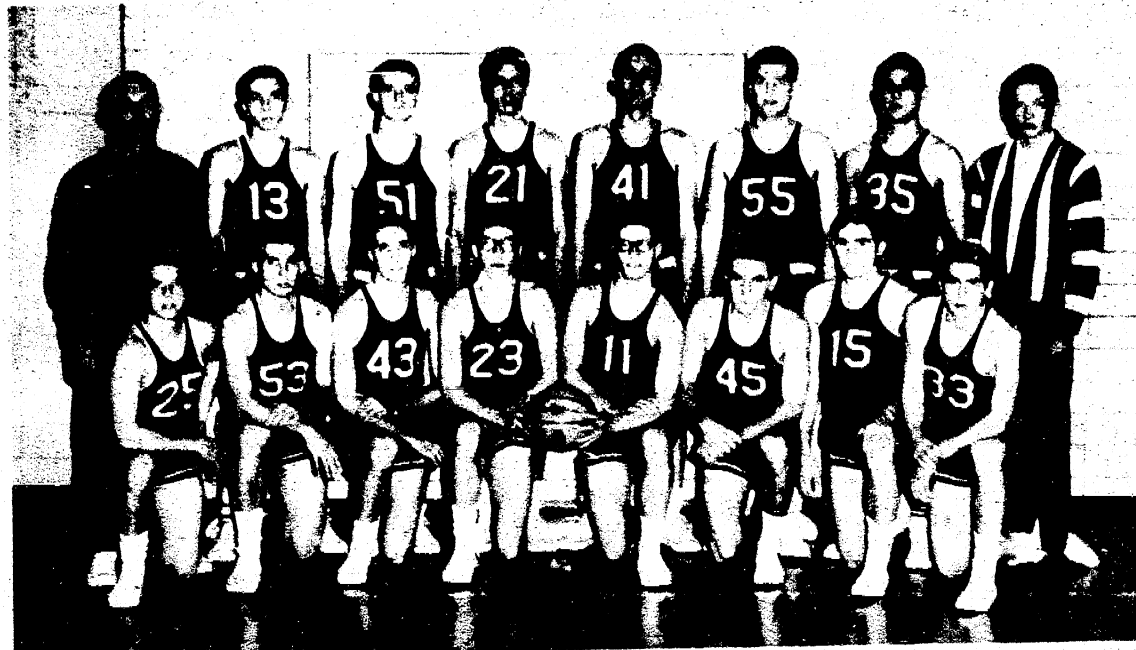

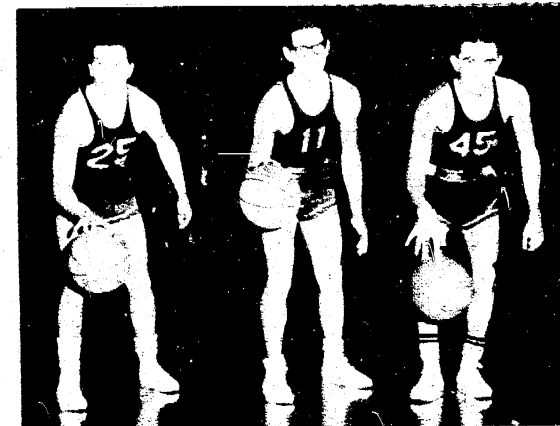

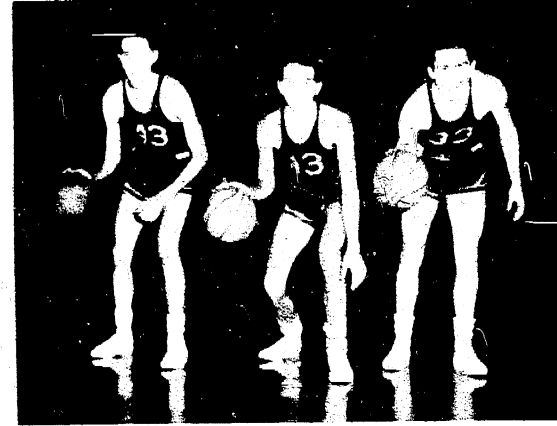

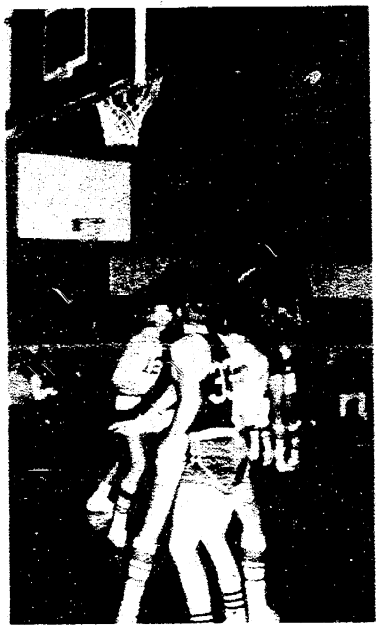
