Strange Man Committed Suicide At City Hotel Tuesday Night

Tuesday afternoon a well dressed man apparently 40 to 45 years of age, and a traveling man, called at Fred Widmayer's hardware store and asked to be shown a revolver. With but few words he purchased the weapon asking Fred to load it with cartridges. Fred gave him five cartridges, but noting the singular conduct of the man, told him he could put them in himself. The stranger then inquired about hotels and restaurants and left, going across the street to the Freeman house. At the hotel he registered as H.S. Davis and was assigned a room. He called for writing material. etc., and was shown to his room. He was out and in two or three times and finally appeared at the back part of the house and inquired of the girls if he could not go up the back stairs to his room. The girls thought strange of this and called the landlord, who told him to go up by way of the office. The fellow had previously paid his bill and when he did so, Mr. Jewett jokingly asked him if he was going to skip

It appears that he applied for a places and finally went over to the city hotel and told Mr. Reichert that he could not get a room at the Freeman house, so Mr. Reichert gave him one. Manchester Enterprise on the door. He then notified Deputy Sheriff Dietle and they broke open the door and found the man apparently asleep. In his right hand he grasped a revolver and in his left an open knife. He was dead. A bullet hole was found back of his right ear, and he had undoubtely taken his own life.

He had removed only part of his outer garments and had covered his head with the bed clothes, probably to muffle the report of the revolver. Justice Kelly being notified, searched the man's pockets and found an envelope addressed "Mrs. E.H. Dow. Carbondale, Pa.," in which were two Michigan Central railroad tickets and trunk checks to match. One ticket was issued Feb. 4th at Chicago to Scranton, Pa., the other at Kaiamazoo, Feb. 5th, to Chattanooga, Tenn. The Chicago check was No. 53,710, the Kalamazoo check No. 272,666.

In the pocket was found a scrap of paper on which was pasted a woman's picture and underneath was written "My wife". An identification slip dated 1-17-07, read: My name is E.H. Dow. Father's address is W.A. Dow, Sioux Falls, S.D. In case of accident wire Mrs. E. H. Dow, Carbondale, Pa." There was also a gold watch and chain, \$32.56 in money, two rings of keys, on one a tag appeared No. 333150. #### Agriculture In Action

A Rapidly Changing

metropolitan areas of the country probably have an outmoded perception of rural America. They tend to think that rural means farming and ranching, declining population, isolation, lack of services, poor educational opportunities, and so on.

The facts are quite different. The past 20 years have witnessed unprecendented increases in employment and population in cities, small towns and the open country of rural America. Viewed as a whole, non-metropolitan or rural areas have become much more similar to metro areas, yet they are far more diverse among themselves.

sociologists at the Department of Agriculture have come out with a report on the social and economic structure of rural America that divides the 2,443 non-metro counties into seven classifications, rather than looking at them as a whole. Actually, between 1970 and 1980,

population increased 16 percent in those counties - about twice the rate of metropolitan counties.

Counties dominated by farming number only 702, less than a third of the non-metro counties and only 13 percent of the non-metro populations. It is in these counties that farmers have the most political clout; but they represent a small minority of congressional districts.

#### A Value Added Tax

For now, Americans have escaped a tax that is a familiar form of revenue collection in Europe, the value added tax. The U.S. House of Representatives turned down the new tax as a means to fund toxic waste cleanup. A value added tax or VAT is similar to a sales tax on goods and services, but it's levied on the value added during each state of production or distribution.




