A New Generation Provides A Weekend's Entertainment

Robin Hood - The Next Generation presented by the MHS Players, provided Manchester drama lovers with an evening of delightful entertainment on both Friday and Saturday night.

As introduced by King Albert and Queen Anne, played by Joe Tobias and Jessica Weber, the tale begins in-where else? - Sherwood Forest. 

The Second Front Page Nationally Known Speaker to Visit

Preventing Drug Abuse is Everyone's Concern

Al Dicken, currently the West Bloomfield, Michigan Assistant Principal and Athletic Director, will speak to he Manchester community on November 28, 1995. Dicken is an experienced teacher, coach, health educator, and is one of the pioneers in the Detroit area for the establishment of student-support groups and drug prevention in the public schools and the community.

West Bloomfield is listed as one of the top 60 schools in the nation for its prevention-based approach to drug and alcohol abuse. Al has been featured in *People* Magazine, **The Washington Post**, and on television for his creative and highly effective student assistance programs and group facilitation trainings.

Bill Kindt, Manchester Community Schools' social worker for the past nine years, indicates that Dicken's talk with the community will be an informational and inspirational one for everyone involved. "Al is a very dynamic speaker," comments Kindt, "and I know how effective he can be because I participated in a training on leading an insight group led by him five or six years ago."

Mr. Dicken will speak to the Manchester community parents on November 28 at 7:00 PM in the High School band room. This is part of a community wide effort to raise the awareness within the community of an apparently significant increase in drug use in Manchester, Kindt explains.

Significant and alarming. Our use of alcohol and inhalants is higher than the national average per the February, 1993 survey of students in the Manchester school district. In addition, national statistics show that 16% of kids come from homes with a substance abuse problem, and "I can't see us as being any different in Manchester," claims Kindt.

Dicken's focus will be on discussing the most recent drug and alcohol survey results, how to detect if your child is using drugs, the importance of family rules, networking with other parents, and other prevention ideas. He will stimulate interest, as well as provide lots of ideas and practical tips. "Everyone needs to do their own part in this effort, "Kindt notes." 'Our goal is to educate and alert parents to the signs and symptoms of drug use.

The 1993 survey showed that A & B students were nearly as likely to have tried drugs as other kids, and "I'm more concerned now than I was two years ago," says Kindt. One especially worrisome aspect of the survey was that kids indicated they would feel OK about riding with a driver who had had three to five drinks - or think it's OK to drink and drive themselves.

"Part of it is that more of these kids' 'don't care attitudes' come back to school. These attitudes have affected not only the kids who have a substance abuse problem, but all of the students at school."

There is a lot of frustration being expressed by teachers and staff with discipline problems stemming from these attitudes. Teacher morale is affected and the kids who want to learn are being disrupted by the constant disciplinary efforts of the teachers and staff. In school suspensions are among the solutions being explored by Interim Principal John Korican and new Assistant Principal John Eisley to alleviate constant suspensions being seen as a "vacation" from school.

However, a room would be needed for this program and is unavailable at this point. Currently if an in-school suspension is instituted, John Korican's office is used, however, "that is also disruptive to the normal process of education," Kindt notes. Part time staff would also need to be hired to monitor the room during these suspen-

sions. "Chelsea has instituted a similar program and has reduced disciplinary problems dramatically," according to Kindt.

This solution is expensive, but so is the problem.

It is these problems which we face which will be addressed by Al Dicken during his presentation to the community, as well as an after-school presentation to all Manchester school staff. This meeting will be mandatory for all staff members. The focus of his presentation will be drug education, using a team approach to drug prevention, and forming a positive parentteacher alliance to help students

who may be harmfully involved with drugs.

A portion of Dicken's presentation will be a display board of the most commonly abused drugs by today's youth. You may be surprised to find out that common household materials can be among the drugs displayed.

Kindt's optimism for this program is summed up in his concluding statement. "As a community, we haven't been pulling together; as a school staff, we could do more. This will be a stimulus to all of us to do a better job."



This is Thanksgiving week and a friend of ours from the Enterprise is headed to Moldova, a part of the former republic of Romania. That trip is to pick up two young orphaned sisters who are separated by a considerable distance in Moldova. What also makes this unique is that the sisters are natives of Poland. The girls are eight and ten years of age, and were separated while in a Moldova orphanage. Apparently the younger girl suffered a great deal of stress from the separation from her sister. The girls have been reunited since the adoption proceedings were initiated and subsequently approved.

Our friend and her husband, we will call them M & P (for Ma & Pa), have had to undergo a great deal of physical, physiological and profile testing before they were approved as potential adoptive parents. Testing of routine things which we never would consider or be subjected to as natural parents. Have you had or have you been exposed to measles, mumps, whooping cough, and all the other childhood diseases? Have you been tested for HIV and other potential or infectious diseases?

In addition to all the testing, it was necessary for them to develop some language skills in both Romanian and Russian, languages used in Moldova, necessary for traveling within the country side and being able to communicate with the girls. M had to acquire a passport, arrange the plane reservations from the USA to Europe, Frankfurt, Germany and then to Moldova, Bucharest and return.

The trip goes well as of this writing. M arrived in Frankfurt and called home at 2:30 AM and departed for Bucharest. Bucharest, called the "Paris of the Eastern bloc Nations," did not support it's claim. The city has no heat or water for most of the day. Electricity and water is available for four hours out of each 24 to the general populace. It is our understanding that M's arriving meal consisted of a can of Dinty Moore Stew, cold and without utensils.

We wish them all the best of luck both on the trip there and back. We hope the girls are well and are conducive to travel. Hopefully things work out for this couple and the two youngsters. The adjustment ahead for all parties and for the inclusion of these two youngsters into our society will not be without challenge. We wish them well.

This should prove to be a real Thanksgiving for M & P and two little girls when they leave their Moldova orphanage. Good Luck and Godspeed home.

Dear Editor,

After reading your editorial comment in the November 9th edition, we feel compelled to write a response. We were impressed with the amount of space you used to get in every detail of who attended the meeting. We thought at least he is going to get all the <u>facts</u> in the story whether he agreed with us or not. But it was not to be.

You missed the entire point of our appeal and that is self-defense. Your second paragraph implies that the whole thing started in a matter of a few minutes. This is not true. The "trash talking" that you mention started during third hour and came to nothing. However, the other boy involved in the situation did tell other students after third hour that he was going to fight with our son. No one reported it as this student always talked this way and no one took him seriously. "Trash talking" as labeled by the Superintendent, Mr. Niedzwiecki, was nothing more than "my bike is faster than yours, you can't ride," etc. We would label it "boys being boys". Our son and the young man were in class together during seventh hour, and there was more "trash talking". At the end of the hour which was also the end of the school day our son left to go to his locker. While walking from the classroom to his locker he was followed by the other young man who was trying to get him to fight. Our son continued walking away trying to avoid a fight but the other boy was determined that he wanted to fight. You also forgot to mention that the other boy's locker was in a totally opposite direction and had he gone to his locker there would have been no fight. While walking toward our son's locker the other boy pushed (assaulted) our son who responded by pushing him back and telling him to leave him alone. As our son got near his locker he was again pushed by the other boy nearly knocking him down. At that point our son after regaining his balance

turned around and told the other boy to leave him alone and that he did not want to fight. Another student then said something to our son and he turned his head to hear the other student. As he started to turn back to face the young man that he was having the problem with he was struck three times in the face without warning. At that point he made the decision rather than stand there and be punched he was going to protect himself and he began to fight back. Shortly thereafter, Mr. Eisley, Asst. Principal, arrived on the scene, and the fight was stopped. Both boys were then taken to the office and within minutes suspended without talking to any of the numerous witnesses. To us that sounds like a "rush to iudgment." (All of the facts above were substantiated by witnesses at the board hearing.)

After talking with our son in detail that night, I decided to take him to school the next morning and talk with the Principal and the Assistant Principal, as we were sure that our son had not explained the situation to them clearly the night before, probably because he was mad by then, and that after hearing the full story our son would not be suspended as he was not fighting but merely defending himself. I also wanted to make sure that they did not have other information that my son may have "forgotten" to tell us that might change things. We were still under the impression that "everyone", even students at Manchester High School, have the right to defend themselves against an attack. We could not have been more wrong.

In your third paragraph you seem to be saying that we appealed because the administration did not follow the rules. Even though that is true, we appealed because we felt the punishment was unfair under the circumstances. Don't misunderstand us. We think the no fighting rule is good but it needs to allow for self-defense. Had this been a


fight between two boys due to tempers, etc., there would have been no appeal, and our son would have also received additional punishment at home. This is the first time in our lives where we have run into a situation where if you are attacked instead of being able to defend yourself, you can expect to be punished. Isn't that victimizing the victim?

The Board of Education's decision affirmed the suspension but waived it if our son performed 20 hours of community service. One thing you did manage to get right was that I was irate. Not only because the board tripled the suspension (from 6 to 20 hours) for our son but because of their suggestion that he spend two hours a night for two weeks helping the janitors clean the school. Can you imagine the "trash talk" that would lead to for any high school kid? Would not the board then be creating another situation that could lead to another fight?

Do we regret our appeal? NO! ~ We did the right thing under the circumstances just as our son did. We are proud of our son. He did exactly what we have always told him. He tried to avoid the fight but when he was attacked, he had the right to fight back. Would any parent tell their child different? In assault and battery cases juries are instructed by the trial judge that "A person has the right to use force to defend himself under certain circumstances. If a person acts in lawful self-defense/defense of others, his actions are excused and he is not guilty of any crime." They are also further instructed, "The person claiming self-defense must not have acted wrongfully and brought on the assault. However, if the defendant only used words, that does not prevent him from claiming selfdefense if he was attacked." Words are not an assault nor are they an excuse for an assault. The administration believes that our son entered the fight by his words. Don't we teach our children to live the law of the land? We would have won this case in a court of law. What message is this administration giving to our children?

We thought in a small community like Manchester our kids would be safe, and we would not have to worry about these things. Our son now has a record and F's in all his classes for that day of suspension. We don't know about anyone else but we sure don't feel good about sending our kids to a school where if someone decides to attack them, they can expect to be punished for being a victim. Punished even if that attack were to put them in the hospital. Gar, there is something much more important at stake here than preserving the integrity of the educational process as you stated, and that is the integrity of the individual and choosing to do right.

Exploring WISD

A Visit to the Washtenaw Intermediate School District

by EWG

Few of us, outside the educational community, know the function of the Washtenaw Intermediate School District or what services they have to offer.

With that in mind we made a trip to Wagner Road, just north of Scio Church Road, where they are based. Superintendent Michael O. Emlaw met us and conducted a tour of the facilities and provided background.

WISD, according to Emlaw, is your regional educational service agency. "We coordinate and deliver services and programs to improve education in 10 school districts in Washtenaw County. (Ann Arbor, Chelsea, Dexter, Lincoln, Manchester, Milan, Saline, Whitmore Lake. Willow Run and Ypsilanti.) We offer training for teachers, bus drivers, secretaries, administrators, board members, other school staff and parents with the latest in technologies, techniques and methods.

"We provide research assistance and a resource library of journals, books, curriculum materials, films and videotapes. We coordinate programs and services that are too expensive for a single school district to operate or that are specialized and serve only a few students, including direct services for youth and adults with special needs. Some of the services are required by law others by demand. We are governed by a five member Board of Edu-Mark cation. Mr. VanBogelen, a Manchester resident, is a Board Trustee of WISD."

Emlaw continued, "WISD is a team of 200 employees serving: over 40,000 students, 1,560 adult education students, 4,800 school employees and 70 public school board members from 10 public school districts and 25 non-public schools. We are funded with federal, state and local dollars. In 1993-94 the general and special education dollars were primarily from local taxpayers, over 67%. (See chart)." Dr. Emlaw conducted a guided tour of the buildings while giving us that information.

The first building we toured was High Point. High Point, is a specialized school building, a beautiful facility. Constructed in 1973-74, with state of the art equipment and amenities designed to educate mentally handicapped

persons previously housed at State of Michigan facilities, such as Lapeer or Ypsi State.

According Emlaw, "The State mandated the shift to the local districts and WISD constructed High Point to accomplish the task. Later the State and the public began to understand that a goodly share of the handicapped could be better served by each local district, as participants within their district school systems.

"High Point has changed; we now serve the more demanding and medically fragile of the handicapped."

Of the rooms we observed different age groupings were present. One classroom had 19 to 26 year old participants, from autistic to socially needy. They were being introduced to computers as a method to express their needs and responses. Another exercise area had paraplegic students who were working with staff members. These students were middle school grades. A third grouping had severely impaired lower elementary age children. Their special needs required medical monitoring. A full-time staff member and three assistants were busy suctioning trach and caring for their needs. The students educational needs had to be coordinated with their physical requirements.

(This writer was very impressed with the care being given to the students. The staff members where willing to share their expertise with me and I truly was impressed with their dedication.)

The building is equipped

with several classrooms and open work areas with large pads on the floor. Many physical devices to assist in care needs. A large gym that was constructed for basket ball gets limited use because of the change in use and needs of the students. A large indoor pool


has a hydraulic lift which was provided by the Kennedy Foundation. This lift allows students, or wheel chairs with students, to use the pool. The lift creates a movable floor with varying depth of water.

WISD leases unused

space to other agencies for related education needs. One of the unique services provided is a day-care center for children of staff members. Persons from the surrounding area can also use the day care services for a fee.

As we were completing the tour of High Point, school buses from the different districts were arriving to pick up their students. As you can well imagine, a cold wintry day, creates unique needs for warm clothing. Just one more task the High Point staff was so ably conducting.

In our next article we will be covering the main building and its "Elvira Vogel" addition. As you probably are aware, Elvira Vogel is a resident of our district and was a 30 year staff member of WISD. Greatly admired and respected by Washtenaw Intermediate School District, the new facility was named after Elvira.

SHERIFF SCHEBIL OFFERS SAFETY TIPS FOR SHOPPERS...

The Thanksgiving holiday is fast approaching and along with anticipating those traditional family get-togethers, turkey dinners with all the trimmings and football games galore, many of us will also be thinking about getting a jump on the hustle and bustle of holiday shopping.

Traditionally, the day following Thanksgiving is one of the busiest shopping days of the year, with throngs of citizens taking ad-

vantage of this four-day holiday to begin filling their Christmas lists. With this in mind, Sheriff Ronald J. Schebil of the Washtenaw County Sheriff's Department would like to pass along to citizens a few safety tips that can help ensure their protection as they venture out on their shopping sprees.

SAFETY TIPS FOR SHOPPERS

Never leave your purse in a

shopping cart or on a counter unattended. Purses should be carried close to the body and secured under

• If using credit cards, request to receive your carbons back or OBSERVE the sales clerk destroy them. Always remember to retrieve your credit card and/or driver's license immediately after each pur-

 Avoid carrying large sums of money.

• If you leave packages in the car, keep them well concealed. Place them in the trunk or cover them with a blanket so they are not readily

• If you shop at night, also shop for a safe parking space. Try to park near a well-lighted area and be sure to make a mental note of the aisle in which you've parked. Be certain your car doors and windows are locked upon leaving your vehicle. (NOTE: Never leave keys in a car or

leave the motor running while your car is unattended; not even for a moment!)

- · Walk on designated walkways that are well lit and well traveled.
- · Walk confidently and assertively. Be alert and aware of your surroundings, even when inside the shopping center.
- · Seek refuge in a store if someone bothers you.
- If you believe someone is following you, be suspicious. Keep looking behind you and you may discourage the follower - the surprise of a hostile look will deter most assailants. Remember, their

greatest advantage is the element of surprise. Scream if necessary. It can attract attention and frighten an assailant.


Other suggestions:

- If someone is following you on foot, cross the street, change directions, or vary your pace. If you are being followed by someone in a car, turn around and walk in the opposite direction. If the person persists, record the license plate number and call 911 immediately.
- · Before you leave the store, place your keys in your strongest hand, wedged between your fingers, and keep that hand free to open the car door quickly.
- · Before getting back into your car, be sure to double-check that the back seat is unoccupied. Upon entering the vehicle, lock the door immediately, even before starting
- · Whenever possible, shop with others. Suggestion: Car pool to and from the shopping center, set up a rendezvous location and time and stay in a group when returning to the parking lot.



Diane Hughes reported there will be an ornament exchange for the Christmas meeting/party. Dept. President Joni Weindorf will be guest for this Christmas potluck.


