## Civil War Monument Due for a Facelift

## Fire Department Scam Revealed

As you pass Oak Grove Cemetery on the west side of town, one of the outstanding sights is that of the Civil War monument near the east entrance. In recent years, however, the base of the monument has begun deteriorating and the monument's viability is threatened. American Legion Emil Jacob Post #117 has begun a campaign to restore this unique and beautiful memorial to its original condition.

Milt Davis, who is spearheading the Legion's effort, has indicated that work will begin within two weeks with hopes of completing by Memorial Day.

"The original inscription is 'In Memory of our Soldiers Dead,' beginning with the Civil and Spanish-American Wars. A plaque has been added since 1975, because it includes WWI through Vietnam," Davis noted. "We would like to re-dedicate this memorial to all, past and future, who lost their lives in service to our country."

The Legion Breakfasts held on the first Sunday of each month, have committed funds to the restoration project, which will cost around \$2,500, according to Davis. The Legion is also inviting other community organizations and individuals to join in this effort. "The original monument dedication indicates it was a community-wide effort along with the Comstock G.A.R. (Grand Army of the Republic) Post #352. We hope to get the community involved in the restoration as well," said Davis. The Comstock Post was named for Manchester resident Lorine Comstock, who was killed in Knoxville, Tennessee, in 1863.

Old issues of the Enterprise indicate that the dedication address on May 30, 1907, was given by Captain Edward P. Allen, who had served with the 29th Michigan Regiment. Because of the historical significance of the original dedication, Legion members hope to have the restoration complete for a re-dedication this Memorial Day. John Schaible will be doing the cement base, and Arnet's of Ann Arbor will sandblast the statue in preparation for re-painting.

Any interested citizens or organizations who would like to contribute to the restoration fund may make checks payable to "American Legion Post #117" and mail it to PO box 144, Manchester, noting that it is a donation for the statue fund. "We are also looking for a few good volunteers," added Davis. If you have an interest or talent which might be useful in this project, you may contact Milt at 428-7874 or Legion Commander George Daubner at 428-8433.

Or come and have breakfast on Sunday, May 5 at the Legion Hall. Bring the whole family; bring your friends. All proceeds are earmarked for the statue restoration fund.

Mat Blosser bemoaned the lack of community involvement in Decoration Day ceremonies back in 1907.

"Our citizens do not seem to take much part in the annual observation of Decoration Day. The G.A.R. from choice or because they feel it their sacred duty, apparently do it all, with the assistance of the school. This ought not to be so, but it is and we are thankful that we have a G.A.R. post to prepare the wreaths of flowers and place them on the graves of the old comrades who have passed away."

Some ninety years later, we have the opportunity to bring the entire community together for this re-dedication. Watch the Enterprise for updates, and we'll see you at the cemetery on Memorial Day.

Fire Chief Gary Wiedmayer reports that at least one Freedom Township resident has received a phone call soliciting funds for our local fire department. The wise resident decided to ask questions before making a decision, and was given an 800 number to call back to donate.

"Currently our only fund raiser is our 300 Club," Wiedmayer clarified. "If you get a call, you may verify it by calling the fire department's non-emergency number (428-9439) and we will return your call." Or, you may call the Manchester Township Office during office hours at 428-7090. It would appear this solicitation is a scam, of which the community should beware.

And the 800 number? Wiedmayer called it and reached a recording, "We're sorry...this number is not accessible from your area."

## WWRA Seeks Funding

### Moving Ahead to the 21st Century

It has been five years since eight municipalities in Western Washtenaw County approved the development of the Western Washtenaw Recycling Authority, and agreed to fund its existence with a \$17/year special assessment to be levied over five years. (Weekly curbside recycling in the villages of Manchester and Chelsea is assessed at \$30 per household per year). At a recent meeting of the WWRA Board, approval was given for the first phase of an expansion project to begin, based upon the exceptional year the Authority had in 1995. They also approved a ballot issue to be put before the voters in November for a renewal of the special assessment to support the continuing efforts of the Western Washtenaw Recycling Authority.

What will we get for this extra \$85 (or \$150) per household over the next five years? What are we getting now that other local communities don't already get for free? What plans are being made for the continuance of the Western Washtenaw Recycling Authority?

Sybil Kolon, the Manchester Township delegate to the WWRA, helped to put some of these questions into perspective. "The benefits of continuing the Authority are many. The Washtenaw County Solid Waste Plan calls for a 30% reduction in solid waste in local landfills. The communities receive tipping fees from BFI based on their population. In order to continue receiving these monies, each community needs to prove that they are meeting these county goals. The WWRA has these facts and figures for every yard and every truckload of recycled goods that they process."

Over the past five years, the WWRA has helped communities increase the incidence of recycling, as well as increasing the varieties of goods which can be recycled.

In the beginning, there was tin, glass and newspaper. Currently, the WWRA accepts #1 and #2 plastics, tin, aluminum, green, brown and clear glass, newspaper, office paper, corrugated cardboard, cardboard packaging and magazines. With the expansion of services has come the need for expansion of their facilities. With the money they have carefully budgeted over the past five years, the WWRA has built their facility, maintained their equipment and expanded services, besides creating a reserve fund for unexpected expenses. With a total budget of around \$250,000 for 1996, approximately 63%

comes from the special assessment. "Recycling is such a volatile market," Kolon explains, "we can't count on the sale of materials being a major source of our income." 1995 was a great year because the market for corrugated cardboard allowed them to do quite well. Sales income was \$80,000+ over budget. However, "this year the demand has lessened, and things might not stay so good," according to Kolon.

Based on the surplus from 1995, however, the WWRA Board has approved Phase one of the expansion program. This will include a 60'x60' addition to their current building, and a 15' lean to for additional storage. "Currently, storage is our main concern," Kolon explained. "Because we cannot store materials, they have to be baled and sold as they come in. This does not allow us a great deal of flexibility in timing, as prices change daily." Extra storage facilities will allow the WWRA to stockpile, wait out the down times in the market and get the

best possible prices for the recycled materials.

With the renewal of the special assessment, the WWRA hopes to increase both services and their own profitability. All of this is a benefit to the communities it serves. "We'd like to be able to accept tires, household batteries, and become part of a cooperative effort in the county program for toxic household waste. We might be able to do an annual or semi-annual collection of household toxic waste materials. We will also be looking into expanding the number of plastics we can accept," said Kolon.

The market for other plastics is not as heavy as for #1 and #2. Kolon noted that the Adrian recycling facility had to close for lack of funding, partly because the owner accepted all kinds of recyclable materials. He then began to ask people for a small donation when they dropped off recyclables, which didn't happen. People seem to think this is 'free,' yet recycling is not a self-supporting project.

We all realize there is no free lunch, and if something seems 'too good to be true,' it probably is. The whole point of recycling is to keep reusable resources out of the landfill. It isn't 'free' to have trash picked up, either.

Phases two and three of the expansion project, which will be begun when the voters have had their say, will include in phase 2 a small separate 20'x24' addition which will be attached to the main building. Currently, they can't have a computer or other dust-sensitive equipment because they are too close to the work floor. This addition will provide space for these office necessities. Phase 3 will be a 40'x64' pole barn to provide inside storage for the vehicles. This will effectively reduce maintenance costs on the vehicles and decrease down-time due to weather.


The terms of the grant under which WWRA is operating include a provision that they show ten years of consistent operation. They are halfway there. "We are not asking for an in-

crease, just to maintain what we have received for the past five years," indicates Kolon. "The nay-sayers thought we'd never make it; that the money would be wasted. We have proved that with good management, we can do it!" She noted that the prison camp workers have been working out well for the WWRA, and are helping to keep costs down. "That's another reason the private sector can't compete with our performance," adds Kolon.

We want to continue to expand our services; extending the assessment for an additional five years will allow us to do that."

Public hearings regarding the special assessment will be held in the summer of 1996. The Board of Public Works will make a determination based on the information and comments received at public hearings. Be sure to watch the *Enterprise* for further information from WWRA over the coming months.

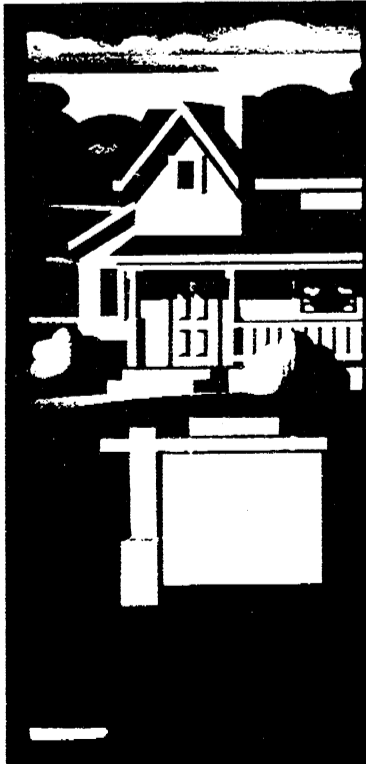

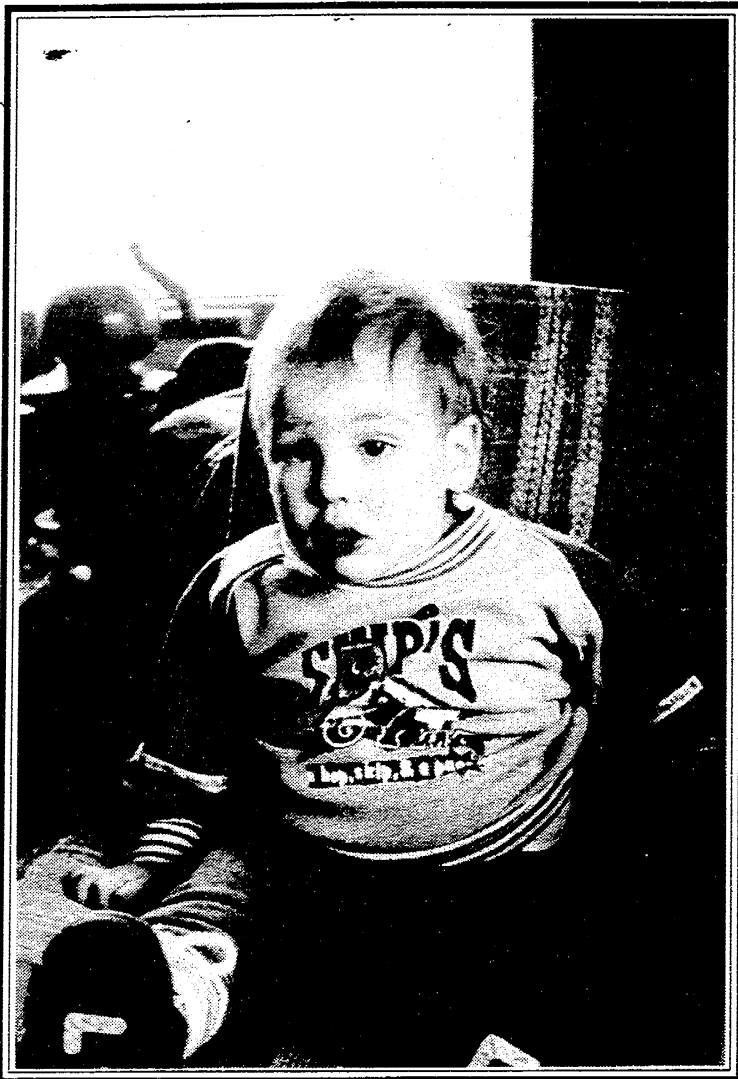

## Dustin Jones' Miracle Rescue and Recovery continues

On a cold, snowy street in Tecumseh on January 29th little Dustin Jones' life almost came to an end, according to his Maternal Grandparents, Mr. and Mrs. Robert Rhees, of Manchester. They shared the story with this writer.

Little Dustin inadvertently fell from his parents pick up truck onto a snowy, slippery Pottawatamie Street. Dustin was trapped under the rear tires of the pick up, with his mother screaming in fright, when James Freshcorn, James Barnette, Chris Doan and Donald Long miraculously came upon the scene.

Sgt. William Warner of the Tecumseh Police Department arrived after the first four responded. Doan, Barnette and Long lifted the truck off little Dustin. Doan began administering CPR, Freshcorn and Warner also used CPR on the little tyke who by this time had turned blue. The men estimated the rescue only took two or three minutes, but they were prob-



ably the longest minutes of their lives.

Dustin's skull fracture, collapsed and bruised lung has healed. He continues physical and speech therapy in Ann Arbor and will continue probably until he starts school.

This little guy is active and is making astounding progress. Dustin's mother Amy Jones has been subjected to a great deal of criticism for not having Dustin strapped in the vehicle, after dropping her 5 year old off at school. Amy said her self-recrimination for not being enlightened regarding child safety lives with her every day. "I learned a hard lesson."

Dustin's "Angels," Barnette, Doan, Freshcorn, Long and Warner were honored by the Tecumseh City Council and have the gratitude of parents and grandparents alike.
