The Second Front Page Olympic Fever

Going For the Gold!!!

If you heard that Manchester, Michigan would not be represented at the 1996 Olympics In Atlanta, you heard wrong.

A Manchester Resident has been working long and hard to perform with excellence at the Olympics in the event for which she is trained.

A Manchester resident has been working long and hard to perform with excellence at the Olympics in the event for which she is trained. And that event is the culinary arts. Debbie (Blossom) Kastanis will be in charge of the VIP catering at all Olympic events from July 25 through August 5th.

The International Olympic Committee hired "Food For All Seasons," an Ann Arbor-based catering firm, to supply the chef power at all events hosting the VIP's of all nations, from the opening through the closing ceremonies. Debbie has been a chef with Food For All Seasons for two years.

Since the Olympics will be held in Australia in the

year 2000, three well known caterers from that country will be in Atlanta this year, to showcase Australian cuisine. They will cooperate with Food For All Seasons and begin to prepare for the special dishes they will concoct four years from now.

Antoinette (Toni) Benjamin, owner of Food For All Seasons, is a member of the International Association of Culinary Professionals, the world's largest professional culinary organization. "We have worked with the Australians, and as they were familiar with us, they requested the IOC that we team up with them for this special event," explained Toni.

What is Australian cuisine, anyway? Toni sent along an article which explains that, "A huge range of produce which the diverse climate allows, combined with the fact that as an island continent, Australia has escaped the worst ravages of air, water and soil pollution that beset other parts of the globe, and European settlers' tastes combined with substituting available ingredients from the bush, have all contributed to an eclectic culinary style." Simplicity of preparation and superior raw produce are the hallmarks of their food.

This is what Toni found when she attended a conference of the International Association of Culinary Professionals last year. She was

so impressed that she came back for two weeks at her own expense, to work and learn in the kitchens of Sydney's Darley Street Thai. She is also among those members of the IACP who nominated Normal Willis of Juste Nous catering in Sydney, as a guest speaker at this year's IACP Conference in Philadelphia.

"We developed a rapport," Toni said. "They

Not that Food For All Seasons doesn't already have an international reputation, according to the articles. Toni has fed President Bill Clinton as well as the Dalai Lama. Toni currently tours the country on behalf of Campbell College, where she serves on the board, to help establish the first catering degree program in the nation. She teaches collegelevel courses in catering and has helped to establish the benchmark for that education. Don Bargo, the executive chef, headed to Atlanta on July 15th to lay the groundwork for what is to

come. Debbie will arrive on July 25th, to head up the operation during the Olympic Games, and will be first in command during that time.

At Food For All Seasons, "We do full course catering," explained Debbie. Toni adds, "We take pride in using the freshest ingredients and place a real emphasis on the taste and the visual effect of the foods we prepare." The company has been serving the Ann Arbor area for fifteen years and was recently featured in a trade magazine, Cater Source Journal.

According CaterSource, Toni is billed as a "culinary wizard on the national scene." The majority of Food For All Season's business stems from the University market. At their annual March Open House at their facility at 1164 Broadway, featured in the CaterSource photo spread, showcased a unique arrangement which allowed the guests to meet each other as well as the catering staff. The complete menu of foods included appetizers, a "Thai station," chicken dishes, and desserts.

Don Bargo has been with Food For All Seasons for just over a year. He has previously worked as a restaurant chef and explains that there are a lot of differences between a restaurant kitchen and a catering one, the wide variety of unique menus being the most prominent dif-

ference.

Toni, too, explained that there is a very real, although perhaps subtle, difference between the two types of chef. "And Debbie is an excellent catering chef," she affirms. She has every confidence that Debbie will represent Food For All Seasons beautifully during the time she is in charge in Atlanta

"While we were making final preparations for Don to go down last week, one of the questions we asked was if there was air conditioning in the kitchen." Toni said with a chuckle. "They told us, there would be when it was finished! It must be wild down there." Toni will find out for herself on Wednesday when she arrives to make more final arrangements for the firm.

At the time of our interview, Toni was not certain of the menus which would be prepared at the Olympic Games. What is certain is that they will be yet another showcase of the exceptional talents of Manchester's own in an international arena.

Congratulations, Debbie!





PROPOSED SYNOPSIS

of the Annual Meeting and Public Hearing on the proposed General Fund budget held June 27, 1996:

The annual meeting was called to order at 7:33 p.m. Board members present: Supervisor Mann, Clerk Hakes, Trustee Widmayer, Trustee Macomber. Absent: Treasurer Turk. Also present: Library Board members Charlotte Major and Patricia Ahrens, Fire Department officers Gary Wiedmayer and David Jose, and Constable Lyle Moore.

The annual meeting was recessed for the public hearing on the proposed budget. Line item revenues for the General Fund budget were reviewed and discussed and all special fund budgets were examined. The budget hearing then closed.

When the annual meeting resumed, the minutes from last year's annual meeting, held June 29, 1995, were approved with one correction. Salaries for the Township Board were approved, and compensation was set for the Board of Review and election inspectors. The financial presentation was given by Supervisor Mann.

Fire Chief Wiedmayer reported that the new truck will be here soon. Two personnel will be added to the department. Appreciation was expressed to employers in the community for allowing firefighters to leave work when necessary. Appreciation was also given to firefighters and their families for their sacrifice and dedication.

Library Board member Char Major presented the library report. She noted that the major event for the library and eventually patrons was the hiring of an architectural firm to aid the library in becoming more accessible to more people. The library is open 46 hours per week, using current staffing. Their annual financial report was presented, along with a five year overview of the library budget.

Constable/Zoning Inspector Moore presented his annual report, noting that 14161 miles were traveled for constable duties, and 3580 for zoning. Duties in both areas have increased tremendously.

The electors present recommended acceptance of the 1996-97 proposed budget.

The Treasurer was authorized to utilize any local bank or savings and loans in the area for the 1996-97 fiscal year.

The regular meeting day for the Township Board was set as the second Monday of the month at the township hall at 8:00 p.m. If this day falls on a holiday, the meeting will be held the following day.





There was so much to do, so much to see and so many things to be involved in. I don't know about you but I'm already looking forward to next years Manchester Community Fair.



Kluwe Re-elected as **School Board President**

July 8, the Board of Education conducted their Organizational Meeting with the seating and oath of office of new board member Marilyn Knouase and incumbent John Ochs.

Correspondence included the Accelerated Reader Parent Survey Results and Superintendent Niedzwiecki presenting the 1996-97 tentative school calendar. The July 1996 organizational meeting of the Manchester Community Schools Board of Education legal reference status as a school district was changed by the Revised School Code (MCL 380.1 et seq) amendments, which became effective July 1, 1996. Prior to this date the district was classified as a fourth class district, we now are a general powers school district by operation of

Board Operations and By Laws were adopted my motion by Winzenz, supported by Ochs. All members present, Kluwe, Winzenz, Ochs, Sahakian and Knouase voting yes. Members absent Abbott and

John Ochs called for a rules suspension to move that existing officers, (Kluwe - President; Turk - Vice President; Winzenz -Treasurer) and the addition of Abbott as Secretary be called for, Winzenz supporting: Sahakian dissented and the individual offices had to be individually voted upon.

Sahakian's reason for dissent became apparent when she voted against Kluwe when he was nominated for the office of president. Kluwe was elected - Winzenz, Ochs, Knouase, Kluwe voting - Yes; Sahakian No; (Sahakian was president prior to Kluwe being elected three years ago.)

Turk was elected as Vice President; Abbott as Secretary; Winzenz as Treasurer, all by a 5 -0 count.

Knouase, Turk and Ochs were appointed to the executive committee. Winzenz, Abbott and Sahakian were appointed to the finance committee. Various meeting dates, and authorizations were made as prescribed by law or rules.

Board meeting of July 15 all members present except Abbott.

The resignation of Cara Weissman band director was accepted with regret being expressed. Weissman has accepted the position of band director with Saline Public Schools.

Brian Schick was appointed 8th grade Boys Basketball Coach for the 96-97 sport season.

Cheryl Mullikin was approved as a Special Education Teacher Consultant part time for the 96-97 school year with probationary status. Debra Boham was approved for part time Speech and Language Therapist for 96-97 school year with probationary status.

A resolution setting the operating millage rate of 18 mills on nonhomestead property and 1.90 mills for the 1995 bond issue certification for December 1996 tax levy was approved by roll call vote.

A recommendation by Superintendent Niedzwiecki for the expenditure of \$25,496.07 for vinyl, carpet and installation by Office Depot was approved by roll call vote.

1st of America submitted the low bid of 4.05% for the purchase of \$800,000 State Aid Notes.

Mike Truax, O'Neal Construction was on hand to update the Board on the building project progress. • Klager... Demolition and structural modifications have been accomplished. Computer room addition has the roof joists and decking in place and awaiting the roofer. Brick and block walls are being erected but the steel due for delivery the 15 has not arrived.

·Ackerson brick and block work proceeding. Concrete slab being poured now. Work is slightly behind schedule.

• Budget status shows the current total to be \$3,265,520 which is slightly increased from last months total of \$3,264,182. Additional increases are expected but the total contract is within budget.

Garlick reported that the work accomplished to date is in substantial compliance with accepted building practices. It appears the building schedule of work probably will not be met and that some delays should be anticipated.

Maintenance Projects in the amount of \$105,000 were approved the Board. Meeting adjourned at 8:30 PM. Staff.

AREA STUDENTS COMPLETE SKILLS TESTING

Two area students have successfully completed the OBRA (Omnibus Budget Reconciliation Act) nursing assistant clinical skills test. Manchester students Katie Tolen and Jamie Knouase took part in the testing after fulfilling their formal education requirement. Students received their education in the Health Occupations class at the South & West Washtenaw Consortium (SWWC). After completing the class, students are eligible to have their name placed on the nurse aide registry in Lansing.

OBRA regulates that nursing assistants for long term care facilities must have a minimum level of training as recognized by the State, provided by a State approved program. SWWC has been a licensed training site since the 1989-90 school year. Students then must complete both a clinical skills and a written skills test in order to receive a State registry document.

Arlene Sullivan, SWWC instructor, said, "Students see completing the program as a stepping stone to other health related careers and/or college." Katie Tolen, a senior, plans to continue her hands-on training in the health care field through a co-op position this fall. Tolen said, "The certification is a way to help put myself through college by helping me get a good job and always having a skill to fall back on." Tolen plans to continue her education in either physical or occupational therapy. As indicated, for those college bound, the registry document provides a way to earn money as they continue their formal education.

Summary - Board of Education


