

The addresses from teachers and administration may have been predictable but they had a special meaning to these four students. The themes of these speeches - setting goals, determination, and success - were the key to their futures.





# Out of the Pen



# Notice of All Sharon Township Residents - Amendments to Sharon Township Ordinance

The following amendment to the Sharon Township Zoning Ordinance was approved by unanimous vote of the Sharon Township Board during a regular monthly meeting held on Thursday, October 1, 1998. A public hearing on this amendment was held on Thursday, August 20, 1998 by the Sharon Township Planning Commission. They recommended approval as did the Washtenaw County Planning Commission except amending Article 10 Schedule of Use Regulations. The County approved it with conditions.

A summary of the amendments are as follows:

To add to Article 2 Definitions, Section 2.01 Interpretation, more specific guidelines for interpreting "shall" and "may", modify Article 2 Definitions, Section 2.02 Definitions, changes to existing definitions, to add new definitions to Article 2 Definitions, Section 2.02 Definitions; to add to Article 11 Supplementary District Regulations, a new Section 11.11 Commercial Communications Towers and Antennae, providing regulations for the use, maintenance and location and removal of wireless communications facilities, to add to Article 2 Definitions, Section 2.02 Definitions, new terms associated with the above new section 11.11; and to amend to Article 10 Schedule of Use Regulations. The following amendment to the Sharon Township Zoning Ordinance was approved by unanimous vote of the Sharon Township Board during a regular monthly meeting held on Thursday, October 1, 1998. A public hearing on this amendment was held on Thursday, August 20, 1998 by the Sharon Township Planning Commission. They recommended approval as did the Washtenaw County Planning Commission except amending Article 10 Schedule of Use Regulations. The County approved it with conditions.

The following amendment to the Sharon Township Zoning Ordinance was approved by a 3 to 2 vote of the Sharon Township Board during a regular monthly meeting held on Thursday, October 1, 1998. A public hearing on this amendment was held on Thursday, November 20, 1997 by the Sharon Township Planning Commission. They recommended approval. The Washtenaw County Planning Commission approved it with conditions.

A summary of the amendment is as follows:

To add a new Article 4.0 Open Space Community District.

The zoning ordinance amendments may take effect not earlier than 7 days after publication. During that 7 day period, any registered elector may file with the Clerk a Notice of Intent to file a referendum petition. A referendum petition must be filed 30 days after publication.




All of those who attend will receive a certification card for the training that you received. Your name will then be added to the file in Detroit as one who is certified.

# WHAT'S AHEAD FOR THE MANCHESTER TOWNSHIP PLANNING COMMISSION?

We talked with John Schmidt, Chair of the Manchester Township Planning Commission, about expectations for the year ahead. He expects to see a lot of growth in the Township. "Frankly, Manchester and Bridgewater are in the crosshairs right now. Saline and Chelsea are getting developed up and we're all of a sudden on a bubble right now." Manchester, he added, "has been saved by not having an I-94 access. If M-52 were a four-lane highway, we would have a very different story." The other members of the Manchester Township Planning Commission agree, and are concerned about how to plan for future growth.

another reason for the increasing pace of development in Bridgewater and Manchester Townships is because Chelsea is having some problems finding a water supply. He should know - water is his business.

John Schmidt manages the office of the Michigan Groundwater Association and has been in the well drilling business during most of his working life. Washtenaw County is home - "I've lived in Washtenaw County all my life, in Lodi, Scio and now Manchester Township."

"There's a lot of work for the Planning Commission. We have our regular work, and we also need to make time to engage in the long term planning pro-Mr. Schmidt says that cess. We've decided unani-

mously that we have to return to two meetings a month." The Planning Commission will meet on the first Thursday of each month for a "working" session and on the third Thursday for its regular sessions." Meetings are open to the public.

While he's not sure of the timetables involved, Mr. Schmidt left little doubt that there's much to be done. "We have a rezoning request to consider, along with other issues, such as looking at mobile home parks, in conjunction with our land use map which needs updating, which may be difficult. We need to update the private road ordinance, and get it in tune with the times."

#### Manchester Village Code Chapter 111 - Nuisances Noise Control

**8.22 General Prohibition** It shall be unlawful for any person to create, assist in creating, permit, continue, or permit the continuance of any unreasonable loud, disturbing, unusual or unnecessary noise which annoys, disturbs, injures, or endangers the comfort, repose, health, peace or safety of others within the limits of the Village of Manchester.


# Timber Lake Road Funds Released

At its meeting on January 11, the Manchester Township Board authorized the release of the funds placed in escrow to assure satisfactory completion of Timber Lake Road, a private road at the Stoney Lake Farms development off Austin Road west of the Village.

# Varsity Team Drops a Close One





# You've got the Flu: Should you treat yourself or see your doctor?

You felt pretty good when you woke up, but now it's late morning and you're starting to feel chilled. An hour later you're feverish, your muscles ache at the slightest movement, your head hurts and a dry cough has cropped up.

"If you have all four of these symptoms at this time of year and you don't have a cold or gastrointestinal problems - the chances are pretty good that you have influenza or "the flu" as it's commonly called," says N. Cary Engleberg, M.D., chief, division of infectious diseases at the University of Michigan Health System. Engleberg says flu season typically runs from December through March.

There remains a lot of public confusion over what flu is. The word "flu" is often used erroneously to describe non-influenza ailments like the common cold or gastrointestinal ailments. Influenza is a virus that attacks the trachea and bronchial tubes. If you get it, there's not a lot you can do other than treat the symptoms. You need to pay close attention to those symptoms, however, to determine if you should treat yourself or seek medical help.

The most common symp-

toms of influenza are fever in the range of 100F to 104F, muscle aches, headache and respiratory complaints such as a dry cough, sore throat and mild nasal congestion. With the common cold, high fever, headache and muscle aches are not usually present and nasal congestion is very prominent.

"The treatment for influenza is to rest and make yourself comfortable, says Engleberg. "That means takin aspirin, ibuprofen or acetaminophen for fever and muscle aches. Also, be sure to take lots of fluids-like water, juice and soup - to keep from getting dehydrated."

Engleberg cautions that children under 18 with the flu should not be given aspirin because it could lead to a serious condition called Reyes Syndrome.

Antibiotics are not effective in treating influenza. The only two medication approved to fight influenza are rimantidine and amantidine. "These antivirals may shorten the course of the illness if given early enough," Engleberg says.

Acute symptoms from influenza usually subside in two to three days, but can last up to a week. And don't be surprised if

you feed fatigued for a couple of

So, what warning signs should you watch for that tell you it's time to seek medical help?

"Any consistent or prolonged fever of 102 or higher is probably good reason to see your doctor," Engleberg says. He adds, "The major dangerous complication of influenza is pneumonia. Thins that would signal a change to be concerned about would be shortness of breath, chest pain when takin a breath and a cough that produces secretions or blood. These may indicate something more than influenza is present."

Influenza is spread when people come in contact with secretions from an infected person, usually from coughing or sneezing.

Yearly flu shot vaccination has been shown to be 70-90% effective in preventing influenza. People over 65, health care workers and those with chronic illnesses should strongly consider influenza vaccinations. Health experts at the Centers for Disease control say the influenza vaccine should be administered between September and mid-November. It takes one to two weeks for antibodies against influenza to develop and provide protection.


