

Tropical Effects Tanning Salon

It was a chilly gray day with a threat of rain... a good day to try out the "positive effects of the sun" at Tropical Effects tanning salon.

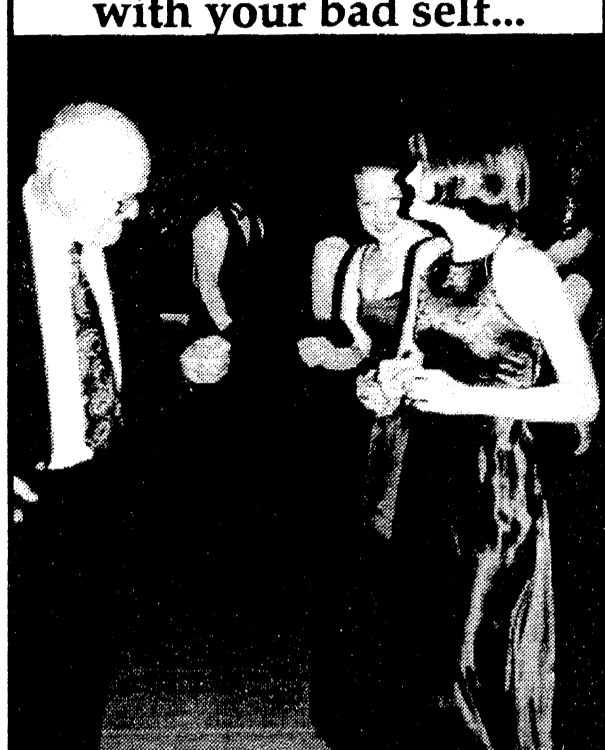

Synopsis, Sharon Township Board Meeting

April 1, 1999

Supervisor Blades called the meeting to order with all board members present and seven attendees.

The Clerk distributed a copy of the 2/25/99, 3/15/99, 3/22/99, and the 3/29/99 minutes to all the Board members prior to the meeting. The minutes were approved.

The Clerk read the minutes of the 3/4/99 meeting. The minutes were approved.

Treasurer's report was approved. The Clerk presented bills for payment totaling \$22,442.64. Board approved payment.

There were a few public comments and questions.

Treasurer Dunny stated that a letter was received from Dennis Doehring stating he had been wrongfully billed for an accident. Motion was made by Blumenauer, supported by Feldkamp to waive the bill. Motion carried.

Zoning Administrator Wilson asked the Board if the proposed private road for the Cole property split on Lehman Road needed to be a paved or gravel road? Motion made by Dunny, supported by Blumenauer to waive the paved road surface. Motion carried.

Blades reported that there were several problems with the Sharon Hills Estate private road. Motion was made by Dunny, supported by Blumenauer that the private road must meet the Washtenaw County standards and the Board is not approving the road "as is". Motion carried.

Blades reported that Farmer Sand and Gravel had re-opened for business.

Blades mentioned the lawsuit with Tom Ellis.

Feldkamp reported that George or Lauren Wacker may be interested in becoming the Recycling Coordinator for the Township.

The Board discussed the handicap ramp. A motion was made by Dunny, supported by Aiuto that Blumenauer contact John Schaible to repair the ramp. Motion carried.

Blades stated that filing cabinets were needed. Motion made by Aiuto, supported by Feldkamp to allocate \$1,000 for the purchase of new file cabinets. Motion carried.

The Board discussed the WC Road Commission's 1999 plan for road maintenance. Motion made by Dunny, supported by Aiuto to sign the contract for two solid applications of calcium chloride and not to exceed \$10,000 in gravel. Motion carried.

The Board discussed Zoning Amendment 2-27-99 and the seven recommendations from the

WC Planning Commission. Motion made by Aiuto, supported by Dunny to approve Article 5 contingent upon the recommendations from the County with the exception of "the review of the WCPC to Section 5.08. Motion carried.

The Board discussed the adoption of the new fee schedule. Motion was made by Dunny, supported by Blumenauer to adopt the revised Sharon Town-

ship fee schedule effective 4/1/99. Motion carried.

The Board scheduled the Budget hearing for 6/3/99 at 8:00 P.M. All salary resolutions were read and approved by all the Board members unanimously.

The meeting was adjourned at 10:15 P.M.

NOTICE OF ALL SHARON TOWNSHIP RESIDENTS AMENDMENTS TO SHARON TOWNSHIP ORDINANCE

The following amendments to the Sharon Township Zoning Ordinance was approved by unanimous vote of the Sharon Township Board during a regular monthly meeting held on Thursday, April 1, 1999. A public hearing on this amendment was held on Thursday, February 18, 1999 by the Sharon Township Planning Commission. They recommended approval, but the Washtenaw County Planning Commission recommended conditional approval.

A summary of the amendment is as follows:

To add a new Article 5 Mobile Home Community District, to provide regulations and provisions for the proposed new mobile home community district.

The following amendments to the Sharon Township Zoning Ordinance was approved by unanimous vote of the Sharon Township Board during a regular monthly meeting held on Thursday, May 6, 1999. A public hearing on this amendment was held on Thursday, January 21, 1999 by the Sharon Township Planning Commission. They recommended approval as did the Washtenaw County Planning Commission.

A summary of the amendments are as follows:

To amend Article 20 Administration and Enforcement, to replace the word "inspector" with the word "administrator", to clarify the requirements for a certificate of zoning compliance, and to increase the fine for not removing a violation after receipt of a stop-work order from \$100.00 per day to \$500.00 per day.

To amend Article 3 General Provisions by making minor grammatical corrections.

The complete text of the amendments are available for examination by any person at the office of the Sharon Township Clerk. Please call (734)428-7002 for an appointment.

The zoning ordinance amendments may take effect not earlier than 7 days after publication. During that 7 day period, any registered elector may file with the Clerk a Notice of Intent to file a referendum petition. A referendum petition must be filed 30 days after publication.

In absence of a Notice of Intent, these amendments will take effect 30 days after publication.

MANCHESTER ORDINANCE CODE

Chapter 146 Ordinance 155

Section 16: Safety Belt Requirements.

Each driver and front seat passenger of a motor vehicle operated on a street or highway in this Village shall wear a properly adjusted and fastened safety belt, except that a child less than four years of age shall be protected as provided in Section 5.82 of Chapter 146 of the Manchester Village Ordinance Code. Each driver of a motor vehicle transporting a child four years of age or more but less than 16 years of age in the front seat of a motor vehicle shall secure the child in a properly adjusted and fastened safety belt. Enforcement of this section shall be accomplished only as a secondary action when a driver of a motor vehicle has been detained for suspected violation of another section of the motor vehicle code and is a civil infraction.

Fire At Timber Lake Contained

A contractor's construction debris fire got "out of control" Friday afternoon due to fairly dry conditions and a brisk wind. The house under construction is located at one of the remotest sites off Timber Lake Road in the Stoney Lake Development.

It was the first known emergency test of the turn around area provided by the agreement between Manchester Township and the development. Fire trucks had to park off the turn around and those that went further had to back up to exit the fire location. Manchester Township Fire Chief Gary Wiedmayer said there had been "no problem" and that if more water had been required, the Department would have run a two-inch water hose to the fire location. He indicated the Department has 4500 feet of line available.

Chief Wiedmayer confirmed the fire had caused little damage and was caused by the contractor burning debris. Asked if the contractor had obtained a burn permit, the Chief said "No, and that was discussed with the contractor. We do want to know when people plan to burn." He indicated that conditions for burning were poor Friday afternoon, but that no fines would be involved.

Choosing the Right Perennials . . . Part III

The hardiness rating is one of the first things to look for in choosing your plants. But don't consider it an absolute. These are average ratings. There are many microclimates around your yards. Some areas near a building, large plants and fences are warmer as they trap the heat and provide shelter from the wind. Other areas that are open, are exposed to the winds or may be low lying, where frosts settle. Another point to remember is that eastern exposure to the sun is cooler and less intense than the western sun. Now that you have observed the area, put the more tender perennials in the protected spots and leave the exposed sites to the tougher varieties. The following is a small list of plants to get you started.

This and That

On Living and Dying

By Dave Helisek. Fifth in a series

Houston, we are ready for lift-off.

The tests that were run the week of April 25th determined that my heart and lungs should be able to withstand the transplant. The eighteen vials of blood taken showed that I was just as weird as I thought I was, but with no other illnesses that could be seen. So, all is go for my entering the U of M hospital on May the 11th for my Bone Marrow Transplant, B.M.T.

What will happen after I enter the hospital is quite simple, quite deadly. I will begin with four days of chemotherapy in pill form, Busulfan. Then a day of rest. This is followed by four days of chemo by I.V. This drug is Cytoxan. Prior to the administration of the Cytoxan each day, my lungs and heart will be examined to make sure that I can take it. Then a second day of rest.

Ten days after arriving at the U, a bag containing approximately a litre and one-half of liquid bone marrow from my donor will be hung at my side and be transfused into me. Just like a blood transfusion. That's it.

The problem is, of course, that the chemo will have destroyed every bit of my blood making and immune system. So much of me will be destroyed by the time of transfusion, that if my donor were a different blood type than me, I would have a different blood type after the transfusion. Now that's Buck Rogers stuff.

If all goes perfect, I can expect to spend at least 30 days in the hospital. It will take ten to fourteen days after the transfusion to see if it took. If it didn't we are in trouble, but the doctors have faced this before and I know that risk is there. The major problems to be faced with a B.M.T., however, are the infections that you face after the chemo has done its job.

With your total immune system shut down, the least of bugs, whether it be bacteria, or fungus or virus will make you sick. I am told to expect to be readmitted to the hospital. The recovery will have small peaks and deep valleys;

not a straight shot upward. I can expect to be off work for at least a year. It will be interesting.

I am going to try to keep up with my series of articles on a two-week basis as before. I can't promise this, though. The staff of the transplant unit and other survivors paint a very mixed picture of how lucid I will be and how much energy and concentration I will have. Every patient is different, and no one will promise what your reaction to the drugs and procedure will be.

I would like to end this part of the series by thanking the people in town who have been very supportive during this first five months of my illness. Father Charlie and the men and women of St. Mary have been especially kind. I also would like to extend a sincere thanks to the *Manchester Enterprise* for allowing me to do this series. Teresa and Marsha have been extremely understanding to a guy who just walked in one day and wanted to do a series of articles on cancer.

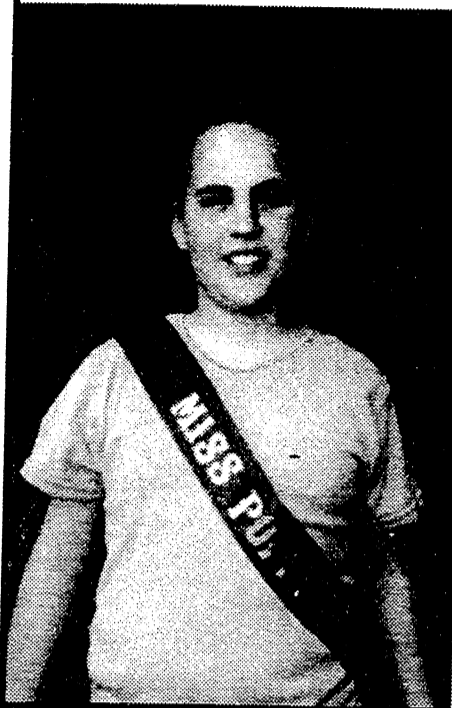

Laura Haeussler of the Country Expressions 4-H Club was presented with the Mary Weidmayer Award for Top Overall Sewer.

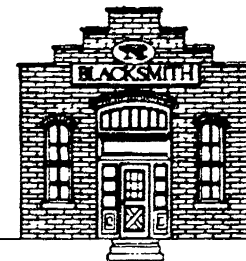

Sharon Township Public Hearing On Flood Plain Ordinance Will Be May 20

Sharon Township is considering an ordinance that will designate flood plain areas to overlay existing zoning districts indicated on the official Sharon Township Zoning Map. Flood plain areas will coincide with the boundaries of the areas indicated within the limits of the 100 year flood, as given by the State of Michigan.

The intent of the proposed ordinance is to limit damage due to flooding and protect flood plains so that they serve their natural purpose, which is to carry and discharge flood waters. Flood plains have not always been recognized as natural resources that require protection. They serve many critical functions - such as natural runoff control, water recharge, pollution control, and flood protection for other areas.

The ordinance will also have the effect of minimizing public expenditures for flood control, rescue and relief efforts. It will direct future development away from flood main areas.

Within the flood plain area overlay zone(s), land can only be used for:

- Agriculture, pasture land and animal grazing. Harvesting native or wild crops such as wild rice, marsh grass, berries and seeds.
- Parks, athletic fields, golf courses and nature areas.
- Wildlife preserves.
- Fishing, trapping and hunting.
- Hunting and conservation clubs.

- Historic sites and structures.
- Required open space for structural uses that are not included in the overlay zone.

If a flood plain area is used for agriculture, pasture land or animal grazing, the ordinance will require a setback of 40 feet from the normal river channel, requiring vegetation to act as a barrier to minimize soil erosion and sedimentation runoff from agricultural activities. Accessory structures and uses associated with permitted use of flood plain areas will be allowed, if they will not increase water elevation, reduce flow or impoundment capacity of the flood plain. Generally, dredging, filling, dumping or backfilling is prohibited unless there is compensating effort.

Article 6 also requires that:

- No building can be erected, converted, placed or substantially improved or land tilled in the flood plain district unless a zoning compliance permit or variance is obtained.
- Public utilities and facilities will be designed to minimize flood damage.
- The Planning Commission will review development proposals to determine compliance.
- Land cannot be divided to create parcels or lots that cannot be used in conformance with the requirements of Article 6.
- Flood plain data from federal, state and county resources shall

be used to meet the standards of the ordinance. Data from the Federal Insurance Administration will take precedence over other data.

The public hearing will be held at the Sharon Township Hall, 18010 Pleasant Lake Road, at 8:00 PM. Copies of the draft ordinance can be obtained from Township Clerk Teri Aiuto at 428-7002. -WF
