"Beaconsfield Golf Club's greenkeeper, Mr. A. E. Berry, died on 4th April after a comparatively short illness.

"Ted, as he was best known, had served the club for 43 years, having started as a boy of 12. He had an aptitude for golf, and on leaving school joined the professionals, with the object of becoming a professional golfer. He won many trophies.

"Later he showed an interest in course maintenance and was persuaded to join the greenkeeping staff. He became a member of the British Golf Greenkeepers' Association and won their All England Championship. An all-round sportsman, he was a keen member of Beaconsfield Cricket Club for whom he played regularly in the 1920's. Had he been able to give more time to cricket he would have been a first-class player.

"Mr. Berry devoted his life to the golf course. His numerous friends mourn the loss of one who served them so well for such a long time."

The Golf Greenkeepers' Endowment Scheme

THERE would appear to be a lack of knowledge in many circles about this scheme and I am indebted to the Editor for this opportunity of explaining how it originated and how it works.

During very cordial discussions between representatives of the B.G.G.A. and representatives of the Clubs in many parts of the Country it became obvious that there existed a desire on the part of many Clubs "To do something for the Greens Staffs".

As a Vice-President of the Northern Section of the Association I was invited to prepare a scheme which could be submitted to Club Councils or Committees on behalf of their own particular staffs.

As the Chairman of the Greens Committee of a Golf Club it was possible for me to appreciate the financial difficulties facing many Clubs at the present time and as a result realised that the success of any scheme would depend on the modesty of the requirements.

Anything in the nature of a Group Pension Scheme as adopted by many industrial companies and business firms could not be considered for a National Scheme to be adopted by Golf Clubs in varying degrees of prosperity.

After very careful thought and much discussion it was decided by the British Golf

Greenkeepers' Association that our aim would be to try and ensure that every greenkeeper in the Scheme would retire with a MINI-MUM sum of £500. This sum to be available to his widow or dependents in the event of his death before retirement age.

It was also felt that preparation for retirement was not the sole concern of the employer but rather a matter in which the responsibility should be shared between the employer and the employee.

Thus the Scheme was born and all green-keepers and ground-staff are urged by the Committee of the Association to examine their own individual position and show this article to the Chairman of the Greens Committee with a request that they be included in the Scheme.

The cost varies with the age of the individual and for young men is very modest as the following table shows:—

This table shows the cost per week but in practice the Club is asked to pay both premiums annually in advance and then to deduct the member's contribution week by week from his wages.

Two Endowment Policies are issued in each case. One is the property of the Club and the other is the property of the green-keeper.





Dear Mr. Editor,

I thoroughly object to the suggestion that this amount should be paid out of Headquarter's Funds. The idea may be unpopular, but I think we are getting full value for money, and another 2/6d, or 5/- would not hurt Head Greenkeepers.

I hope the younger members have read Mr. Smithers' letter in the April issue, and have realised the hardships that the Association had to go through in the early days; how greenkeepers had to stand on their own feet; how they carried on with their courses before the advent of the Research Institute; and how individual greenkeepers were entirely responsible for working out the treatment of their greens and fairways—and stood or fell by their own deeds. Now we have the S.T.R.I., which probes into and solves many of our problems, and makes things much easier in every way by providing more scientific knowledge of the whys, the wherefores, and the hows.

By the way, I note with pleasure that our old friends Messrs, C. Prickett and E. Dunn have been made Hon. Life Members. Only this morning I came across two of our very old Journals—1927 and 1928. On the frontispiece of the first was a photograph of Mr. Prickett, and in the 1928 edition was a picture of Mr. Dunn. I wonder how many of these old Journals are about today? Mr. Prickett was our Chairman in 1926-7. At the end of the 1926 issue is a report by Mr. W. H. Smithers (the then Hon. Sec.) stating that 41 new members had joined that year—which proves what he said in his letter with regard to getting new members. The Association, says the report, had a total working balance of £110.

In the 1928 issue there is a very good photograph of Mr. Smithers, and it is full of useful articles. In those days we only received the Journal once a year, yet it must have taken a lot of compiling and would, I bet, have been another of Bill's voluntary activities. I see that the Annual Tournament over 36-holes in that year was held at Sudbury, and that C. A. Tydeman (Hcp. 14) returned a score of 157—which was good going.

I think we should be very proud of our Association, and although we have plenty of grumbles and a little mudslinging, this invaluable organisation will still go on; and if the younger members do as much for the future

of greenkeeping and the Association as the "old 'uns" did in the past, then in some years to come the B.G.G.A. will be something we "old 'uns" will be proud to have helped build.

One final piece of advice to the younger members. Go out and help yourself to knowledge. Be inquisitive. Don't always wait for permission to do something—take a risk and do it; you will get plenty of knowledge that way.


