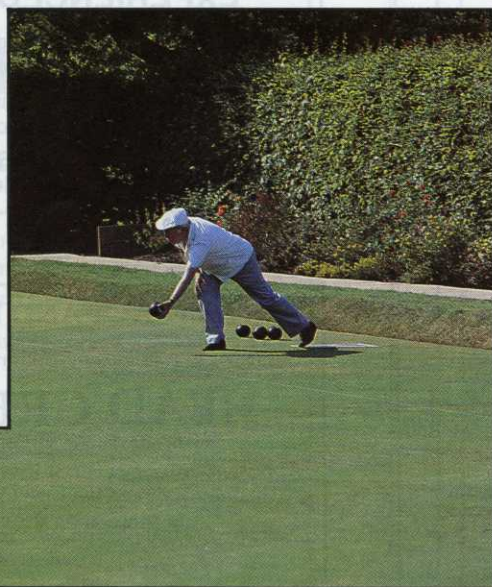
It was pleasing to see so many Central section members at BTME and I'm sure everyone who attended voted the event a great success and will be looking forward to Harrogate and BTME in '93.

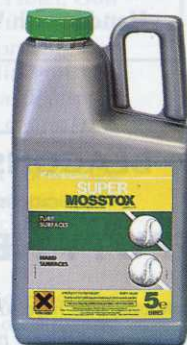

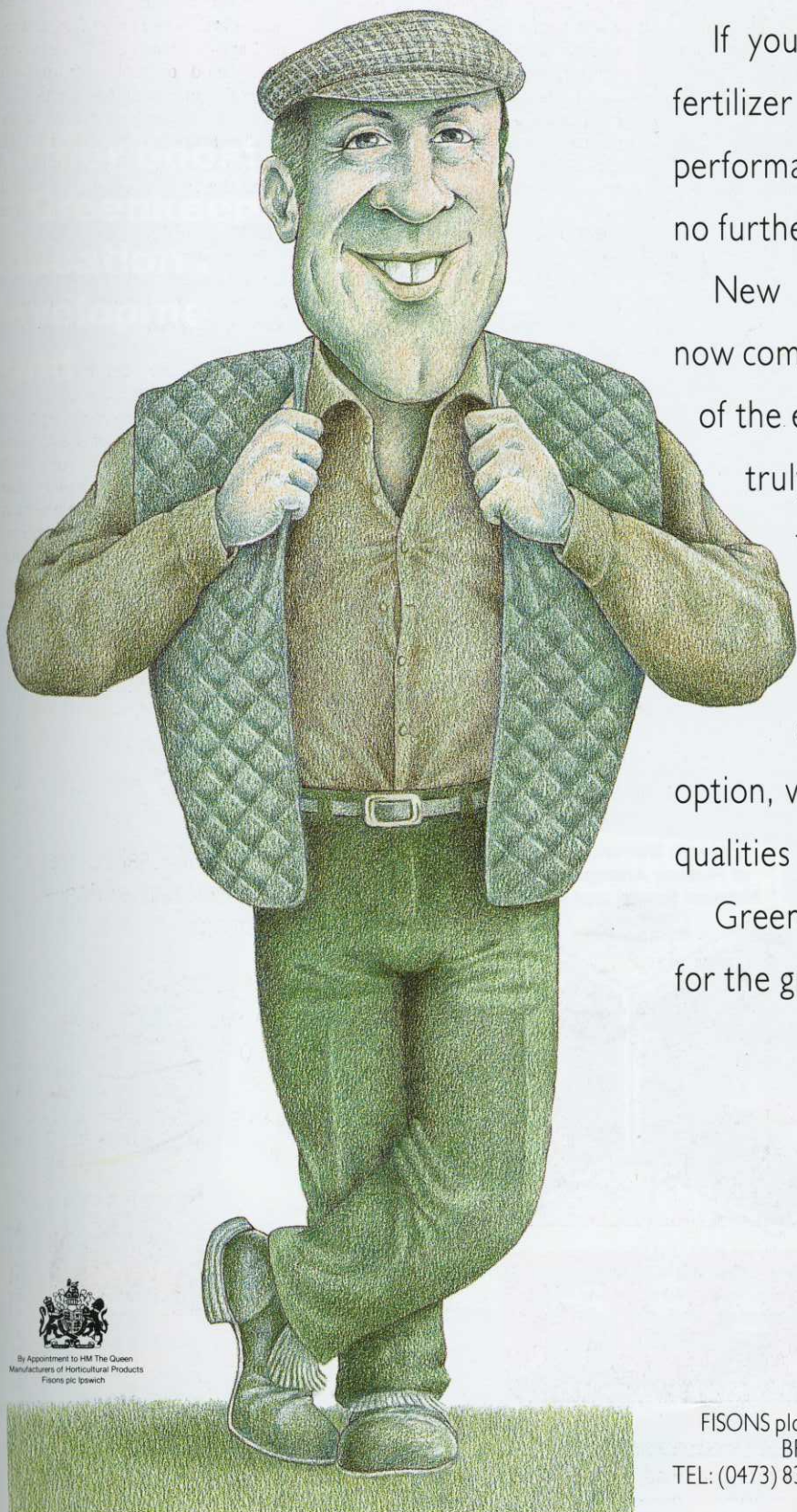
