## JOB ANALYSIS CAN CUT WASTE OUT OF MAINTENANCE

This article is condensed from a speech made by Williams at the annual USGA Green Section meeting.

What does it cost the club members for the annual operation of their private clubs? The round figure of \$500,000 for a 300 member club is fairly realistic, possibility somewhat conservative. As we get closer to our subject, we find that the course maintenance costs lie in the range of \$40,000 to \$80,000. So taking the average figure of \$60,000, we can conclude that the cost of operating the course proper is about 12 per cent of the member's expense dollar. As we get closer to the more detailed consideration of the grounds labor, we are speaking of a \$25,000 to \$50,000 expense which, in turn, represents 5 to 10 per cent of the member's expense dollar.
