Our speaker at the evening dinner was **Ted Albrecht** offense guard for the Bears football team. If he plays football as good as he can talk the team should be a winner this year.

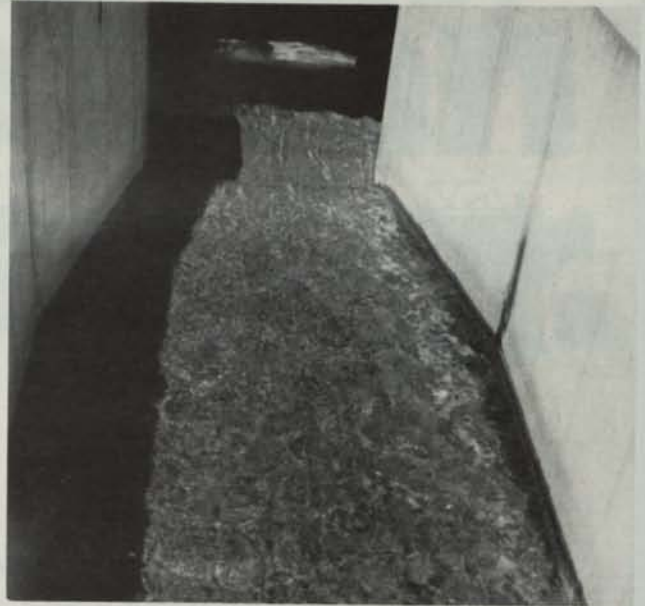

This picture shows 15,000,000 gallons of treated water every day being wated by going down the river. This treatment plant is located at the North Shore Sanitary District on the north side of Chicago near Highland Park, IL. When completed it is anticipated it will be treating 35,000,000 gallons of effluent water a day. The results are that this water can safely be used for irrigation. Part of the cost is being financed by the Chicago District Golf Association. I am sure we all feel that this is a worthy project due to a shortage of water we may have to face within the distant future. It is anticipated the 35,000,000 gals. a day will be ample to irrigate several golf courses in the North Shore area.

The University of Illinois will be watching this project very closely and will have some turf grass plots near the treatment plant. The plots will receive this treated water to determine how it will react on different strains of turfgrass.
