There was no "Mickey Mouse golf" as Robert Allenby's intelligent contribution to the matter suggested (a week before he even stepped foot on the golf course), and whatever gag rule that was put into action by the Tour seemed to work, because the players and commentators said very little about it. Sometimes grass dies. Paint it green for TV, roll it smooth, and party on, and just shut up about it.

Kudos to XM Satellite Radio and its "Making the Turn With Peter Kessler" show which regularly features interviews with golf course superintendents in the spotlight. Instead of reporting secondhand news about the inner workings of a televised golf event, this show goes straight to the horse's mouth for the real scoop. Recently two horse's mouths of local note were heard on Mr. Kessler's segment—the aforementioned Ken Lapp and ex-MAGCS member Tom Brodeur whose TPC Boston course hosted the Deutsche Bank Championship last month.

GCSAA's 2007 Nominating Committee proudly announced its slate of candidates for the 2008 Board of Directors election to be held on February 1 in Orlando. The following Class A members have been nominated:

- **Director** (2 to be elected) Patrick R. Finlen, CGCS, The Olympic Club in San Francisco, CA; John J. O'Keefe, CGCS, Preakness Hills Country Club in Wayne, N.J.; Sanford G. Queen, CGCS, City of Overland Park, KS; and Roger M. Ruff, CGCS, Outlaw Golf Club in Park City, Utah.
- Keith A. Ihms, CGCS, Country Club of Little Rock in Little Rock, Arkansas and Ricky D. Heine, CGCS, Golf Club Star Ranch in Austin, Texas will remain on the Board for one more year, while Sean A. Hoolehan, CGCS, Wilderness Resort and Casino in Oregon will retire from Board service.

Among the many pressing issues to be voted on at GCSAA's Annual Meeting in Orlando in February will be a proposed 6% dues increase (translating to \$20 for Class A and SM, and \$10 for Class C members). This will be the first increase since 2003 when a 20% increase was passed. Prior to that, a 19% increase was enacted in 1998. According to President Ricky Heine, the 20% increases have historically been associated with significant backward momentum in membership growth, thus the smaller (but probably more frequent) proposal for 2008.

The much-anticipated launch of GCSAA's redesigned web site (gcsaa.org) has run into some technical snags and was thus delayed (as of press time). Members may not be able to make changes or updates on the site until these snags are resolved, so in order to log Education Points or make other changes to your membership status, contact GCSAA Member Solutions at 800-472-7878.


The August issue of *Golf Course Industry* magazine prominently featured several of our more renowned MAGCS members. The cover story, "The Right-Hand Man—
