Other speakers on the C.D.G.A. program were:




Let me enumerate some of the things that financial support from organizations like yours have allowed us to accomplish in the past 18 months:

#### **Dennis Willms**

#### ASSISTANT-SUPERINTENDENT COMMUNICATIONS

The business-oriented superintendent likes to be well informed on operations pertaining to his golf course. With more and more activity on golf courses, a superintendent must stay abreast of current activities on his course.

As an assistant I have had the responsibility of the superintendent during his absence. I try to run the golf course including the maintenance shop as I think the superintendent would like to have it run.

I compile all my notes into an informal report so that when he returns, he can sit down and look over the report. In a matter of minutes, he can bring himself up to date on happenings that took place while he was away.

The following is an example of such a report that I gave John Ebel (superintendent) upon his return after an absence from October 20 through October 26, 1972. First of all, the memos he gave me upon his departure, and then the report which I handed him upon his return. Notice that I included weather conditions for each day which enables the superintendent to see why I chose the direction for each day's work.

Memo to: Dennis Willms

From: John Ebel

Subject: Work schedule

I will be away Oct. 20 - Oct. 26. Please use the following outline to help you supervise the men.

#### Regular Maintenance

- 1. Check course daily for damage, etc. Change tee markers as necessary.
- 2. Mow greens tees fairways if possible on Friday, Oct. 20. Rake traps.
- 3. Police club house grounds.
- 4. Leaf removal.
- 5. Log daily hours and labor distribution.
- 6. Record all important messages.
- 7. Be sure to secure buildings and check tools and equipment daily.
- 8. Check lights and thermostats.
- 9. Other Be Careful Safety First.

#### Other Projects

- 1. Clean, wash, wax pickup truck.
- 2. Karl install plugs and points in truck.
- 3. Remove screens, install storms, wash **all** windows inside and out, in employees quarters.

- 4. Clean out flower beds, bring in the flower boxes.
- 5. Start setting up skeet about Wednesday.
- 6. Check roof halfway house and tar leaks.
- 7. Clean out ditch along service road near #12 tee.
- 9. Bring in equipment, rakes, signs, etc.
- Apply lime to greens and tees, approx. 200 lbs. of lime per green. Also nursery.
- 11. Put cover on septic tank.
- 12. Repair tile lines.

#### TOLERANCE OF DOLLAR SPOT (Sclerotinia homeoacarpa) TO BENOMYL

During 1972, benomyl failed to give control of Sclerotinia dollar spot in several locations. The pathogen (Sclerotinia homeoecarpa) isolated from control failure sites in Illinois, Ohio, New Jersey, and Pennsylvania has shown 100 times the tolerance to benomyl as isolates from other areas where no control difficulties exist.

Instead of relying upon one fungicide for the control of Sclerotinia dollar spot, it is better to alternate fungicides. This will decrease the probability of tolerant strains from occurring. The control of mist turfgrass diseases from year to year is best when at least two fungicides are used in alternate applications.
