In the B Flight, Scott Zakany of International Golf Management and partner Todd Wiggington of Admiral Lehigh Resort were top dogs for the day. But the big winner was the Endowment Fund.

At this year's LCCC alumni gathering in Las Vegas, David Fry, tournament co-chairman, presented a check in the
