### U. S. Golf Handicaps Adopts USGA Rating System

United States Golf Handicaps, Inc., an organization that provides the casual golfer with a handicap rating for \$5.00 yearly, is adopting the USGA handicap system. Members have to make only a slight but very important change in their reporting procedure. Members now will report their actual scores, but will no longer deduct strokes over double bogies within their handicap group. USGH will base all future computations on the differentials between actual scores and course ratings.

#### Six Times A Year

Founded a year ago, USGH provides a score card and dates for mailing upon receipt of the membership fee. Handicaps are computed six times a year on the USGH computer. The group also offers a service for providing temporary handicaps for various groups whose golf activity is confined to one or two outings a year, thus relieving the tournament chairmen of the burden.

According to Bill Brown, executive secretary of the USGH, the group has been so successful that it has acquired a national headquarters with the purchase of the Riverside Golf and Swim Club, south of San Jose, Calif. USGH members will be able to play the course at reduced rates and at preferential times.

## National Golf Fund Holds Annual Meeting

The annual meeting of the National Golf Fund, Inc. was held at the PGA National GC in Palm Beach Gardens, Fla., Feb. 24, with a total of \$53,000 being distributed by NGF officials. Leo Fraser presented a check to Harold A. Moore, president of the Fund, in behalf of the PGA, from the net proceeds of National Golf Day in 1964. The NGF allocated the money on a basis of 48 per cent to educational programs pertaining to golf, 27 per cent to golf charities and projects, and 25 per cent to general educational programs, such as caddie scholarship funds.

Moore, of Chicago, Ill. and a past president of the Western Golf Assn., was re-elected president and director. Also re-elected were Herb Graffis, editor of GOLFDOM, v-p and Thomas W. Crane, PGA executive consultant, secretary-treasurer. Curtis Person of Memphis, Tenn., was re-elected a director. A new director is Dr. Joseph R. Ewers, executive director of the PGA.





tions) is that the commissioner may 'terminate the license when, in his sole judgment, he deems that termination is necessary by operation of law, or he deems that the leased premises are required for a paramount park or other purpose.'

These last-quoted eight words are not very specific, but we read them not as giving the commissioner any broad rights, but as limiting his power of termination to a situation where it can reasonably be said that the city needs the lands for a more important or pressing public need. This was not a revocable-at-pleasure clause such as discussed in McNamara v. Willcox, (73 App. Div. 451,452.77 N.Y.S. 294,295) nor does it meet the requirements of Gushee v. City of New York (42 App. Div. 37,58 N.Y.S. 967, supra) that the city in such grants must reserve the right to cancel whenever it decides in good faith to do so. This was rather, as said in Williams v. Hylan (223 App. Div. 48,128 N.E. 121, supra), a revocation clause of a kind common in ordinary commercial cases." (Miller v. City of New York, 255 N.Y.S. 2d 78)

promptly answer all correspondence pertaining to our club and the way that it operates.

Handicap figures of the Rogue Valley Seniors compare favorably with the overall handicap brackets of other players at the club. Here is how they stack up:

12 handicap or under.	31
12 to 21	31
over 21	22

#### **One-Sixth** of Play

Seniors account for about one-sixth of the play at Rogue Valley. Total play per day, men, women and children, averages about 175 rounds. There usually is about one week a year when conditions are not favorable for play. There are about 10 days of rain a year. That means we have no more than a total of 17 days when there is no golf. Hence, we have in our 347 playing days a total of about 61,000 rounds. Of these, the Seniors account for at least 10,000.

Women's play is strong at Rogue Valley. The women, too, have a vigorous association within the club and they account for approximately 30,000 rounds a year.

Our Senior members are very much above average in patronage of club facilities as well as in the amount of golf played. The retirement factor accounts for this exceptional use of the club. We have a large percentage of retired membrs.

We get 50 to 60 Seniors out for our monthly sweepstakes. One of our popular events is a three ball-best ball threesomes team affair, with each team competing against the others in medal and match and length of drives. Prizes are merchandise certificates, each certificate being worth one to five points. Each point is valued at \$1.25. The certificates, of course, are redeemable in the pro shop.
