The Wisconsin State Assembly, on the Tuesday before adjournment, killed a proposal that would have allowed the governor to appoint the Secretary of Agriculture. The Secretary will continue to be selected by the Board of Agriculture. The Secretary will not be selected by the voters, either. The current procedure, to some extent, insulates the office from partisan politics.

The Field Day is set for Camelot Country Club near Lomira on Tuesday, August 26. Red Roskopf and Marc Davison will be our hosts again this year. ### Pesticide Posting Proposal Dropped

Alderperson Eve Galanter has withdrawn her proposal before the City of Madison Council that would have required posting of any turf area treated with any pesticide. The proposal included all turf areas within the city limits - home lawn, city parks, any golf course, cemeteries, roadsides, medians, etc. The withdrawal was based on a judge's decision in a Wauconda, Illinois case in which a similar law was thrown out. The proposal would have been very costly and burdensome to turf managers, and the ordinance carried a \$500 fine each day. Ms. Galanter still holds the belief that a similar ordinance in Madison would withstand the test of the courts, but is at least smart enough to recognize such litigation would be lengthy and costly.

The alderperson, in a letter to "interested persons," states she will "continue to work with the Public Intervenor, representatives of environmental groups, lawn care companies, and other interested persons to draft and introduce a statute which encompasses the concerns which have been raised, and which will result in fair, effective regulation." It seems that all the petty politicians and bureaucrats think about is regulation. They should have to go out and try to earn a living sometime — it would be a shock to their systems.
