



Spring Fever

overnor Scott Walkers recent Budget Repair Bill **J**grabbed the attention of Wisconsin residents and the nation as groups from opposite ends of the political spectrum let their opinions be known. The discussion briefly flowed onto the turf industries listserve, Noernet.

I say briefly because the Noernet is a extension of the University of Wisconsin – Madison so discussion are to be used for purposes that fulfill the mission of teach-

ing, research and public service. That leaves out politics, sports and religion. Listserve caretaker Tom Schwab needs to remind us of that from time to time. The entire topic was a great reminder for those in the

golf and turf industry to keep an eye on local, state and national issues and how they affect us as individuals and industry professionals. We are lucky to have many organizations and professors to keep an eye on pending

regulation changes so we are not taken by surprise. However we as individuals still need to keep our ears to the ground and let chapter leaders know what is going on in your area.

I suggest you reach out to your state senator and assemblyman as well as your city or county elected official when they first take office to introduce yourself and let them know what your concerns are, and what experiences you have that they may be able to take advantage of. Getting to know them early will give you an advantage when they are considering an issue you have an opinion on.

If you hear of a local or statewide issue please contact Colin Seaburg and Mark Storby who serve as Chairmen for the WGCSA Environmental and Governmental Regulations Committee.

A new regulation that does affect every golf course is the new ban on landfilling used oil filters and absorbents. It is a good idea, but does add a budget and labor cost to our already stretched budgets. It is estimated that Wisconsinites throw away 187,000 gallons of used oil in disposed oil filters. The recycling effort will also save over 4.5 million pounds of steel for re-use each year.

Most homeowners can take their used filters to businesses that do oil changes but for a golf course that is not feasible. Crushed filters can be recycled at the scrap yard however applicable crushers cost a few thousand dollars and cause quite a mess.

Most oil recycling companies provide 50 gallon barrels to store the used filters in and then charge around \$50 to pick it up when it is full. At this time hydraulic oil filters are not included in the law, however common sense would say to include them on your own.

The filter law is cut and dried but there is some thinking to do with the absorbents. Absorbents include rags, kitty litter, floor dry or sand but there is a exemption to allow the disposal of up to one gallon of oil absorbent materials from a non-routine spill. That is one gallon of rags or floor dry not one gallon of oil. You can go to the DNR website at http://dnr.wi.gov/org/aw/wm/recycle/newpages/oilabsorb. htm for more information or just do a google search if you don't want to type all that in.

I put on my general managers hat for a few hours recently and attended the Golf Course Owners of Wisconsin Spring Meeting at Hilly Haven Golf Course. WGCSA President Jeff Millies was there to represent the WGCSA and presented information on the Par4Research Program.

Phil Immordino presented "Increasing Golf Outing Business" on steps facilities can take to attract and keep golf outings along with how to help outings grow their participation rate.

Many courses need to increase their communication with current and new groups through phone calls and offers of help to existing events and follow-up communication for groups that call with questions. Often in the hustle of the season customer follow-ups get forgotten so Immordino

Jeff presented that Michigan spends more to advertise just its golf courses in Wisconsin markets than Wisconsin spends on a whole advertising tourism.

Steve Stumbras, President, GCOW gave a presentation on the composting program the Bruce Company is using to reduce fertilizer and chemical use on some of their golf courses.

President Millies

Jeff Millies began his term as the 41 President of WGCSA a year early than anticipated when Past President Brian Zimmerman took a position in Cleveland. However it is a position he has been training for his entire life. In a way you can say Jeff was born into the golf industry. His great grandfather Louis Boeger farmed in Hillside, IL and in 1906 he bought a neighboring farm for \$10 a acre. His brother William Boeger was a lawyer, and one of the other lawyers in firm (Sears) kept telling them how great that piece of land would be for a golf course.

A land contract was drawn up and Sears began building a golf course in 1924 and in 1927 Hillside Golf Course opened for business. Unfortunately the depression soon followed and when Sears fell behind in payments Louis took control of the golf course. When Jeff's grandparents Louise Boeger and Fred Millies married, Fred was working as a caretaker of a cemetery and eventually became the Greenskeeper on the golf course.

Around 1959 the city of Hillside wanted part of the land the golf course was on to build a new high school (Proviso West). The course operated for a few more years as a 9 hole course before the land was sold for light commercial use and housing. The family purchased land in Big Bend WI and construction began on Edgewood Golf Course in 1966 with 9's opening in 1969, 1971, 1989 and 1999.

So really Jeff was born into the industry but Millies also


has experience outside the family run operation. A graduate of Iowa State University with a BS in Horticulture Jeff interned at Ames Golf and Country Club while attending Iowa State. He also worked at Medina Country Club in 1986 while the course was preparing for the 1990 US Open.

Jeff was the assistant Superintendent at Terradyne Country Club in Andover, KS working for Jack Tripp for a short time before returning home to help start building the third 9 holes at Edgewood. Never one to quite learning Jeff became a Certified Member of the GCSAA in 1996 and received his MBA from University of Phoenix in 2003.

Jeff is lucky to share his golf course time with his Dad Fred who is a 29 year member of the WGCSA and his brother Dan who is the clubhouse manager. Millies sister Kim and brother in law John Freeman the golf professional work in the golf shop and provide lessons.

He lives on the golf course with his wife Nicole and daughters Morgan and McKenna. Nicole is a real-estate broker for Shorewest and helps as needed with bartending, beer carting, mowing and helping with aerating in the fall.

Morgan is a sophomore at UW Madison, majoring in Biology and Spanish and bartends and drives the beverage carts in summer. McKenna is a sophomore in high school and is on the golf team and shows horses but still finds time to help in the golf shop. The family has 4 horses that live next to the course and pasture near one of the putting greens.

Jeff feels he is taking over at a critical time in the industry with economic challenges affecting all courses. He hopes courses can "hold their own" through this time to survive for the future. Although he feels the golf industry has hit near bottom there are many challenges to overcome and it will take time to see a measurable recovery. Gas prices, interest rates, inflation and the housing market are key question marks that will affect consumer discretionary spending on golf.

Edgewood which operates as a semi private club with 135 members has made adjustments as the economy has changed. Reductions to mowing frequency, bunker work and other maintenance jobs have worked for the course while operating with a smaller maintenance staff.

As President Jeff is pleased with the strong shape of the WGCSA and the continued success we have had with a strong membership using the benefits the association provides. The relationship with Chapter Manger Brett Grams has been a huge benefit not only for the board but for every member. Millies stated before we had a chapter manager the board had good ideas but not the method to implement them but now those ideas can be implemented.

Brett provides the knowledge and drive to get things done for the success of the chapter. The administration of the Chapter can be a daunting task especially from Dec 15 to April when renewals for memberships and advertising peak along with the administration of activities and meetings.

With the PAR4RESEARCH program the association can increase its funding to the valuable projects the UW Madison Professors are working on at the Noer Center. Millies is thankful we have a full staff of turf professors and world class facility for them to do their work.
