I hope the below will help explain our 1977 Applicator licensing'
certification program.
With the advant of the Federal Pesticide Control Act of 1972 and the Minnesota Pesticide Control Law of 1976 there have been some changes made with regard to licensing/certifying pesticide applicators.

Individuals supervising the use of Restricted Use Pesticides on golf courses will have to be licensed/certified under the noncommercial applicator classification. All individuals seeking this license/certification this year will be tested under a monitored condition. This applies to all individuals no matter if they are new or renewal applicants.

The applicant must select the general ground exam and any other category specific exam that applies to him.

In addition, if the individual has a side business of applying pesticides for hire, he needs the commercial applicator license/ certification. This is similiar as to obtaining the noncommercial license/certification with the one additional stipulation the applicant must furnish proof of financial responsibility.

## GOLF COURSE SUPERINTENDENTS TO HONOR STODOLA

Harold W. Stodola, St. Paul, has been chosen to receive the 1977 Distinguished Service Award of the Golf Course Superintendents' Association of America (GCSAA). The highest honor bestowed by GCSAA recognizes Stodola's many years of service and significant contributions to the organization and the profession of golf course management. He becomes only the 28th person in GCSAA's 50-year history to receive this special award.

Letters supporting Stodola's nomination for the award cited his work in keeping the Association intact as president during World War II as one of his most significant accomplishments. Stodola served as GCSAA president from 1941 to 1945, the second longest tenure in its history, and through personal correspondence with members and local chapters throughout the country, he held the Association together when the war curtailed meetings.

Stodola, golf course superintendent of the Mendakota Country Club in St. Paul, will be honored by some 5,000 colleagues during the opening ceremonies of GCSAA's 48th International Turfgrass Conference and Show February 6-11 in Portland, Oregon. He will receive a commemorative plaque, and in addition his name will be added to a permanent plaque housed at GCSAA Headquarters, Lawrence, Kansas.

Stodola joined GCSAA in 1930 and is a member of the Quarter Century Club. In 1938 he became chairman of the editorial committee of the Greenkeepers' Reporter, the official publication of the Association during the 1930s and 1940s. He served as a director in 1938 and 1939 and as vice president in 1940 before beginning his five-year presidential term.

Superintendent of the Mendakota Country Club since 1967, Stodola was previously superintendent of the Tucson (Arizona) Country Club. He is a member of the Minnesota Golf Course Superintendents' Association and the Arizona Greenkeeping Superintendents' Association and has served as secretary and president of the Minnesota association.
