The Golf Course Superintendent and his Contract

Being a Golf Course Superintendent and having charge of such an expensive piece of real estate should require a contract between the Superintendent and his club. This contract should be drawn up by either the club's lawyer or the Superintendent's lawyer. If the club uses their lawyer to draw the contract then the superintendent, before signing, should have his lawyer check the proposed contract over.

The contract should be as simple as possible but should cover any controversial point.

Below is a mock contract that may be of assistance in drawing up of a contract between the Superintendent and his club.

Contract

Agreement made this <u>first</u> day of January, 1962 between the Country Club of Anywhere hereinafter referred to as the Employer and John Doe of Anytown, Anystate, hereinafter referred to as the Superintendent.

The Employer agrees to employ the Superintendent for a period of two years extending from January 1, 1962 through December 31, 1963, as Superintendent of the Country Club Grounds located in Anytown, Anystate, and the Superintendent agrees to accept this position upon the following conditions:

The Superintendent agrees to take charge of the care, maintenance and repair of the Country Club Grounds and Property including but not necessarily limited to the Golf Course itself, the machinery used for the care, maintenance and repair of the Tennis and Squash Courts located on said Golf Course, the setting of lake equipment at the lake in the spring of the year, the removing of said equipment at the lake in the fall of the year and Supervising the Skating Pond and Warming Cabin during the winter months.

The Employer agrees to pay the Superintendent for his services the sum of X thousand dollars (\$X000.00) per year in equal monthly payments of X hundred dollars (\$X00.00) each, payable on the fifteenth day of each month while this contract is in force.

The Employer agrees that the Superintendent is to have one month's vacation with pay during each year as long as the vacation is taken during that part of the year when the golf course itself is closed for the season. The Employer agrees to pay dues for the Superintendent to the National Superintendent's Association of America and expenses to the National Conference at the rate of X hundred dollars (\$X00.00). It is further agreed that the Employer is to pay the Superintendent's dues and expenses to meetings of the Local Superintendent's Association at the rate of X dollars (\$X.00) and his expenses to the University of Rhode Island and the University of Massachusetts turf conferences.

The Employer agrees that the Superintendent is to have a foreman and sufficient other employees to carry out his duties, it being assumed that under normal circumstances there will be a foreman and a minimum of five other employees during the golf season, all of whom are to be hired by the Superintendent. The Superintendent is to have complete control over these men with the right to discharge any or all of them at anytime and for any reason.

Mr. John Doe is the present Chairman of the Grounds Committee of the Employer and the Superintendent is to deal directly with Mr. John Doe or his designated representative or his successor in office of the successor's designated representative, as the representative of the Employer in all the Superintendent's operations with the Employer.

At the expiration of the aforementioned period, if the services of the Superintendent have been satisfactory to the Employer and the Superintendent is satisfied, the Superintendent has the option of entering into a new contract with the Employer for one year or more years at an annual salary to be agreed upon by the Superintendent and the Employer at that time.

In the event the Employer or Superintendent does not wish to renew this contract at the time of expiration, notice shall be given in writing to the other party of the intention not to renew at least thirty days prior to the expiration of this contract.
