RANDOM THOUGHTS

Gosh, this has really been a cold, dry spring. And the unusual part is that it is not just a local condition. Word has come in from all over the country and it is all the same. Seems the season is running just about a month behind. Dave Fairbank says his new shop is coming along slowly but surely. He has his phone in now and the number is the same as it was b.b. (before blaze)

Is your Poa giving you a lot more seeds than usual this year? It makes the greens look like they have a much higher population of the stuff than in years before. The unnerving thing about the situation is that it makes you wonder if the pre-emergent materials you have been using for a few years are letting you down. Scarey, isn't it?

A good lesson in the requirements that different weeds have for germination can be seen each year. This year it has been Poa and chickweed. Last year it was dandelion, the year before that it was knotweed. Sure keeps you on your toes, doesn't it?

There has been a lot of stuff lately dealing with how many parts per million are in our lakes and streams. The Louisiana Cooperative Extension came up with figures to give people a better understanding of it. One p.p.m. equals 1 oz. of sand in 34¼ tons of concrete powder (that's 68,500 lbs.) or 1 oz. of dye in 7,530 gallons of water.

EDITORIAL

Been to a party lately? How 'bout a garden club talk? Do you read the papers once in a while or watch TV or listen to the radio? All the talk seems to be pollutants, environment, contaminants, eco-systems, smoke, smog, fines (not many), pesticides, offenders (many), controls, etc., etc., etc.

It is wonderful that the American public now has at least ONE eye open to this menace that has been around for no less than 20 or 30 years now! But unfortunately, it is just one eye of some and none of others.

It is a personal observation that the government may be using this subject to detract from other important issues such as the Viet Nam conflict, racial affairs in the U.S., poverty and others and by playing this one item up and capitalizing on it, it has taken some of the attention away from these other issues that are still very real and present.

One unfortunate thing is that a big number of politicians see and have been using this issue for their own personal gain in elections by playing on public sentiment on just one issue instead of several.

Other people have also been using this as a means of personal gain outside the political area. In a short period of time there are many people who have become "experts" in the field of population, ecology, deformed rats and pregnant mothers. In this same, these people have written books, given lectures, rabble roused and left their mark one way or another to get their piece of the action.

And get it they have. The only problem is that the people they have aroused are not the ones who can do much in the way of alleviating the already critical situation. GREENS COMMITTEE REPORT

The board of governors has approved an operating budget for 1971 of \$120,000. In addition \$28,000 has been approved to purchase much needed capital equipment for golf course maintenance. Among the items to be procured is a back hoe for work in preparing the fairway drainage system.

You are no doubt aware of the soggy conditions of fairways 7 and 18. These are good examples of the results of inadequate drainage.

Craig Spottswood plans to start his drainage project before the year is out.

Proper fairway drainage is necessary for the healthy growth of grass, particularly bermuda. Speaking of bermuda; Craig will start the propagation of sprigs in June on the back nine. Complete bermuda grass coverage for the nine fairways may take about five years. But be patient. A good five-year plan is better than no plan at all.

The front nine is too shady for good bermuda growth, so the emphasis here will be on blue grass. Major reseeding will be accomplished this fall. In the meantime we will try to keep the fairways playable with what we have.

Greens will be aerated and top dressed again in May. Then they should be good enough through the summer.

So much for what the board and the greens superintendent are doing. Now, what can you do?

(a) Be understanding when the course is closed to carts on wet days.

(b) Pick up your tees and throw the broken ones into the rough. They raise cain with mower blades.

(c) Repair at least two ball marks when you reach the green.

(d) Educate the kids to respect the course. Maybe even set a good example.

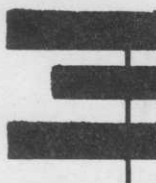

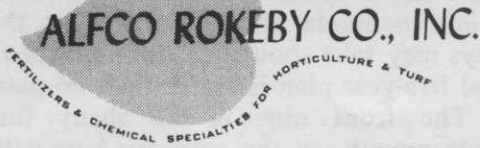

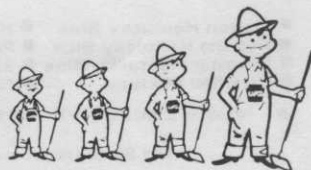
