



## OUR HOSTS — HOBBITS GLEN GOLF CLUB AND BILL NEUS

The Hobbits Glen Golf Club was opened in September 1967 and was the Columbia Associations' first facility. This private, non-profit corporation now owns and operates 19 pools, 3 tennis clubs, 2 complete indoor athletic clubs, 1 indoor ice rink, over 2,000 acres of park land, the ColumBus public transportation system, community centers in each village, and the largest before and after school day care program in the country. All within the town of Columbia.

Hobbits Glen was designed by Ed Ault and is spread out over 200 acres. In the past several years major renovations and construction have taken place. #1 green was rebuilt and opened two years ago. This year dramatic relocations were made to greens #5 and 7 to be opened in late fall or early spring. These projects were designed by Lindsay Ervin and constructed by McDonald & Sons. This past winter a sewer line went through the entire golf course. The scars from this are still very evident. Over the past five years 23 tees have been built, rebuilt, or enlarged and they are currently in a five year program to completely renovate all of the bunkers. So even if you don't play golf on the 9th there is still plenty to see at Hobbits.

The maintenance of the course which serves over 55,000 rounds per year and measures 7,196 yards from the blue tees includes; greens mowed at 7/32", 5-6 times per week with approximately 6 lbs. Napplied through a combination of IBDU in the fall and spoon feeding in the summer to repair the traffic damage. They are aerified twice per year with the VertiDrain which has had a dramatic positive impact on these heavy clay greens. Tees and fairways are mowed at 3/4", 3 times per week with 3 lbs. N applied in the fall and winter. For the first time this year no pre-emerge crabgrass control was applied, instead Acclaim will be used. Due to the weather, the rough hasn't been mowed in weeks (it may never have to be mowed again) and at this writing the fairways won't be watered or mowed again until it rains.

Bill Neus, our host, has been at Hobbits since 1981 and had previously been superintendent at Fauquier Springs CC in Virginia. He attended UMBC and then The Institute of Applied Agriculture graduating in 1976. Bill and his wife Lynne have been married for 13 years and have 3 *Continued on page 3*

## PESTICIDE PARANOIA

A little knowledge is a dangerous thing. The truth is, that is all the general public has about pesticides, a little knowledge. You have heard the stories on the news or read them in the papers. The stories of how this pesticide killed that, or that pesticide hurt this. It is enough to make you afraid to go into your own chemical storage area.

The trouble is that the public only hears the negative effects of pesticide use, and is usually unaware of how valuable pesticides are when used properly. The media does not inform the people about how great a particular pesticide is, that does not sell. After all, people do not want to hear good news, they want to hear about everyone's problems. So that leaves it up to us, the professional pesticide applicators, to inform the public about the good uses for pesticides.

How can you, as an individual, educate all these people? Start small. Write an article for your club's newsletter promoting the benefits of properly applied pesticides. This can be expanded on by submitting an article or editorial for your local newspaper. You can even address your local homeowners association by speaking at one of their meetings. Anytime you can educate the public, take advantage of the opportunity.

While you are educating the public, it may be wise to look at the way you handle

and use pesticides. Have you trained your staff in the proper application techniques? Are your registered in your state as a certified pesticide applicator? If not, why? There is adequate training available, such as the "Pesticide Use and Safety" seminar recently sponsored by the Mid-Atlantic Association of Golf Course Superintendents. In addition, there are regional and national conferences held each winter which provide valuable information to the pesticide user. There are also extension service personnel only a phone call away if you need any information.

Finally, keep up to date on all the government regulations concerning pesticides and their use. Not only for your protection but for the safety of all those who come into contact with the pesticide. Write your congressman or the GCSAA if you have any comments or suggestions regarding the pesticide laws.

By educating the public and keeping up on the latest technology we become more professional, in a time where professionalism is paramount. It is up to each one of us to put our best foot forward and make this world a little safer and better for everyone.

## 1988 JOHN DEERE TEAM CHAMPIONSHIP
