WE ARE GOLF. That is the sentiment that echoed throughout Capitol Hill on Wednesday as members of the We Are Golf coalition gathered in support of the game we all love. Included in the day's activities were meetings with congressmen and senators (and/or their staffers), golf exhibits on display in the Canon House building, and media activity that included an appearance by Jack Nicklaus. What a great way to spread the good word about golf's value apart from its intrinsic entertainment advantages.

So what was discussed in our meetings with America's legislators? Well, how about the direct economic impact of golf across the U.S.? It's almost 70 BILLION dollars per year. Or how about the fact that golf employs 2 million American people? Another great example is charitable initiatives. Golf donates more to charity (almost 4 BILLION dollars annually) than the NFL, NHL and MLB combined. Yes, that's right, COM-BINED. The list goes on. How about our environmental stewardship and value as community green spaces? Or the value of golf for physical activity -1,300 calories are burned playing 18 holes, and that's if you take a cart! Do yourself and your industry a favor and commit these stats to memory for the next time you encounter a cynical golf critic.

Specific to GCSAA's agenda during

the day's meetings, we spoke to our lawmakers about the proposed language changes to Waters of the U.S. (WOTUS), found within the Clean Water Act. To summarize, the proposed changes are very vague in language and open to interpretation. If the changes are approved, this could mean the EPA has jurisdiction over an area that has flowing water at any point throughout the year. In other words, if you get a 3-inch rain storm, and have runoff flowing across 7 fairway, that then becomes the EPA's jurisdiction. So what does that mean? It means costly permits and susceptibility to huge fines - up to \$37,000 per day. We believe the EPA is overstepping its boundaries with these suggested amendments, and we want to stop it. Believe me, this is a BIG deal, and we all need to keep an eye on this issue.

All in all, I would say National Golf Day was a great success. This initiative speaks to advocacy in the highest light, and I believe we can take this model and use it on a state level. Some have already started to do so, and those of us who haven't should be excited to follow their lead. For more about the National Golf Day initiative, the day's activities, or about

What a tremendous experience that was afforded to the MAAGCS delegation at National Golf Day! Serving this year at the event with me as GCSAA ambassadors on Capitol Hill were: Chris Harriman (Cattail Creek CC), Jay Nalls (Norbeck CC), Ryan Kraushofer (Westminster National GC), Teddy Blauvelt (Hampshire Greens GC), and Galen Evans (Laytonsville GC).

The 4:00 a.m. alarm clock for us was place, the Capitol Police officer a "normal" beginning to a typical weekday. But instead of going to our courses, we assembled at Norbeck Country Club and began piling expecting us. And a whole host of golf maintenance supplies into Ryan's vehicle. So the 6 of us squeezed in alongside bent, bermuda, and tall fescue sod, putting green hex plugs, gadgets like a digital macroscope, infrared thermometer, light meter, moisture meter, soil profilers, laptops, iPads, aeration tines, sprinkler head, stimpmeter, Ziploc bags of grass seeds, irrigation map, samples of records like soil and water tests, spray sheets, and the list goes on!

So we head around the beltway towards an off-site security check-point stuff no one has that checks trucks before they're allowed to make deliveries to Capitol Hill. Bomb-sniffing dog, ID checks

The First Tee kids were especially intrigued with using the regular macroscope and also the digital one connected to a laptop to see things like grains of sand appear so big!

All in all, we showed our students for the day how we save water, how we keep grass healthy, why we use some of the tools we do for scouting disease or assessing growing environments, and were able to also discuss how a lot of these things relate to maintaining our valuable green space as a place that wildlife can thrive. We're not just the people that mow the grass! It was a great opportunity to help spread the good word about what we do since negative stereotypes are still so pervasive outside our industry. 

This was a special day since both the Collegiate Turf Bowl Trophy and the STMA Student Challenge Trophy were on display for golfers and alumni to admire. This was the first time that any UMD Turfgrass teams were able to win both national championships! The Turf Terps also known as the "Fab Four" won the 2014 STMA Student Challenge and after 15 years of competition finally won the 20th Collegiate Turf Bowl competition. This accomplishment would not have been possible without alumni, industry, and the Shields families' support of this benefit tournament

Over \$14,000 was raised at this year's tournament and the proceeds not only support student travel to national and regional meetings and competitions but also supports student scholarships. I am extremely proud of how the Shields Endowment has grown and now generates over \$10,000 annually for student scholarships at the University of Maryland's Institute of Applied Agriculture. Since 1991 a total of 103 Shields Scholarships have been awarded to deserving students majoring in our Golf Turf program.

There are several items that are in focus for government relations this season. The first is the potential pesticide ban for Montgomery County, MD. The second is our starting work on the BMP program for MAAGCS. Finally, we are also working with the MDA on reporting requirements for fertilizer usage.

Today several industry members, including Dean Graves from Chevy Chase CC will be meeting with Mr. Leventhal to discuss why we as an association do not support the proposed pesticide ban for Montgomery County. Currently golf courses are exempt in the language for the bill, however it is unclear if this includes clubhouse grounds, tennis facilities, pool grounds, etc. So you may be able to keep weeds out of your fairways, tees, and roughs, but you cannot treat to protect your lawns around your buildings. The GCSAA is passionate about the "turf industry" sticking together, and so is the MAAGCS. We will continue to speak out against this bill, discussing the environmental benefits of our industry, instead of leaving the rest of the turf industry without our support.

Chase Rogan recently sent us information about a GCSAA grant available for developing BMP programs. Our BMP committee is meeting soon to discuss how to best begin the application process for this grant. Two organizations will be given \$10,000 to work on BMPs. This looks like a great way to get started! The deadline for the application is August 31st, so the

MAAGCS is well ahead of the ball game. Chase, thanks for the heads up!

Recently Dean Graves, Mark Schlossberg, Rick Lanore and I met with officials in the MDA to go over the reporting requirements for the Fertilizer Use Act. By next month we should see our first "beta test" for the reporting requirements. This will give us the opportunity to iron out any problems our members may have in reporting fertilizer usage, and also give us opportunity to educate our members on how to report annual usage. The MAAGCS BOD looks forward to this opportunity to serve our membership!

On a personal note, two days ago I had a young lady knock at my door asking for support for the "Clean Water Act". She spoke about how only 50% of our drinking water was protected from pollutants, and wouldn't I like to make that 100%? I told her that as a professional in the agriculture industry, I would not support this bill. It isn't fair to have less than 1% of the population

feed 99% of the population, manage important green space, care for our yards and parks, etc. and then turn around and restrict our ability to do it well in an environmentally responsible manner. She responded that anyone in the agriculture industry can receive a license to "pollute", and if approved, they could apply the requested products. I can only imagine what response the public would have to our industry applying for "licenses to pollute!"




