## President's Message

**G**reetings! How time truly flies. It seems as though we just started the grass maintenance season, when suddenly there are only a few precious weeks left in the growing season for most of us before Autumn frost arrives. I hope the past season has been a successful one for all turf managers and you were able to keep your athletic and recreation fields in the best possible condition. With material cutbacks, labour cutbacks, and water restrictions in some areas, it has been a definite challenge for most of us.

To me a highlight of the past turf season was the exposure natural sports fields received with the World Cup from mid-June to mid-July. With artificial surfaces still outnumbering natural fields at the professional level, it was wonderful for our industry and others to see what spectacular conditions the natural fields were in for the World Cup soccer matches. The practice and game site locations were superb and even after a month of tolerating heavy use, and in most cases extreme heat, the fields remained in exceptional condition. The resounding success of the Pontiac Silverdome "mobile" field will hopefully convince other stadiums that natural grass, especially sand-based fields are viable, especially in future retractable-roof venues. The World Cup field conditions were certainly a shot in the arm for our industry from my perspective. This kind of positive exposure regarding the performance and durability of the natural grass fields (both Kentucky Blue

and Bermuda) will hopefully benefit athletes of the future as we try and decrease the amount of synthetic (asphalt) playing surfaces. Granted the cost for the Silverdome field and the upgrading required on many fields was expensive, but so are the devastating amount of injuries and careers shortened or terminated by playing on artificial turf surfaces.

With a high, there is often a low, and I regret to inform the membership that Steve Bodsworth resigned his position in July with the Board of Directors, and Bob Sheard will be stepping down as our Executive Secretary, effective Jan. 1, 1995. To Steve, on behalf of the STA, my sincere thanks for all your efforts and being a member of the Board, Newsletter Editor, colleague and friend. I hope you can assist us again sometime in the future. To Bob, it is just about impossible in this small article to express the respect and gratitude we have for the work you have done for our Association over the past 4 years.
